Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Hot Springs Village Property Owners' Association 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Basis for Opinion on the Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). 1. Summary of Significant Plan Provisions

The following description of the Hot Springs Village Property Owners’ Association 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan for the benefit of the employees of the Hot Springs Village Property Owners’ Association (the “Employer”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Eligibility

Each employee, who is not a member of a collective bargaining unit or eligible for local police and fire pension and relief fund or any other state retirement system provided for public or quasi-public employees under Arkansas state law, is eligible to participate in the Plan at the next entry date coinciding with or following the employee attaining age 21 and completing ninety days of service. Employees are automatically enrolled in the Plan immediately following or coincident with the date the employee satisfies the eligibility requirements. Plan entry dates occur throughout the year on the first day of each month.

Contributions

Participants may contribute through payroll deductions and may make eligible rollover contributions. Participants may elect to contribute 1% to 90% of their compensation. The Employer will make a safe harbor matching contribution of 100% of participants’ elective contributions up to 3% of eligible compensation plus 50% of elective contributions between 3% and 5% of eligible compensation. For participants to be eligible for the safe harbor matching contribution into the Plan, participants must be employed on the last day of the Plan year and complete 1,000 hours or more of service. The Employer may also make a discretionary nonelective contribution as determined by the Employer. However, no such discretionary contribution was made during the years ended December 31, 2024 and 2023. The Plan contains provisions as to the maximum annual additions that may be made to a participant’s account.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and allocations of (a) the Employer’s contributions and (b) Plan earnings/losses and is charged with applicable withdrawals and an allocation of any administrative expenses. Allocations are based on participant compensation, contributions or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions into the investment options available under the Plan. Participants may change their investment selections at any time.

Vesting Rights

Participants are, at all times, fully vested with respect to their contributions, safe harbor contributions and rollover contributions plus earnings/losses thereon. With respect to Employer contributions, the

benefit attributable to a participant shall be fully vested and nonforfeitable upon death, becoming totally disabled or reaching their normal retirement age.

If a participant terminates employment for reasons other than death, disability, or retirement, he is entitled to the portion of discretionary nonelective contributions made by the Employer, plus earnings/losses thereon, according to the following schedule:

Less than 2	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 or more	100%

Forfeitures

The portion of a participant's account to which they are not entitled as a result of being less than fully vested shall be forfeited by the participant. Forfeitures may first be used to pay any administrative expenses. Forfeitures may then be allocated to all participants eligible to share in the allocations of profit-sharing contributions or in the same proportion that each participant's compensation for the Plan year bears to the compensation of all participants for such year.

Payment of Benefits

Upon retirement, death, disability or termination, a participant may elect to receive a lump sum, installments, or partial withdrawals in amounts equal to the value of the participant's vested interest in their account. Participants, upon termination of employment, may also elect to defer payment on their account balance if it exceeds \$5,000. If a terminated participant's account balance is equal to or less than \$5,000, the account will be automatically distributed. In-service withdrawals are available to participants who have met certain hardship requirements. Benefits shall be paid as soon as administratively feasible following the date on which a distribution is requested or is otherwise payable.

Termination of the Plan

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Subsequent Events

The Plan has evaluated subsequent events through September 24, 2025, the date the financial statements were available to be issued.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and change therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan provides for investments in various investment securities which, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risk. Further, due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the financial statements.

Investment Valuation and Income Recognition

Plan investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Change in fair value of investments includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

During the years ended December 31, 2024 and 2023, certain administrative expenses of the plan were voluntarily paid by the Employer. Expenses paid by the Employer are excluded from these financial statements.

3. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and Schedule of Assets (Held at End of Year), including investments held and net appreciation in fair value of investments, interest and dividends, was obtained by management and agreed to or derived from information certified as complete and accurate by Minnesota Life Insurance, the custodian of the Plan from January 1, 2023 to January 31, 2024, and Empower Retirement, LLC (“Empower Retirement”), the trustee of the Plan from February 1, 2024 to December 31, 2024 and was not subjected to any audit procedures, except for comparing the information with the related information included in the financial statements and supplementary schedule.

4. Concentration of Investments

During the year ended December 31, 2024, four investments within the Plan represented more than 10% of the Net Assets Available for Benefits. During the year ended December 31, 2023, two investments within the Plan represented more than 10% of the Net Assets Available for Benefits. At December 31,

2024 and 2023, the investments representing more than 10% of the Net Assets Available for Benefits were approximately 54% and 72%, respectively, of the Net Assets Available for Benefits.

5. Fair Value Measurements

Fair Value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value is categorized based on a hierarchy that gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value as of December 31, 2024 and 2023.

Pooled separate accounts: Pooled separate accounts represent investments held in pooled funds. The Plan’s interests in the pooled separate accounts are valued based on the NAV provided by the fund sponsor. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the account less its liabilities.

Mutual funds: These instruments are valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Tax Status

The prototype plan document the Plan is utilizing received an opinion letter dated November 14, 2022, in which the Internal Revenue Service (“IRS”) stated the document is designed in accordance with the applicable requirements of the Internal Revenue Code (“IRC”). As permitted by the IRS, the Plan is relying on the opinion letter on the prototype plan document for its own qualification. Although the prototype plan document has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate the tax position taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that, more likely than not, would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024 and 2023, respectively, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process. Federal and state income tax statutes dictate that tax returns filed in any of the previous three reporting periods remain open to examination. Currently, the Plan has no open examinations with either the Internal Revenue Service or state taxing authorities.

7. Party-in-Interest Transactions

Minnesota Life served as the custodian of the Plan for approximately one month during the year ended December 31, 2024. Minnesota Life held the Plan’s investment assets and executed investment transactions during this time period. The Plan paid Minnesota Life \$6,529 in administrative expenses during the year ended December 31, 2024, for these services.

During the year ended December 31, 2024, the Plan transitioned to Empower Retirement. Empower Retirement now holds the Plan’s investment assets and executes investment transactions. The Plan paid Empower Retirement \$45,056 in administrative expenses during the year ended December 31, 2024 for these services. Since Empower Retirement serves as the trustee of the Plan’s assets, Empower Retirement is by definition a party-in-interest and, as a result, the investments and transactions pertaining to the investments are with a party-in-interest. Empower Annuity Insurance Company, the parent of Empower Retirement, is the record keeper of the Plan and is by definition a party-in-interest.

All of these transactions are exempt from being prohibited transactions by ERISA.
