1. Plan Description

The following description of the AVCON, INC. 401(K) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more comprehensive description of the Plan's provisions.

- a) *General* – The Plan is a 401(k) defined contribution plan covering substantially all full-time employees of AVCON, Inc. (the "Company"), excluding Class 1 employees. The effective date of the Plan is January 1, 1989. The Plan has an age requirement of 21 years for participation and are eligible after 3 months of service. The Plan automatically enrolls newly eligible employees on the first day of each month following the satisfaction of eligibility requirements. Non full-time employees age 21 and older may be eligible after 1000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").
- b) *Contributions* – Each year participants may contribute to the Plan up to 75% of compensation subject to certain limitation under the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions up to 100% of compensation allowable by the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit plans or defined contribution plans (rollover).

The Plan automatically enrolls employees upon entry date at a deferral of 6% pre-tax, unless an affirmative election or opt-out is made prior. The Plan also employs an automatic increase feature, that increases participant contributions by 1% on the anniversary of the automatic enrollment date, up to a maximum of 10%. Participants can opt out of the Plan or the automatic increase at any time.

The Company contributes a Safe Harbor match of 100% of the first 1% of participant deferrals, and 50% of the next 5% of deferrals. The Company may make a discretionary nonelective contribution annually to those employed on the last day of the Plan year. Total employer contributions made for the period ended December 31, 2024 was \$880,576, including \$476,438 of Profit Sharing contributions.

Participants direct the investment of their contributions and the Company's contribution into various investment options offered by the Plan. Participants may change their investment options at any time via the internet.

- c) *Participants Accounts* – Each participant's account is credited with the participant's contributions and allocation of (a) the Company's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Administrative expenses may be charged based on account balances or charged equally to each participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- d) *Vesting* – Participants are vested immediately in their own contributions, plus actual earnings thereon. Participants vest 100% in employer matching contributions after 2 years of service. Nonelective employer contributions vest on a six year graded schedule, beginning with 20% upon reaching two years of service, and another 20% each additional year until fully vested at six years.
- e) *Notes receivable from Participants* – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Participants may only have one loan outstanding at a time. The notes are secured by the balance in the participant's account and bear interest at a reasonable rate. Loans must be repaid in no more than 5 years, unless used to purchase a primary residence in which case maturity can be up to 10 years. Principal and interest is paid ratably through payroll deductions.

- f) *Payment of Benefits* – In the case of retirement, death, disability or termination of employment, participants may elect to receive the vested accumulated value of their account in a lump sum distribution

In-service withdrawals are permitted from all vested balances for those age 59 ½ or older. Hardship withdrawals may be taken any time from participant and other vested amounts, minimum \$500. Normal retirement age Distributions are available for those who continue employment after reaching the normal retirement age of 65. Qualified reservist distributions are available for those who have been called to active military duty indefinitely or for more than 179 days.

- g) *Forfeited accounts* – Forfeitures of nonvested balances may be used to pay Plan expenses or reduce employer discretionary contributions. As of December 31, 2024, the forfeiture account balance was \$20,694. During 2024, \$8,021 was used to pay plan expenses and \$18,051 was used to reduce Company contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan to make estimates and assumptions that affect the reported amounts of net assets and changes therein. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024.

Payment of Benefits

5. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified within Level 1 of the fair value hierarchy.

Self-directed brokerage accounts – Accounts primarily consists of mutual funds, common stock and exchange traded funds that are valued on the basis of readily determinable market prices.

Common collective trust – The units of the common collective trust account is stated at fair value as determined by the issuer of the account based on the fair value of the underlying investments. Individual participant accounts invested in the common collective trust account are maintained on a unit value basis.

6. Risks and Uncertainties

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

7. Party-in-Interest Transactions

The Plan invests in certain investments of the Plan's custodian, Fidelity. Therefore, these transactions qualify as party-in-interest transactions. Additionally, notes receivable from participants are considered to be party-in-interest transactions because they are transacted with Plan participants. Fees paid for the investment management services are included in net investment income. The Plan paid \$67,079 in fees to the custodian in 2024.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

9. Tax Status

The Plan is a pre-approved defined contribution plan ("Pre-approved Plan") sponsored by Fidelity Management Trust Company ("Fidelity"). Voya obtained its latest opinion letter dated June 30, 2020 that the Pre-approved Plan, as then designed, was in compliance with the applicable requirements of IRC. is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan management believes that the Plan is currently designed, and is currently being operated, in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified, as the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.
