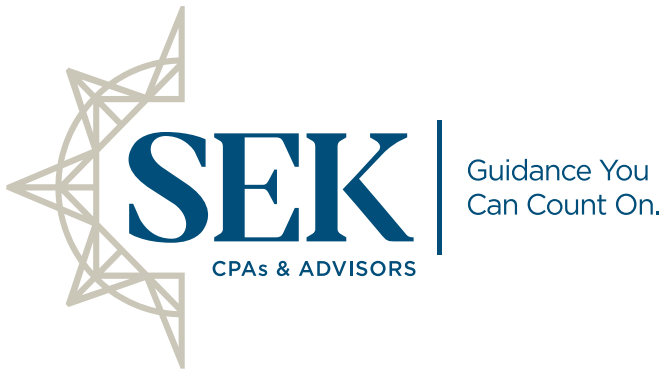

## INDEPENDENT AUDITOR'S REPORT

### SCOPE AND NATURE OF THE ERISA SECTION 103(A)(3)(C) AUDIT

We have performed audits of the financial statements of Blackburn, Childers & Steagall, PLC 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**NOTE 1 - DESCRIPTION OF PLAN**

Blackburn, Childers & Steagall, PLC (the “Company” or “Employer”) established the Blackburn, Childers & Steagall, PLC 401(k) Profit Sharing Plan (the “Plan”) on July 1, 1992. Other members of the control group participating in the Plan are BCS Financial, LLC d/b/a BCS Wealth Management, Covenant Trust, LLC d/b/a First Covenant Trust and Advisors, LLC and Trinity Valuation Consulting Group, PLC. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering all full-time and part-time employees of the Company who have completed six months of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Contributions**

Each year, participants may contribute up to 100 percent of pretax annual compensation or a flat dollar amount, as defined in the Plan, and in accordance with applicable sections of the Internal Revenue Code. Participants may designate some or all of their deferral contributions as a Roth Deferral. The election is irrevocable. Participants may defer a flat dollar amount or a whole percentage from 1% to 100% of any bonus designated by the Employer into the Plan, or suspend their contribution completely by completing a special election form. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions and any Company contributions into various investment options offered by the Plan. The Plan currently offers a money market fund, mutual funds, a stable value fund, and self-directed brokerage accounts as investment options for participants. The Company contributes a safe harbor matching contribution equal to 100% of the first three percent of the participant’s eligible compensation, and 50% of the next two percent of the participant’s eligible compensation. The Company also has the option to make an additional discretionary matching contribution. The match is computed by the Company and based on eligible compensation deferred into the Plan each plan year. The Company may designate all or a portion of any matching contributions for the plan year as qualified matching contributions and allocate them to Non-Highly Compensated Employees to help the Plan pass one or more annually required nondiscrimination tests. The Company may make a discretionary non-elective contribution each plan year if the participant completes at least 1,000 hours of service and employed as of the last day of the plan year. In addition, a qualified non-elective Company contribution is available to be made in the event this is deemed necessary in order to pass certain nondiscrimination tests. Both participant and employer contributions are subject to limitations under applicable provisions of the Internal Revenue Service (IRS).

**NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)**

**Participant Accounts**

Each participant's account is credited with the participant's contribution, an allocation of (a) the Company's contributions and (b) Plan earnings. Each participant's account is also charged with an allocation of administrative expenses (if paid by the Plan's Trust). Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in their own contributions plus actual earnings thereon and their Company safe harbor matching employer contributions and qualified non-elective contributions. Vesting in the Company's discretionary employer contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100 percent vested in their account after six years of credited service and automatically becomes fully vested upon reaching normal retirement age (65 years old), or in the event of disability or death.

**Payment of Benefits**

Upon termination of service, due to termination, death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the vested balance of the participant's account. Participants may also delay distributions of their vested balance. Effective January 1, 2024, the threshold increased from \$5,000 to \$7,000 for mandatory distributions. Distributions of a vested account balances of less than \$7,000, but greater than \$1,000 that meet the provisions for a mandatory distribution will be paid as a direct rollover into an individual retirement account designed by the Plan Administrator with an affiliate of Fidelity Management Trust Company if the participant does not elect the distribution method. Distributions of a vested account balance less than \$1,000 that meet the provisions for a mandatory distribution will automatically be paid directly to the participant if the participant does not elect the distribution method. In addition, in-service distributions are permitted if certain criteria are met.

**Forfeited Accounts**

Forfeitures may be used to pay the administrative expenses of the Plan or offset Company contributions to the Plan. Unallocated forfeitures were \$3,251 and \$2,510 as of December 31, 2024 and 2023, respectively. During 2024, \$2,575 of forfeitures were used to pay administrative expenses of the Plan from forfeited nonvested accounts.

**Subsequent Events**

The Plan has evaluated subsequent events through September 26, 2025, the date the financial statements were available to be issued.

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and (losses) on the investments bought and sold, as well as held during the year.

**Contributions**

Contributions from Plan participants and the Company safe harbor matching and discretionary contributions are recorded in the year in which the employee contributions are withheld from compensation and on compensation paid during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Operating Expenses**

Professional fees and transaction fees related to the administration of the self-directed brokerage account are included in administrative expenses and charged directly to the participant's account. Other investment related expenses are included in net appreciation in fair value of investments.

**Reclassifications**

Certain amounts from the December 31, 2023, financial statements have been reclassified to conform with current year presentations with no effect on the statements of changes in net assets available for plan benefits.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC), provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets.

Level 2

Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**NOTE 3 - FAIR VALUE MEASUREMENT (CONTINUED)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money Market Fund:* Valued at the Net Asset Value (NAV) of shares held by the Plan at year-end. The money market fund held by the Plan is deemed to be actively traded.

*Mutual Funds:* Such funds are normally calculated at NAV as of the close of business of the New York Stock Exchange. When calculating a fund's NAV, portfolio securities for which market quotations are readily available are generally valued at their market value, which typically is the last quoted sales price at the time of valuation. When there are no readily available market quotations for a security, the portfolio security is valued based on its fair value, which typically is the amount which the fund might reasonably expect to receive from the security upon a current sale. The mutual funds held by the Plan are deemed to be actively traded.

*Self-Directed Brokerage Accounts:* Comprised of common stocks valued at the closing price reported on the active market on which the individual securities are traded, mutual funds valued as described above, and a money market account as described above, all deemed Level 1 investments. In addition, comprised of corporate bonds valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing the value of yields currently available on comparable securities of issuers with similar credit ratings. Lastly, comprised of certificates of deposit valued at amortized cost, which approximates fair value and includes basing the value on interest rates or yield curves for similar instruments. Corporate bonds and certificates of deposit are deemed Level 2 investments.

*Stable Value Fund:* The stable value account is valued daily at NAV. The NAV, as reported by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. There are no unfunded commitments or redemption restrictions.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 - RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds and the stable value fund managed by Fidelity Management Trust Company, the trustee as defined by the Plan. These transactions qualify as party-in-interest transactions. Direct fees paid by the Plan to Fidelity for transaction fees amounted to \$1,509 for the year ended December 31, 2024.

BCS Financial, LLC d/b/a BCS Wealth Management and Purshe Kaplan Sterling Investments serve as the investment advisors. Direct fees paid to them for the plan year totaled \$61,177.

**NOTE 5 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**NOTE 6 - TAX STATUS**

The Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.
