## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF PLAN

The following description of the Planned Parenthood of Central and Western New York, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan with an effective date of January 1, 2005, that provides retirement benefits to all employees of Planned Parenthood of Central and Western New York, Inc. (the Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Eligibility**

All employees are eligible to begin salary deferrals upon employment. Employees are eligible for employer contributions the month following their first year of employment and have completed 1,000 hours of service.

#### **Administration**

The Employer's Board of Directors and its appointed retirement committee are responsible for the general administration of the Plan. USI Consulting Group (USI) serves as the Third Party Administrator (TPA) of the Plan's assets. USI contracts with Newport Trust Company, Inc., who serves as the custodian and recordkeeper.

#### **Participant Contributions**

Effective January 1, 2019, new employees are automatically enrolled into the Plan with a contribution of 4%, unless elected otherwise within 90 days of hire. Participants may make voluntary pre-tax contributions in the form of salary reductions up to 100% of their annual compensation, as defined, subject to certain limitations under the terms of the Plan and Internal Revenue Code (IRC). In addition, participants may contribute rollover contributions received from another qualified retirement plan.

#### **Employer Contributions**

The Plan is a Safe Harbor Plan. The employer Safe Harbor match equals 100% of elective deferrals that are not in excess of 4% of compensation plus 50% of elective deferrals that exceed 4%, but which do not exceed 6% of compensation.

Additionally, the Employer can make a profit-sharing contribution which is allocated equally among all eligible participants. Profit sharing contributions for the year are made to the Plan subsequent to year-end. There was no profit-sharing contribution made for the years ended December 2024, and 2023.

#### **Vesting**

Participants are immediately vested in all contributions and earnings/losses thereon. Employer profit sharing contributions vest 20% per year beginning after two years of service. Participants are fully vested after six years of credited service or upon normal retirement age.

## 1. DESCRIPTION OF PLAN (Continued)

### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Employer's matching contributions, and an allocation of any earnings or losses thereon and charged with an allocation of administrative expenses. Participants direct the investment of elective deferrals, employer matching, and rollover contributions into various options offered by the Plan. Allocations are based on specific terms provided by the Plan.

### **Benefit Payments**

A participant may withdraw any part of his/her vested account at any time after attaining age 65 or upon termination of service due to death, retirement, or disability. Normal retirement age is age 65.

### **Hardship Withdrawals**

Participants may also withdraw amounts in the event of undue hardship, as defined in the Plan document.

### **Notes Receivable from Participants**

Loans may be made to participants for a minimum of \$1,000 and a maximum of \$50,000, but no more than 50% of the participant's vested balance. The loans are secured by the balance in the participant's account and bear interest at prime rate plus 1% (7.50% and 8.50% at December 31, 2024 and 2023, respectively). Principal and interest are paid through payroll deductions over the term of the loan.

### **Forfeitures**

Forfeitures of non-vested profit-sharing contribution accounts can be used to reduce Plan fees. There were no forfeitures used to reduce Plan fees for the years ended December 31, 2024 and 2023. There were no balances remaining of forfeited non-vested profit-sharing contribution accounts at December 31, 2024 and 2023.

### **Administrative Expense**

The Employer pays certain administrative expenses of the Plan.

### **Plan Termination**

Although the Employer has not expressed any intent to do so, it has the right to terminate the Plan at any time subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). In the event of Plan termination, partial termination or complete discontinuance of contributions to the Plan, all amounts credited to the accounts of the participants are vested. All distributions would be made in accordance with any applicable requirements of ERISA and the IRC.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (US GAAP).

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### **Investments**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### **Fair Value Measurement - Definition and Hierarchy**

The ASC 820 framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation does not entail a significant degree of judgment.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

A description of where the Plan's investments fall within the ASC 820 hierarchy is provided in Note 4.

### **Benefit Payments**

Benefit payments are recorded when paid.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Estimates

The preparation of financial statements in accordance with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

##### **Valuation Methodologies**

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at fair value based on quoted prices in active markets.

*Common Collective Trust:* The Reliance Trust Stable Value Fund Collective Investment Trust, Series 25053 (the Fund) is valued at the NAV per unit by dividing the total assets of the Fund, less its liabilities, by the total number of units outstanding at the time of such computation. Investment income earned is reinvested in the Fund and included in the determination of unit values.

The Fund is administered by Metropolitan Life Insurance Company (MetLife) and is managed by MetLife and Reliance Trust Company (the Trustee). While the Trustee generally relies on MetLife to manage the Fund's assets, the Trustee maintains ultimate fiduciary authority over the management of, and investments made in, the Fund. The Fund is invested in a common collective trust that calculates NAV on a daily basis. Units are issued and redeemed as of the end of each day at the daily NAV. The Fund's primary investment objectives are to preserve principal while generating earnings at rates competitive over time with short-term high quality fixed income investments and provide daily liquidity at contract value for participant withdrawals and transfers.

Redemptions are generally restricted to processing on a valuation date at the NAV per unit computed on that date. Trust units may be redeemed on a daily basis to meet benefit payments and other participant-initiated withdrawals permitted by retirement plans invested in the trust. The Fund does not have any unfunded commitments.

#### **5. PARTY-IN-INTEREST TRANSACTIONS**

The Employer is the Plan sponsor. Newport Trust Company is the trustee and custodian of the Plan's assets for the years ending December 31, 2024, and 2023. As such, transactions between the Employer, Newport Trust Company, and the Plan are party-in-interest transactions. Additionally, transactions involving notes receivable from participants qualify as party-in-interest transactions.

#### **6. TAX STATUS**

The Plan has adopted a pre-approved Plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved Plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved Plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt. No provisions for income taxes have been included in the Plan's financial statements.

**7. RECONCILIATION TO FORM 5500**

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agreed to Form 5500 in total as of December 31, 2024 and 2023 and for the years then ended.

**8. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through October 3, 2025, which is the date the financial statements were available to be issued.
