### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of SEMCAC 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of SEMCAC 401(k) Profit Sharing Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

## **SEMCAC 401(k) Profit Sharing Plan Notes to Financial Statements**

### **NOTE 1 - DESCRIPTION OF PLAN**

The following description of the SEMCAC 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General and Eligibility**

The Plan is a defined contribution plan, under section 401(k) of the Internal Revenue Code (IRC), covering all employees of SEMCAC (the Organization) who have completed 1 month of service and are at least 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established on January 1, 1999, and was most recently amended and restated July 22, 2022. The Organization is responsible for the oversight of the Plan.

#### **Contributions**

Participants in the Plan may contribute a portion of their pretax compensation, as defined in the Plan, not to exceed the limit of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit and defined contribution plans, as well as after-tax contributions from their current compensation. Participants direct the investments of their contributions into various investment options offered by the Plan. The Organization may, at its discretion, elect to make matching contributions allocated to those who elect to make contributions. For the years ended December 31, 2024 and 2023, the Organization made matching contributions of 100% of elective deferrals up to 4% of eligible compensation that a participant contributed to the Plan. The Organization may, at its discretion, elect to make a nonelective contribution allocated to all eligible participants. There were no nonelective contributions authorized for the years ended December 31, 2024 and 2023. A participant must complete 800 hours of service during the Plan year to be eligible for the nonelective contributions, unless the participant terminates employment because of death, disability, or attainment of normal retirement age. The Organization's contributions are invested in the same manner as participant contributions. Contributions are subject to certain IRS limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, Organization contributions, and Plan earnings. Participant accounts may be charged with an allocation of administrative expenses, as defined. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Organization's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after four years of credited service.

## SEMCAC 401(k) Profit Sharing Plan Notes to Financial Statements

### NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

#### Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect from a single-sum amount or installments. The Plan allows for in-service distributions if a participant reaches age 59 ½ and hardship distributions subject to Plan provisions. Vested balances of less than \$7,000 can be distributed in lump sum without participant election.

#### Forfeitures

Forfeitures resulting from a terminated participant's failure to be fully vested in the Organization's contributions to the Plan are used in the following order: reduce the Organization's matching contribution or to offset Plan expenses. Forfeited nonvested accounts totaled \$854 and \$4,579 at December 31, 2024 and 2023, respectively. There were no forfeitures used to reduce the Organization's contributions for the years ended December 31, 2024 and 2023. In 2024 forfeitures of \$4,600 were used to pay Plan expenses.

### NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

#### Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting in conformity with accounting principles generally accepted in the United State of America.

#### Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Organization's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 3 for discussion of fair value measurements.

The Organization's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Contributions

Contributions from Plan participants and the matching contributions from the Organization are recorded in the year in which the employee contributions are withheld from compensation.

## SEMCAC 401(k) Profit Sharing Plan Notes to Financial Statements

### NOTE 2 - SUMMARY OF ACCOUNTING POLICIES (CONTINUED)

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

#### Subsequent Events

The Plan administrator has evaluated subsequent events through September 16, 2025, the date which the financial statements were available to be issued.

### NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are unobservable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3: Inputs are unobservable inputs based on the Plan's own assumptions used to measure assets and liabilities at fair value.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 - FULLY BENEFIT RESPONSIVE INVESTMENT CONTRACT**

The Plan offers a traditional fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company of America (EAICA) totaling \$238,123 for 2024 and \$473,228 for 2023. EAICA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is declared from time to time by EAICA in accordance with its usual practices but may not be less than 0%.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value as reported to the Plan by EAICA, represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

### **NOTE 4 - FULLY BENEFIT RESPONSIVE INVESTMENT CONTRACT (CONTINUED)**

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (a) amendments to the Plan's documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the ERISA, or (e) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability to transact at contract value with the participants.

### **NOTE 5 - INCOME TAX STATUS**

The Plan sponsor is relying on an opinion letter that the pre-approved plan received from the Internal Revenue Service dated June 30, 2020, that the Plan is acceptable under Section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. Although the pre-approved plan has been amended since receiving the opinion letter, the Plan administrator believes that the pre-approved plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more than likely would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in employer contributions.

### **NOTE 7 - CERTIFICATIONS**

Certain information related to investments from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by EAICA and Empower Trust Company, LLC (the Insurance Company and Trustee/Custodian of the Plan).

**NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS**

The Plan's investments are managed by Empower Trust Company, LLC, the trustee, and EACIA, the insurance company. Therefore, these transactions qualify as party-in-interest transactions.

**NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
