## Independent Auditor's Report

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of NTN Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

### Note 1 - Plan Description

The following description of NTN Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all eligible employees of NTN USA Corporation; NTN Bearing Corporation of America; American NTN Bearing Manufacturing Corporation; NTN Driveshaft Anderson, Inc.; NTN Driveshaft, Inc.; salaried employees of the NTN-Bower Corporation; former employees of NTN-BCA Corporation; and hourly employees of the NTN-Bower Macomb, Illinois plant (collectively, the "Companies") who have completed one hour of service per month during two months of employment with the Companies. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

The Plan provides for employee salary 401(k) contributions subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan allows participants to contribute a portion of their compensation on an after-tax basis. Participants age 50 or older are eligible to make catch-up contributions. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Eligible employees are automatically enrolled in the Plan after meeting the eligibility requirements at a 3 percent pretax contribution rate unless they elect otherwise. The Plan includes an auto-escalation feature of 1 percent per year up to a maximum of 6 percent unless the participant specifically elects otherwise.

The Plan provides for safe harbor employer matching contributions equal to 100 percent of the first 1 percent of eligible compensation contributed by an employee and 50 percent thereafter for the next 5 percent of eligible compensation.

The Plan provides for an additional nonelective discretionary contribution for participants hired on or before July 1, 2019, equal to 1.5 percent of eligible compensation paid to each eligible employee.

The Plan provides for an additional discretionary contribution, referred to as a Retiree Medical Contribution for eligible participants, as defined in the plan document.

#### **Participant Notes Receivable**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$5,000 or 50 percent of their account balances. The notes receivable are secured by the balance in the participant's account and bear interest at rates that range from 4.25 percent to 9.50 percent, which are commensurate with local prevailing rates determined periodically by the plan administrator. Repayment terms in general may not exceed five years unless the loan is used for the purchase or construction of a principal residence. Principal and interest are paid ratably through ACH. A participant may not have more than one loan outstanding at any time.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Companies' contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Vesting**

Participants are immediately 100 percent vested in employee salary contributions, rollover contributions, and any income or loss thereon.

Vesting in the Companies' matching and discretionary contribution portion of the participants' accounts is determined in accordance with the following schedule:

***Benefit Payments***

Upon termination of service due to death, disability, or retirement (at age 65), a participant or beneficiary may elect to receive a single, lump-sum amount equal to the value of the participant's vested interest in his or her account, installments over a specified period, or direct rollover distribution.

Participants may request that all or a portion of their accounts be distributed after attaining the age of 59½ or in the case of financial hardship, as defined in the plan document.

***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. Any remaining forfeitures are to be allocated to participants in the manner described in the Plan. At December 31, 2024 and 2023, forfeited account balances were insignificant. During the year ended December 31, 2024, forfeitures used to reduce employer contributions were insignificant.

***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Empower Annuity Insurance Company and Empower Trust Company, LLC or their affiliates. Empower Annuity Insurance Company and Empower Trust Company, LLC are service providers of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

***Termination***

While they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation and Income Recognition***

The Plan's investment are stated at fair value except as noted below. The fully benefit-responsive unallocated contract is valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

The pooled separate accounts and collective trust fund are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. There are no redemption restrictions or unfunded commitments on these investments. All other investments are valued based on quoted market prices reported in active markets. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

### Note 2 - Summary of Significant Accounting Policies (Continued)

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Various administrative costs are paid by the Companies.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### ***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including September 25, 2025, which is the date the financial statements were available to be issued.

### Note 3 - Certified Information

Empower Annuity Insurance Company and Empower Trust Company, LLC hold the Plan's investments and execute all related transactions. The investment balances and related income and losses, other than those noted below, included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by Empower Annuity Insurance Company and Empower Trust Company, LLC.

The Plan's investments in mutual funds totaling \$204,884,667 as of December 31, 2023 and investment income on mutual funds of \$3,427,694 for the year ended December 31, 2024 were not certified. The Plan's investments in participant notes receivable totaling \$5,480,575 as of December 31, 2023 and related interest income on participant notes receivable of \$34,517 for the year ended December 31, 2024 were not certified.

### Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

**Note 5 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

**Level 1**

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

**Level 2**

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan’s assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

**Note 6 - Investment Contracts**

The Plan has a benefit-responsive investment contract with Empower Annuity Insurance Company (EAIC). EAIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a semiannual basis for resetting but may not be less than 1.50 percent. When establishing interest crediting rates for this product, EAIC considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer’s general account.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and which require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

As described in Note 2, because the contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets attributable to the investment contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.
