## **INDEPENDENT AUDITOR'S REPORT**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Goodwill Industries of Central Oklahoma, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024, and 2023 stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Supplemental Schedule Required by ERISA**

The supplemental schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**1. PLAN DESCRIPTION**

The following description of Goodwill Industries of Central Oklahoma, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

**General and Administration** - The Plan is a fully participant directed contribution plan covering all eligible employees of Goodwill Industries of Central Oklahoma, Inc. (the “Company”). The Plan was established on January 1, 2009 and last amended on November 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). Administrative costs are primarily paid through transaction fees charged to participant accounts to cover the cost of loans and distributions. Some costs of administration are absorbed by the Company, at no cost to the Plan.

**Contributions** - Participants may make contributions during the plan year through regular payroll deductions which are limited by provisions of the Internal Revenue Code and is adjusted periodically for increases in the cost of living. Participants age 50 and older are eligible to make additional catch-up contributions. When participants have (a) attained the age of 21, and (b) met the sixty days of eligibility service requirement, they become eligible to participate in all deferral types. Participants may elect to defer up to 80% of their annual plan compensation. Participant rollover contributions are permitted under the plan document.

The Company, at its sole discretion may make discretionary matching and/or profit sharing contributions to the Plan based on either a uniform percentage of participant plan compensation or a flat dollar amount. The Company makes safe harbor matching contributions of 100% for the first 3% of a participant’s contributions and then 50% of the next 2%. Company matching contributions totaled \$265,670 for the year ended December 31, 2024. The Company did not make a profit-sharing contribution for the plan year ended December 31, 2024.

**Forfeitures** - The non-vested portions of participant account balances are forfeitable if a participant leaves the Plan and used to reduce Company matching contributions or pay administrative fees of the Plan. At December 31, 2024 and 2023 unallocated forfeited accounts totaled \$3,440 and \$1,257, respectively. During 2024, no funds from the forfeited accounts were used to reduce Company matching contributions.

**Participant Accounts** - Each participant’s account is credited with the participant’s contributions, allocations of Company matching contributions and/or profit sharing contributions, and plan earnings or losses.

**Vesting** - Participants are immediately vested in their elective deferral contributions and safe harbor matching contributions, plus the earnings thereon.

**Payment of Benefits** - Upon death, disability, termination of service, or reaching the age of 65, a participant or beneficiary may receive a lump-sum payment equal to the vested value of the participant’s account. In-service withdrawals are permitted for participants who have attained the age of 59 ½ or who are in a situation of financial hardship. Hardship distributions are only permitted if the relevant conditions under DOL and IRS rules and regulations have been met.

**Notes Receivable from Participants** - Notes receivable represent loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Loans are made available to all qualifying participants. A participant may borrow from his or her account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of his or her vested account balance. The repayment period of any loan will be no more than five years unless any such loan is for the purchase of a participant's primary residence. The loan is secured by the balance in the participant's account and bears interest at rates based on prevailing market rates, as specified in the plan agreement. Principal and interest are paid through payroll deductions. Loans bear interest equal to the prime rate plus 2%. All loans outstanding at December 31, 2024 have rates from 5.25% to 10.50% and mature through 2030.

**Investment Options** - Under enrollment in the Plan, a participant may direct employee contributions among a variety of investment choices in increments of one percent. Participants may change their investment options on any normal business day.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Presentation** - The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Investment Valuation and Income Recognition** - The Plan's investments, except for fully benefit responsive contracts, are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by investment advisors, trustees, and other third-parties. See Note 3 for discussion of fair value measurements.

Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. The Plan presents in the statement of changes in net assets available for benefits the net change in the fair value of its investments, which consists of the unrealized appreciation or depreciation on those investments.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes; accordingly, actual results could differ from those estimates.

**Payment of Benefits** - Benefits are recorded when paid.

**Subsequent events** - The plan administrator has evaluated subsequent events through July 30, 2025, the date the financial statements were available to be issued. There are no subsequent events requiring recognition or disclosure in the 2024 financial statements.

### 3. FAIR VALUE MEASUREMENTS

Accounting standards establish the framework for measuring fair value. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The Plan measures fair value in accordance with accounting standards that establishes a fair value hierarchy based on the observability of inputs used to measure fair value. These inputs are summarized in the three broad levels listed below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value of measurement.

In many cases, a valuation technique used to measure fair value includes inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

**Mutual funds** – The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs). While the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **4. TAX STATUS**

Beginning November 1, 2022, the Plan engaged Fidelity Management Trust Company to be the Plan’s custodian and trustee, at which time the Plan adopted a new prototype plan document sponsored by the trustee. The prototype received a determination letter from the IRS dated June 30, 2020, stating that the prototype plan document satisfies the applicable provisions of the Internal Revenue Code.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

#### **5. PARTY-IN-INTEREST TRANSACTIONS**

Certain investment funds and notes receivable from participants are managed by Fidelity Management Trust Company, and therefore qualify as party-in-interest transactions.

#### **6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. Upon termination of the Plan, the rights of the participants under the Plan shall become 100% vested and nonforfeitable.

#### **7. INFORMATION CERTIFIED OR PROVIDED BY THE TRUSTEE (UNAUDITED)**

The Trustee that held the Plan assets as of December 2024 and 2023 was Fidelity Management Trust Company (from here on referred to as “Trustee”). The following is a summary of the Plan’s financial information that is included in the financial statements based on information certified by the trustee as complete and accurate in accordance with Section 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee has certified the completeness and accuracy of all investment balances and certain activity, including investments at fair value, fully benefit-responsive investment contract at contract value, notes receivable from participants, net change in fair value of investments, interest and dividend income, and interest income on notes receivable from participants as of and for the year ended December 31, 2024, and as of December 31, 2023.

The Plan’s independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements

and supplemental schedule. The attached Schedule H, line 4i – Schedule of Assets (Held at End of Year), as well as the following amounts, have been provided and certified as complete and accurate by Fidelity Management Trust Company as of December 31, 2024, and 2023 and for the year ended December 31, 2024:
