Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Acorda Therapeutics 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). As a result of the termination, the Plan changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements.

All assets of the Plan were distributed as of December 31, 2024. As a result, the Plan ceased to exist as of December 31, 2024.

Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

1. Description of Plan

The following description of the Acorda Therapeutics 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan description for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan covering substantially all employees of Acorda Therapeutics (the "Company" or "Employer"). An employee could become eligible to participate in the Plan on the date the employee first performed an hour of service. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Employer filed under Chapter 11 of the bankruptcy code in April 2024. As a result, the Employer terminated the Plan effective July 31, 2024. As of December 31, 2024, all assets of the Plan were distributed. As a result, the Plan ceased to exist as of this date.

Contributions

Participants could elect to have a percentage deducted from their compensation as defined by the Plan. Participant contributions could be deducted in "pre-tax" dollars for the 401(k) and "post-tax" dollars for the Roth 401(k). The Plan included an auto enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan, unless they affirmatively elected not to participate, with a default rate set at 10% of their eligible compensation. Participants who attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans. A participant could elect to increase, decrease or suspend deductions according to procedures established by the Company. There was an annual limit as to the amount that could be deducted from compensation that was determined by the Internal Revenue Code ("IRC").

For each dollar an employee contributed to the Plan up to 6% of their eligible compensation, the Company contributed an additional 50 cents into the Plan. The Company made discretionary matching contributions of \$367,358 for the year ended December 31, 2024.

As a result of the Plan's termination, all contributions to the Plan ceased July 31, 2024.

Participant Accounts

Each participant's account was credited with the participant's contribution and allocations of (a) the Employer's contribution and (b) Plan earnings (losses) thereon. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account. All investments were participant directed.

A participant was 100% vested in his or her deferral and rollover accounts including allocated earnings thereon at all times. For any Employer matching and non-elective contributions, the following vesting schedule applied prior to termination.

Due to the termination of the Plan, all participants became 100% vested in their accounts as of that date.

Forfeitures

If a participant terminated their employment with the Company, the non-vested contributions plus allocated earnings thereon could be used to reduce aggregate future Employer contributions or Plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$9,764. During 2024, \$7,867 was used to reduce Employer contributions and \$41,216 was used to reduce Plan expenses.

Notes Receivable from Participants

The Plan offered a loan feature whereby a participant (borrower) enrolled in the Plan could borrow a minimum amount of \$1,000 up to a maximum amount of 50% of their vested account balance or \$50,000 (whichever is less). Loans were collateralized by the balance in the participant's account and bear interest at rates equivalent to regional bank rates for similar loans at the time the loan was made. The loan must be repaid within a five-year period, unless the loan was used to acquire the principal residence of the borrower which must be repaid within a fifteen-year period. A participant could not have more than one loan outstanding at any one time. Principal and interest were paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service, participants could elect for payment to be made in a lump sum or in an amount the participant designates from time to time. Benefits could also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which were considered hardship withdrawals, cannot exceed the amount required to relieve the financial need.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

As a result of the Plan's termination (see Note 1), the Plan changed its basis of accounting from the going concern basis to the liquidation basis. All assets of the Plan have been distributed as of December 31, 2024 and expenses to liquidate the Plan will be paid by the Company. The accompanying financial statements are prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") which requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan followed U.S. GAAP guidance on *Fair Value Measurements* which defined fair value and established a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2023, the Plan's investments were valued using level 1 inputs.

Investment Valuation and Income Recognition

The Plan's investments were stated at fair value. Mutual funds were valued at the daily closing price as reported by the funds. Mutual funds held by the Plan were registered with the Securities and Exchange Commission. These funds were required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

Purchases and sales of investments were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation in fair value of investments included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceased to make loan repayments and the plan administrator deemed the loan to be in default, the participant loan balance was reduced and a benefit payment was recorded.

Payment of Benefits

Benefits were recorded when paid.

Expenses

Certain expenses of maintaining the Plan were paid by the Company and were excluded from these financial statements. Investment related expenses were included in net appreciation in fair value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is September 10, 2025.

3. Information Certified (Unaudited)

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC, a qualified institution.

4. Tax Status

The Plan's prototype plan document preparer has obtained an opinion letter dated June 30, 2020 from the Internal Revenue Service ("IRS") stating that the Plan is designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

5. Party-in-Interest Transactions

Participants who were active employees could borrow from their accounts and such loans qualified as exempt party-in-interest transactions under ERISA. These loans were recorded as notes receivable from participants in the statements of net assets available for benefits.
