To the Plan Trustees of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Tingue, Brown and Co. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules ("DOL") and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institutions").

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTES TO FINANCIAL STATEMENTS

Note 1 - Description of the Plan:

The following description of the Tingue, Brown & Co. 401(k) Plan (the “Plan”) provides only general information and is presented to assist in understanding the Plan’s financial statements. The financial statements and notes are representations of the Plan’s management, which is responsible for their integrity and objectivity. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution profit sharing plan covering all full-time employees of Tingue, Brown & Co. and subsidiaries (the “Company” or the “Plan Sponsor”), who have elected to participate. Employees are eligible to participate at eighteen years of age and after completion of three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Administration - The Plan is administered by the Plan Sponsor. The Plan’s assets are held by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, collectively (“Empower”), the Trustees of the Plan (the “Trustees”), who are responsible for the custody and management of the Plan’s assets.

Automatic Enrollment - Beginning August 1, 2013, all employees meeting the eligibility and service requirements noted above, are automatically enrolled in the Plan. Employees are deemed to have elected a pre-tax contribution of 3% of their Plan compensation in the absence of an affirmative election in the contrary. Effective January 1, 2022, the Plan was amended to include an automatic deferral percentage increase that will increase participant’s deferral percentage by 1% per year up to a maximum of 10% of compensation.

Contributions - Employees who are eligible and voluntarily elect to participate in the Plan must contribute at least 1%, but not to exceed 100%, of compensation through pre-tax or Roth payroll deductions. No employee is permitted to make contributions in excess of the dollar limitation specified in the Internal Revenue Code (“IRC”). Participants may also rollover amounts representing pre-tax distributions from other qualified defined benefit or defined contribution plans.

Effective January 1, 2022, the Plan was amended to include a safe harbor contribution. The Company will match 100% of participant contributions up to 1% of employee compensation plus 50% of participant contributions from 1% to 6% of compensation. Safe harbor employer contributions totaled \$342,408 for the year ended December 31, 2024.

The Company may make an employer discretionary additional matching contribution. The discretionary additional matching contribution will not apply to elective deferrals exceeding 6% of compensation and will not exceed 4% of compensation. The Company may also make an employer nonelective contribution that is at the discretion of the Company and is allocated based on a formula that takes participants compensation into account. There were no employer discretionary matching contributions or employer nonelective contributions for the year ended December 31, 2024.

Participant contributions are made through voluntary payroll deductions elected by each participant. Individual accounts are maintained for each Plan participant by the Trustees of the Plan.

Vesting - All participants are immediately 100% vested in their voluntary contributions to the Plan, plus actual earnings thereon. Participants become 100% vested in safe harbor employer contributions after two years of credited service. Participants vest in employer discretionary matching contributions and employer nonelective contributions at a rate of 25% per year, becoming fully vested after four years of credited service. Each participant is credited with a year of service for each Plan year that they reach 1,000 hours of service from their date of hire until their termination date.

Participant Accounts - Each participant's account is credited/charged with the participant's contribution and allocation of (a) the Company's contribution, if any, (b) Plan earnings/losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants - Participants may borrow from their individual account balances in accordance with Plan provisions. The minimum loan is \$1,000, and the maximum amount of any loan shall not exceed the lesser of 50% of a participant's vested balance or \$50,000. Loans are repaid via automatic payroll deductions in equal installments, one per pay period, representing a combination of interest and principal sufficient to amortize the loans over their terms. Generally, repayment terms are not to exceed five years; however, if the loans are used to fund the purchase of a principal residence of the participant, the repayment period shall be a reasonable period which may exceed five years but cannot extend beyond the participant's retirement date. Each loan bears interest at a rate equal to 1% over the Prime Rate published in the Wall Street Journal on the first business day of the month the loan is originated. A participant is permitted to have a maximum of two loans within the Plan outstanding at any point in time.

Payment of Benefits - Under the Plan, normal retirement age is 65. Upon attaining the normal retirement age, a participant becomes fully vested in his or her account. Termination withdrawals result from disability, retirement, termination, or death. Prior to the normal retirement age, withdrawals from the Plan are allowed if a financial hardship is proven.

Forfeitures - Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures may be used to reduce the Company matching contributions or cover administrative expenses of the Plan. For the year ended December 31, 2024, no forfeitures were used. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$34,496 and \$12,351, respectively.

Note 2 - Summary of Significant Accounting Policies:

Basis of Accounting - The accompanying financial statements are prepared on the accrual basis of accounting.

Investment contracts held by defined contribution plans are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive group annuity contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions in net assets available for benefits during the reporting period. Actual results, as determined at a later date, could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value (except for fully-benefit responsive group annuity contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by its investment advisors, trustees, and insurance company. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes received from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment management and advisor fees are also shown as administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan Administrator deemed the participant loan to be in default, the participant loan is reduced and a benefit payment is recorded.

Benefit Payments - Benefits are recorded when paid.

Hardship Withdrawals - The Plan provides for hardship withdrawals from participants' vested balances, not to exceed an amount required to meet an immediate need created by hardship, and then only to the extent that such immediate need cannot be satisfied by other sources reasonably available to the participant. Permissible circumstances for hardship withdrawals include medical expenses, purchase of a home, tuition payments, amounts necessary to prevent eviction from the participants' personal residence, and such other circumstances as the Plan Administrator may determine in accordance with Internal Revenue Service rules and regulations.

Cash and Equivalents - Cash and equivalents include money market funds and all other highly liquid short-term investments purchased with maturities of three months or less.

Subsequent Events - The Plan Administrator has reviewed and evaluated all events and transactions from December 31, 2024 through October 2, 2025, the date the financial statements were available to be issued. The effect of those events and transactions that provide additional pertinent information about conditions that existed at the Statements of Net Assets Available for Benefits date have been recognized in the accompanying financial statements.

Note 3 - Certified Investment Information:

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, the Trustees, qualified institutions, have certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.

- Investment income, as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- Investment information included in the Schedule H, Part IV, Line 4i - Schedule of Assets (Held at End of Year), as of December 31, 2024, as shown on the ERISA-required supplemental schedule of assets (held at end of year).

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule of assets (held at end of year).

Note 4 - Fair Value Measurement:

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, Fair Value Measurements, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Mutual funds: Valued at the closing price in the active market in which the fund is traded.
- Cash and equivalents: Valued at the closing price in the active market in which they are traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Transfers Between Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. For the years ended December 31, 2024 and 2023, there were no significant transfers in or out of Levels 1, 2, or 3.

Note 5 - Group Annuity Contract with Insurance Company:

The Plan entered into a benefit-responsive group annuity contract with Empower Annuity Insurance Company of America (the “Issuer”), which maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and interest at a specific rate that is guaranteed to the Plan.

As described in Note 2, the group annuity contract meets the fully benefit-responsive investment criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive group annuity contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The contract value of the group annuity contract was \$0 and \$490,541 at December 31, 2024 and 2023, respectively. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract cannot be terminated before the scheduled maturity date.

The Plan’s ability to receive amounts due in accordance with group annuity contract is dependent on the third-party Issuer’s ability to meet its financial obligations. The Issuer’s ability to meet its contractual obligations may be affected by economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the Trust to be tax-exempt under Section 501(a) of the IRC.
2. Premature termination of the contracts.
3. Plan termination or merger.
4. Changes to the Plan's prohibition on competing investment options.
5. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events that allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines.
2. A breach of material obligation under the contract.
3. A material misrepresentation.
4. A material amendment to the agreements without the consent of the issuer.

Note 6 - Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and the Company also has the right under the Plan to terminate the Plan subject to the provisions of the IRC. In the event of Plan termination, participants' contributions remain fully vested and Company contributions become fully vested as of the Plan termination date. Under no circumstances may the Company take ownership of any of the Plan's assets as a result of such termination.

Note 7 - Tax Status:

The Plan was written on an Internal Revenue Service ("IRS") non-standardized pre-approved document, which obtained its latest opinion letter on November 14, 2022 in which the IRS stated that the Plan as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

NOTES TO FINANCIAL STATEMENTS

Note 8 - Risks and Uncertainties and Concentration of Investments Risk:

Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the financial statements.

The Plan may invest in funds with contractual cash flows, such as asset backed securities, collateralized mortgage obligations and commercial mortgage backed securities, including securities backed by sub-prime mortgage loans. The value, liquidity and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

The Plan's investment in three funds comprises approximately 51% of total investments at December 31, 2024. The Plan's investment in four funds comprised approximately 56% of total investments at December 31, 2023.

Note 9 - Party-In-Interest:

Certain Plan investments are managed by the Trustees, who also provide investment management and administrative services, and Concurrent Investment Advisors, who serve as the investment advisor to the Plan. These transactions qualify as party-in-interest. The fees paid by the Plan for these services for the year ended December 31, 2024 were \$60,544.
