**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Madison Wood Preservers, Inc. ### **NOTE 1—DESCRIPTION OF PLAN:**

The following description of the Madison Wood Preservers, Inc. Profit Sharing 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

#### **General**

The Plan is a defined contribution pension plan covering all eligible employees of Madison Wood Preservers, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan trustees are responsible for oversight of the Plan, determine the appropriateness of the Plan's investment offerings, and monitor investment performance.

#### **Eligibility**

Eligible employees are those who have completed six months of service and are age 21 or older.

#### **Contributions**

Each year, participants may contribute up to the maximum allowed by law of their pretax annual compensation, as defined in the Plan. They may designate all or a portion of their elective deferrals as Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans and individual retirement accounts. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2 percent of eligible compensation and their contributions invested in a designated fund until changed by the participant. The Company makes a non-elective contribution of 2 percent of compensation for the payroll period of each employee who is an active participant on the last day of the payroll period. In addition, the Company may make matching contributions equal to a discretionary percentage of salary deferrals and profit-sharing contributions for eligible participants. Participants direct the investment of all contributions into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and Company non-elective and matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their account is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

#### NOTE 1—DESCRIPTION OF PLAN: (CONTINUED)

##### Payment of Benefits

On termination of service, a participant may elect to receive the value of the participant's vested interest in his or her account, as a monthly annuity, substantially equal installments, partial withdrawals, or a single lump-sum amount. In-service withdrawals are permitted for participants who have attained age 59 1/2 or for a qualified financial hardship.

##### Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$11,080 and \$10,866, respectively. These accounts will be used to reduce future employer contributions, to pay administrative expenses of the Plan, or be allocated to eligible participants. During 2024, \$10,975 was used to reduce employer contributions and \$0 was used to pay administrative expenses.

#### NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

##### Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

##### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustee determine the Plan's valuation policies utilizing information provided by the investment adviser, Principal Life Insurance Company ("PLIC"), and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("PTC"). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### Payment of Benefits

Benefits are recorded when paid.

**NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES: (CONTINUED)**

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of benefits paid are charged directly to the participant's account and are included in administrative expenses. Investment related expenses paid indirectly through revenue sharing arrangements are included in net appreciation of fair value of investments.

**NOTE 3—INFORMATION CERTIFIED BY PLAN'S TRUSTEE:**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2023 was obtained by management and agreed to or derived from the information certified as complete and accurate by Principal Life Insurance Company (the trustee of the Plan). The information has not been audited by the Plan's independent auditors.

#### NOTE 4–FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quotes prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts:* Valued by PLIC, the sponsor of the pooled separate accounts, at net asset value ("NAV"). The NAV is based on the fair value of the underlying investments held by each account less its liabilities. The NAV is published daily and available to plan participants and is the basis for current transactions.

**NOTE 5–RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS:**

Certain Plan investments are pooled separate accounts sponsored by PLIC. PLIC and PTC are the recordkeeper and the custodian, respectively, for the Plan and are responsible for the investment of and accounting for Plan assets. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity. These transactions qualify as exempt party-in-interest transactions under ERISA.

**NOTE 6–TAX STATUS:**

The IRS has determined and informed the pre-approved plan sponsor by a letter dated March 31, 2014, that the pre-approved plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (the IRC). Although the pre-approved plan has been amended since receiving the advisory opinion letter, the Plan administrator and the pre-approved plan sponsor believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan’s tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. There are currently no income tax examinations in process.

### NOTE 7-PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in the company contribution portion of their account.

### NOTE 8-RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
