Opinion

We have audited the financial statements of the ***Modern Plumbing Industries ESOP and Trust*** (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the "financial statements").

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis of Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Independent Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. 1. DESCRIPTION OF THE PLAN

The following description of the *Modern Plumbing Industries ESOP and Trust* (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

Modern Plumbing Industries, Inc. (the "Company") established the Plan effective January 1, 2023. The Plan operates as a leveraged employee stock ownership plan ("ESOP"), and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (the "Code") of 1986, as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan is administered by the Company. The Company retained the services of an independent third party as the Plan's trustee (the "Trustee").

On May 31, 2023, the Plan purchased the outstanding Modern Plumbing Industries, Inc. common stock ("Company Stock") using the proceeds of a loan from the Company in the amount of \$1,000,000 (see Note 5), and holds the stock in a trust established under the Plan. The borrowing is to be repaid over a period of 30 years by fully deductible Company contributions to the trust. As the Plan makes each payment of principal and interest, an appropriate percentage of stock will be allocated to eligible employees' accounts in accordance with applicable regulations under the Code. The stock was purchased at a price of \$1 per share for an aggregate purchase price of \$1,000,000.

The borrowing is collateralized by the unallocated shares of Company Stock and is guaranteed by the Company. The Company has no rights against shares once they are allocated under the ESOP. Accordingly, the financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to:

- (a) the accounts of employees with vested rights in allocated stock ("allocated"), and
- (b) stock not yet allocated to employees ("unallocated")

Eligibility

Employees of the Company aged 18 or older are generally eligible to participate in the Plan after one year of service, providing they worked at least 1,000 hours during such period. Participants who do not have at least 1,000 hours of service during such Plan year or are not employed on the last working day of a Plan year are generally not eligible for an allocation of Company contributions for such year.

Contributions

The Plan is funded by contributions of the Company, in cash or shares of the Company Stock in an amount determined by the Plan documents. The Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan's earnings from dividends and interest, equals the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan. Participant contributions are not permitted.

Participant Accounts and Forfeitures

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of (a) shares of the Company Stock released by the Trustee from the unallocated account and (b) forfeitures of terminated participants' nonvested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on a participant's credited points, relative to the total points of all eligible participants. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance.

Plan forfeitures are eligible for allocation at the earlier of a) distribution of the entire vested portion of the terminated participant's account balance or b) the last day of the Plan year in which a terminated participant incurs five consecutive one year breaks in service. Terminated participants with no vested account balance are deemed distributed at the date of termination. Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation of all participants for the Plan year. There were \$2,305 of forfeitures allocated to participants from forfeited nonvested accounts in 2024.

Vesting

A participant's interest in the Plan is fully vested after six years of credited service or when they reach the normal retirement date (65 years of age), permanent disability, or death. If a participant's employment with the Company ends for any reason other than retirement, permanent disability, or death, he or she will vest in the balance in his or her account based on total years of service with the Company. A participant becomes 20% vested after two years of credited service and increases ratably until fully vested after six years of credited service. Employees who terminate before vesting forfeit their nonvested interest in the Plan after a one year break in service. Participants terminating from the Plan receive no allocation of employer contributions or forfeitures in the year they terminate from the Plan.

Payment of Benefits

No distributions from the Plan will be made until a participant retires, becomes disabled, dies (in which case, payment shall be made to his or her beneficiary or, if none, his or her legal representatives), or otherwise terminates employment with the Company. Distributions are made in cash or, if a participant elects, in the form of Company Stock plus cash for any fractional share. Under the provisions of the Plan, the Company is obligated to repurchase participant shares which have been distributed under the terms of the Plan as long as the shares are not publicly traded or if the shares are subject to trading limitations. Notwithstanding the foregoing, no distribution of Company Stock that was acquired with the proceeds of an "exempt" loan will be made until the close of the Plan year in which the loan is fully repaid.

If a participant's benefit payment does not exceed \$5,000, the participant will be entitled to a distribution of a lump-sum payment as soon as administratively feasible in the Plan year after the participant has terminated service. If the participant's account balance exceeds \$5,000, the participant may elect to receive a single lump-sum cash payment on or after the close of the Plan year after the Plan year of termination of employment or installment payments over a period not to exceed the participant's life expectancy or five years.

During 2024, the Company did not repurchase any participant shares.

Voting Rights

All Company stock held by the trust shall be voted by the Trustees. Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustees prior to the time that such rights are to be exercised. The Trustees shall vote any unallocated shares held by the trust, as well as any allocated shares for which a participant has failed to give timely voting direction for the collective best interest of the Plan participants and beneficiaries.

Put Option

Under federal income tax regulations, the Company Stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its common stock distributed to participants for which there is no market. The put price is intended to be representative of the fair market value of the Company's common stock. The Company can finance any common stock repurchase with interest over a period not exceeding five years. The purpose of the put option is to ensure that the participants have the ability to ultimately obtain cash for the value of their shares.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. The election to diversify is made subsequent to year end based upon the shares of Company Stock in the participant's account at year end. During 2024, there were no purchases from participants to diversify their Company Stock.

Administration of Plan Assets

The Plan's assets, which consist principally of Company Stock, are held by the Trustees of the Plan.

Company contributions are held and managed by the Trustee, which invests cash received, interest, and dividend income and makes distributions to participants. The Trustee also administers the payment of interest and principal on the loans, which are reimbursed to the Trustee through contributions as determined by the Company.

Certain administrative functions are performed by officers or employees of the Company or its subsidiaries. No such officer or employee receives compensation from the Plan. Certain administrative expenses including Trustee fees are paid directly by the Company.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. The fair value of Modern Plumbing Industries, Inc. Company Stock is one such significant estimate. Actual results could differ from those estimates.

Allocations

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated Company Stock ("allocated") and (b) Company Stock not yet allocated to employees ("unallocated"), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Investment Valuation and Income Recognition

The shares of Company common stock are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisor and Trustees. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Realized gains and losses from security transactions are reported on the average cost method. Net change in fair value of investments includes the Plan's aggregate gains and losses on investments bought and sold as well as held during the year.

Contributions

Employer contributions are recorded in the period in which they become obligations of the Company.

Benefits Paid to Participants

Benefit payments to participants are recorded when paid.

Administrative Expenses

The Plan's administrative expenses are paid directly by the Company and are excluded from these financial statements. Interest expense was paid by the Plan.

Subsequent Events

In preparing these financial statements, Plan management has evaluated, for potential recognition or disclosure, significant events or transactions that occurred during the period subsequent to the most recent statement of net assets available for benefits presented herein, through the date these financial statements were available to be issued.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurements. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Modern Plumbing Industries, Inc. Company Stock: The fair value of the Company Stock held by the Plan is valued at estimated fair value based upon an independent appraisal. This appraisal was based upon a combination of the market and income valuation techniques consistent with prior years. The appraiser took into account historical and projected cash flows and net income, return on assets, return on equity, market comparables, and estimated fair value of company assets and liabilities. Plan management has concluded that a market participant would also recognize a discount for lack of marketability.

The valuation process involves Plan management's selection of an independent appraiser. Plan management accumulates the data for the appraiser from the audited consolidated financial statements of the Company. The appraiser prepares a preliminary report which Plan management, along with the ESOP Trustee, reviews in detail, discusses and approves. The results of this process are documented in minutes of the Plan fiduciary. The estimated fair value of Company Stock as of December 31, 2024, was \$2.90 per share.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. LOAN PAYABLE

On May 31, 2023, the Plan entered into a \$1,000,000 term loan agreement (the "agreement") with the Company. The loan is an exempt loan in accordance with Section 4975(d)(3) of the Code, Treasury Regulations Section 54.4975-7(b), Section 408(b)(3) of ERISA. The proceeds of the loan were used to purchase 1,000,000 shares of the Company Stock. Unallocated shares are collateral for the loan. The agreement provides for the loan to be repaid in 30 equal annual installments beginning December 31, 2023 and maturing on December 31, 2052. The loan bears interest at 2.82%. During 2023, the loan payment was made subsequent to the end of the year and the Plan accrued \$16,456 in interest.

6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in Company Stock and had indebtedness with the Company. These are related party and party-in-interest transactions. As described in Note 2, the Company pays substantially all Plan expenses. The Plan has a number of service providers. Such providers are parties-in-interest under ERISA and related transactions are exempt from prohibited transactions rules.

7. TAX STATUS

The Plan and related trust has applied for a determination letter from the Internal Revenue Service. Management believes that the Plan and trust, as then designed, is in compliance with the applicable requirements of the Code and the related trust is tax-exempt.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan may be subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan agreement and the Code. Upon termination of the Plan, the Plan's Administrative Committee shall direct the Trustees to pay all liabilities and expenses of the trust fund.

9. RISKS AND ECONOMIC UNCERTAINTIES

The Plan has investments in the Company Stock of the Plan sponsor, which is exposed to various risks, such as interest rate, market and credit risks as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk anticipated with the investment in the common stock and uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the fair value of the common stock will occur in the near term and that such changes could materially affect the amount reported in the statements of net assets available for benefits and changes in net assets available for benefits.
