Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Husson University Section 403(b) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan by a bank or similar institution, or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section,

- The amounts and disclosures in the 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles (U.S. GAAP).
- The information in the 2024 financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with U.S. generally accepted auditing standards (U.S. GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the 2024 Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with U.S. GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with U.S. GAAS, we:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with U.S. GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. Description of Plan

The following description of the Husson University Section 403(b) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a 403(b) defined contribution plan covering employees of Husson University (the University). Student workers are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Employees are immediately eligible to participate in the Plan. Employees enter the Plan on the first pay date following the date their employment begins. Participants must complete one year of service and work 1,000 hours to become eligible to receive University contributions.

The Plan document is a volume submitter plan sponsored by The Variable Annuity Life Insurance Company (VALIC). Balances are part of a group contract and there are no more additions being made to existing individual contracts under the Plan. The group contract is funded via a custodial account and, as such, there is a custodial agreement between the Plan and AIG Federal Savings Bank (AIG). There is a separate group unallocated annuity contract between the Plan and VALIC.

Contributions

Each year, participants may contribute pre-tax deferrals of a specific amount or percentage of eligible compensation, as defined by the Plan. The Plan includes an auto enrollment provision whereby all newly eligible employees working 30 or more hours per week are automatically enrolled in the Plan, unless they affirmatively elect not to participate in the Plan or elect to have a specified amount contributed to the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated fund until changed by the participant. Eligible participants can also make Roth deferral contributions, which are contributions based on after-tax compensation. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. In addition, participants at any age with at least 15 years of service may make special Internal Revenue Code (IRC) Section 403(b) catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers several mutual funds, pooled separate account options, and insurance company general account options as investment options for participants. Contributions are subject to certain IRC limitations.

The University makes a 2% non-elective contribution to all eligible employees who work 1,000 hours, and have completed one year of service, as defined in the Plan document. The University may also make an additional discretionary non-elective contribution; however, there was no additional non-elective contribution for the year ended December 31, 2024. The calculation of the 2% non-elective contributions is determined and deposited each pay period and the additional discretionary non-elective contribution is determined and deposited annually, if applicable.

The University also makes a match contribution equal to 4% of the participants' defined compensation for those participants who contribute at least 3% to the Plan. The calculation of match contributions is determined and deposited each pay period.

Participant Accounts

Each participant's account is credited with the participant's contributions, University contributions, and allocations of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting Provisions

Participants are vested immediately in their contributions, plus actual earnings thereon. University contributions are also immediately 100% vested.

Account Balances Associated with Defaulted Plan Loans

In years prior to the January 1, 2009 Plan document restatement, participants invested in contracts at The Lincoln National Life Insurance Company (Lincoln) and VALIC were allowed to borrow from their fund accounts. Such loans are secured by the participants' balances in their investments in insurance company general accounts (fixed funds) and bear interest at 3%. Based on management's assessment of the employment status of the participants having outstanding balances and their payment histories, it has been concluded that realization of losses on balances outstanding at year-end will be immaterial.

Payment of Benefits

Upon termination of service, death, disability, or retirement, participants, or their beneficiaries, as applicable, may request a distribution in a lump sum amount, a form of installment payments, or the purchase of an annuity contract. A lump-sum distribution is automatically distributed to the participant upon termination of service if the vested account balance is \$1,000 or less. Participants may choose to roll over distributions to other eligible retirement plans. The Plan also allows for in-service distributions in the event of a financial hardship, as defined in the Plan document, or upon attainment of age 59½. Benefit payments on balances contributed prior to June 3, 2013 are in the form of a joint and survivor annuity.

Administrative Expenses

The University absorbs a significant amount of administrative costs on behalf of the Plan. Expenses that are paid by the University are excluded from these financial statements.

Plan-to-Plan Transfers

The Plan provides for transfers of individual annuity contracts to and from other IRC Section 403(b) plans, with the requirement that the corresponding plan also allows for such transfers.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (U.S. GAAP).

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in sub-accounts of variable annuity contracts, mutual funds, a pooled separate account, and a guaranteed annuity account. Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Account Balances Associated with Defaulted Plan Loans

Account balances associated with defaulted Plan loans represent the value of collateral (the participant accounts used to secure loans made prior to January 1, 2009) which had defaulted prior to the end of the Plan's reporting period. Collateral is reclassified as a distribution upon complete distribution of the related account balances, based upon the terms agreed upon by the insurance carrier.

Payment of Benefits

Benefits payments are recorded when paid.

Subsequent Events

The Plan has considered subsequent events through September 12, 2025, the date the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date;

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets,
- Quoted prices for identical or similar assets or liabilities in inactive markets,
- Inputs other than quoted prices that are observable for the asset or liability, and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability; and

Level 3: Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Account: Accumulation Unit Values (UV) are derived by the fund administrators, using a factor calculation and daily pricing files for the underlying shares of investments. Most of the underlying investments are priced using market quotation from independent pricing services.

Fixed Annuity Insurance Company General Accounts: Units are valued based upon principal contributions, plus accumulated interest, less contract withdrawals and charges, which is a cost-based approach. As stated above, fair value in accordance with accounting literature is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, which is a market-based approach.

Teachers Insurance and Annuity Association (TIAA) and College Retirement Equities Fund (CREF) assert that, based on two theories, contract value approximates a market-based approach. A fair value estimate of this investment has not been provided to the Plan, other than on a cost-based approach. However, TIAA and CREF have used a quantitative model, using 25 years of data for this investment as a whole, to demonstrate that discounted cash flows, based upon an 87% correlation between the 10-year treasury rate and the TIAA Traditional Annuity average return, supports one of its two theories of why the contract value approximates fair value using discounted cash flows. The other theory is based upon participant investments to this fund, by choice, represents willing market participation and orderly transactions. Management is unable to conclude whether there may be a material difference between contract value and fair value using a discounted cash flows model for the Plan.

Lincoln asserts that the value of the investment contract is derived from the contract provisions and, therefore, contract value and fair value are the same when the creditworthiness of Lincoln is in good standing.

VALIC asserts that the fair value of its investment contracts is the amount which is payable on demand on the reporting date, which is contract value.

Management has reviewed the Plan's investments in the non-benefit-responsive fixed annuity insurance company general accounts and determined, based on the evaluation of the credit ratings and other financial data pertaining to the issuer, that it agrees with the vendors' assessments that contract value approximates fair value, as of the Plan's year-end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values.

Furthermore, although management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investment restrictions – CREF accounts – Accumulation units in CREF Accounts are available for transactions at the closing accumulation unit value on any day the New York Stock Exchange (NYSE) is open for business. In an effort to reduce market timing and excessive trading, shareholders will be locked out of an account for 90 days if a purchase, sale, and repurchase within that account is made within a 60-day period, other than for the CREF Money Market Account.

Investment restrictions – TIAA Real Estate Account (REA) – Accumulation units in the REA are available for transactions at the closing accumulation unit value on any day the NYSE is open for business. Transfers out of the REA are limited to one per calendar quarter. Although the underlying assets of the REA cannot be quickly sold and converted to liquid assets, the TIAA general account provides the REA with a liquidity guarantee – i.e., TIAA ensures that the REA has funds available to meet participant redemption, transfer, or cash withdrawal requests.

Investment restrictions – TIAA Traditional (non-benefit-responsive portion) – see Note 4.

Investment restrictions – Lincoln Fixed Accounts – see Note 4.

4. Investment Contracts with Insurance Companies

The Plan invests in TIAA Traditional Annuities, including both fully benefit-responsive and non-benefit-responsive fixed annuity contract options that are fully and unconditionally guaranteed by TIAA. During the accumulation phase, the TIAA Traditional Annuity provides a guarantee of principal, a guaranteed minimum rate of interest, and the potential for additional interest if declared by TIAA. When the accumulation is converted to an annuity based on life expectancy, the present value of the stream of payments is equal to the accumulation. The accounts are carried at contract value which, according to TIAA and CREF, approximates fair value.

TIAA issues various types of contracts as funding vehicles for retirement plans. Certain contract types contain liquidity restrictions on the redemption of TIAA Traditional Annuity accumulations, which could impact the value realized upon exiting the contract. Distributions, withdrawals, and transfers can only be made in ten annual installments. There are no liquidity restrictions on the benefit-responsive traditional contract option.

Because a portion of the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of net assets available for benefits. The contract value of TIAA Traditional Annuity equals the accumulated cash contributions, interest credited to the Plan's contracts, and transfers, if any, less any withdrawals and transfers, if any. There are no reserves against contract value for credit risk of the contract issuer or otherwise. There are no known events that will limit the participant's ability to transact at contract value with TIAA. There are no known events or conditions that will allow TIAA to terminate the contract and settle at an amount different than contract value.

Lincoln Financial Fixed Accounts

The Plan, through individual annuity contracts, invests in a Fixed Account option with Lincoln, which is a non-benefit-responsive fixed annuity contract. Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate for a defined period, based on deposit dates. Participant withdrawals and transfers to other investment options are subject to a five-year payout period, or penalty for early withdrawal. Management has determined the amount of the potential surrender charge to be immaterial to the financial statements. The account is carried at fair value as represented by the issuer.

Fixed account contracts with Lincoln also include acquired contracts of UNUM. Such contracts are non-benefit-responsive and operate similarly to the Lincoln contracts in the preceding paragraph, except that they are subject to a 4% surrender charge for withdrawals of lump-sum payments or transfers to another annuity contract. Management has determined the amount of the potential surrender charge to be immaterial to the financial statements. The account is carried at fair value as represented by the issuer.

VALIC Fixed Accounts

The Plan, through individual annuity contracts, also invests in three Fixed Account options with VALIC which, except for one contract (fixed interest), are non-benefit-responsive fixed annuity contracts. VALIC maintains the contributions in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate for a defined period, based on deposit dates. Under the fixed interest fully benefit-responsive traditional investment contract, participant transactions are effected solely at contract value; therefore, contract value is the relevant measurement attribute for that portion of net assets available for benefits. There are no known events that will limit the participant's ability to transact at contract value with VALIC. There are no known events or conditions that will allow VALIC to terminate the contract and settle at an amount different than contract value. There are no liquidity restrictions on the benefit-responsive contract option.

5. Information Prepared and Certified by Custodians

The financial information included in the Plan's financial statements and supplemental schedule regarding investment assets and account balances associated with defaulted Plan loans as of December 31, 2024 and 2023, net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, has been obtained by management and agreed to or derived from information certified as complete and accurate by the custodians in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

6. Related-Party Transactions and Party-in-Interest Transactions

Certain plan investments, as of December 31, 2024 and 2023, and for the year ended December 31, 2024, were managed by TIAA and CREF, Lincoln, and VALIC, who are the custodians of the Plan. Since all service providers are considered parties-in-interest, such transactions are considered to be party-in-interest transactions under ERISA.

7. Plan Termination

Although it has not expressed any intent to do so, the University has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions or ERISA.

8. Tax Status

The Plan's terms have been drafted in reliance on the sample language provided by the Internal Revenue Service. The Plan is required to operate in conformity with the IRC to maintain the exclusion from tax for plan participants. The Plan does not have letters of tax exempt qualification; however, the plan administrator, with the assistance of the Plan's document provider, believes that the Plan is currently designed and being operated in compliance with the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.
