### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the accompanying financial statements of Valley Communications Systems, Inc. Flexible Compensation Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits – modified cash basis for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Valley Communications Systems, Inc. Flexible Compensation Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Valley Communications Systems, Inc. Flexible Compensation Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. ### **Basis for Accounting**

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. **1. DESCRIPTION OF THE PLAN**

The following brief description of the Valley Communications Systems, Inc. Flexible Compensation Profit Sharing Plan (“the Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All employees are eligible to participate on the first day of each month, after they have completed six months of service.

The plan sponsor is Valley Communications Systems Inc., a Massachusetts Company (the “Company”) that is engaged in the business of providing engineered audio and visual equipment, sales, and services.

**Contributions**

For 2024, eligible employees of the Company (participants) may contribute up to \$23,000 of pre-tax annual compensation as defined in the Plan. Participants over the age of 50 can contribute a maximum of \$30,500. The Internal Revenue Service adjusts this maximum annually. Participants have sole discretion to direct their contributions into various investment options offered by the Plan.

**Matching contributions**

The Company matches fifty percent of the participants’ pre-tax contribution up to three percent of their annual compensation, as defined in the plan.

**Employer optional profit sharing contributions**

Additional discretionary profit sharing amounts may be contributed at the option of the Company’s Board of Directors and are invested in each participant’s portfolio of investments in the same manner as the salary deferrals. For the years ended December 31, 2024 and 2023, the profit-sharing contributions were \$96,000 and \$80,000, respectively.

**Rollovers**

Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans.

**Participant accounts**

Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contributions and plan earnings. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. All accounts are participant directed.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100 % vested in the Company’s contribution after six years of credited service.

**Notes receivable from participants**

Participants can borrow from their fund accounts the lesser of 50% of their account balance with a maximum loan amount of \$50,000. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant loans fund. All loans must be repaid within five years. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest, as determined by the Plan's trustees. Principal and interest is paid ratably through weekly payroll deductions. In the event of a default, death, disability or termination of employment, the entire outstanding principal and accrued interest shall be immediately due and payable. There were loans totaling \$71,796 and \$81,852, outstanding on December 31, 2024 and 2023, respectively.

**Investment options**

Upon enrollment in the Plan, all contributions made to the Accounts of Participants shall be held for investment by Fidelity Management Trust Company, the custodian. Each participant shall direct the investment of his account among the permissible investments designated in the Service Agreement.

**Payment of benefits**

On termination of service due to death, disability or retirement, a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, or various installment plans. Refunds of contributions in excess of the Section 401(k) limits are included in this category.

**Forfeited accounts**

Participant forfeitures are used by the Plan sponsor to pay plan expenses. At December 31, 2024 and 2023 there were \$44,107 and \$108,241, respectively in the forfeited non-vested accounts.

**2. SIGNIFICANT ACCOUNTING POLICIES**

This summary of significant accounting policies of the Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management, who are responsible for their integrity and objectivity. These accounting policies conform to generally accepted accounting principles and have been consistently applied in the preparation of the financial statements.

**Basis of accounting**

The Plan's policy is to prepare its financial statements on the modified cash basis of accounting; revenues are recognized when received rather than when earned, and expenses and purchases of assets are recognized when cash is disbursed rather than when the obligation is incurred. Modifications from the cash basis of accounting include investments which are stated at their current market values.

**Business activity**

The Plan is responsible for administering employee and employer contributions for employees of the Employer. The Plan collects funds from the employer and transfers the collections to Fidelity Management Trust Company who invests and distributes the funds.

**Investments**

The Plan maintains policies and procedures to value instruments using the best and most relevant data available. In addition, the Plan has an investment management team that reviews valuation, including independent price validation for certain instruments. Further, in most instances, management develops internal valuations of the assets and instruments held in the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the cash basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of benefits**

Benefits are recorded when payable under the terms of the Plan.

**Operating expenses**

All expenses of maintaining the Plan are paid directly by the Company, unless the forfeiture account is used, or a combination of both.

**Fair value**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 3 for discussion of fair value measurements.

Accounting Standards Codification provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Accounting Standards Codification are described as follows:

- Level 1 valuations reflect quoted market or exchange prices for the actual or identical assets or liabilities in active markets.
- Level 2 valuations reflect inputs other than quoted prices in Level 1 which are observable. The inputs can include some or all of the following into a valuation model:
  - quoted prices on similar assets in active markets
  - quoted prices on actual assets that are not active
  - inputs other than quoted prices such as yield curves, volatilities, prepayments speeds inputs derived from market data.
- Level 3 valuations reflect valuations in which one or more of the significant valuation inputs are not observable in an active market, there is limited if any market activity, and/or are based on management inputs into valuation model.

**Income tax status**

The Plan, an adopted prototype, obtained its latest determination letter on March 31, 2014, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirement of the Internal Revenue Code under Section 401. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan has adopted Accounting Standards Codification, "Accounting for Uncertainty in Income Taxes." Accounting Standards Codification prescribes a comprehensive model for the financial statement recognition, measurement, classification and disclosure of uncertain tax positions. Management has not identified any uncertain tax positions and, therefore, no liability has been recorded in the financial statements.

The Plan's income tax filings are subject to audit by the Internal Revenue Service and Department of Labor.

**Accounting estimates**

The preparation of financial statements in conformity with the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual result may differ from those estimates.

**Subsequent events**

Management has evaluated subsequent events through August 29, 2025 the date which the financial statements were available to be issued.

**3. INVESTMENTS**

Investments – mutual funds are valued using a daily valuation system by the custodian which takes into account available market prices and third party valuations making them Level 1 assets.

**4. PLAN TERMINATION**

Although it has not expressed any interest to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 2024 and 2023, was obtained by the Plan administrator and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the custodian of the Plan).

**6. RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the custodian and record keeper for the Plan and, therefore, these transactions qualify as party in interest transactions.

Fidelity Management Trust Company provides certain administrative services to the Plan pursuant to a Service Agreement between the Plan and Fidelity Management Trust Company. Fidelity Management Trust Company receives revenue directly from mutual fund service providers for services Fidelity Management Trust Company provides to the funds. This revenue is used to cover and/or offset certain amounts owed to Fidelity Management Trust Company for its administrative services to the Plan.

**7. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
