Note 1. Description of Plan

General

The following brief description of Harkins Administrative Services, Inc. 401(k) Profit Sharing Plan (Plan) is provided for general information purposes only. Participants should refer to the plan document for a complete description of the Plan's provisions.

The Plan is a defined-contribution plan sponsored by Harkins Administrative Services, Inc. (Company and plan administrator) for the benefit of its employees who are 21 years of age or older. Terms of the agreement provide for covered employees to become participants generally after completion of 60 days of service, as defined. Entry to the Plan is on the first day of the month coinciding with or following the date an employee satisfies the eligibility requirements. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Minnesota Life Insurance Company serves as custodian.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 100% of their eligible compensation. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The Plan includes a Basic Safe Harbor Matching Contributions provision. Under this provision, when a participant makes salary deferrals, the Company will match those deferrals by contributing an amount equal to 100% of the deferrals up to 6% of compensation, as defined in the Plan. The Company may also make discretionary profit-sharing contributions each year to the Plan. No discretionary profit-sharing contributions were made in 2024. Contributions are subject to certain IRS limitations.

Participant Investment Account Options

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's contributions, as well as allocations of Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan, as applicable. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their voluntary and rollover contributions plus actual earnings thereon. Participants are also immediately vested in the Company's Safe Harbor matching contributions plus actual earnings thereon. Participants vest in the Company's profit-sharing contributions portion of their accounts based on years of credited service, as defined. A participant is 100% vested in profit sharing contributions after three years of credited service.

If a participant reaches normal retirement age (age 62), dies, or becomes totally disabled, the participant becomes fully vested in Company discretionary contributions, irrespective of years of service.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum not to exceed the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's

account and bear interest at the trustee's prime rate. The loans are required to be paid over a maximum of five years or longer if the loan is for the purchase of a primary residence. For loans obtained prior to October 1, 2020, principal and interest payments are paid ratably through payroll deductions. For loans obtained on or after October 1, 2020, principal and interest are paid through direct debit from the participant's personal checking account.

Payment of Benefits

On termination of service, a participant may elect to receive a lump-sum amount equal to the value of his or her vested account or installment payments, as defined.

Forfeiture Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$0 and \$1,900, respectively. Forfeitures may be used to reduce future employer contributions or to pay administrative expenses, which would otherwise be paid by the Plan. During 2024, no forfeited accounts were used to reduce employer contributions and approximately \$1,900 were used to pay administrative expenses.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect the reported amount of net assets and the reported amounts of additions to and deductions from net assets. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable From Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses, including but not limited to bank charges, investment fees, commissions, accounting and auditing fees, and similar charges may be paid by the Company. If not paid by the Company, then such charges will be paid by the Plan and charged directly to participants' accounts, as applicable. Investment related expenses are included in net depreciation in fair value of investments.

Note 3. Certification of Custodians

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as of and for the year ended December 31, 2024, The Standard Company, and as of December 31, 2023, Minnesota Life Insurance Company—both qualified institutions—have certified that the investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate.

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments. As described in Note 2, expenses for benefits paid to participants are charged directly to the participant's account. The Company pays directly any other fees related to the Plan's operations.

Note 5. Disclosures About Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities

Level 2 Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities

Level 3 Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

The following is a description of the valuation methodology and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Pooled Separate Accounts

Pooled separate accounts are valued at estimated fair value as provided by Minnesota Life Insurance Company. The fair value is based on the fair value of the underlying investments held by the fund. Pooled separate accounts are made up of a wide variety of underlying investments such as equities, preferred stock, bonds, mutual funds, and commercial real estate.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 7. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a volume submitter profit sharing plan document sponsored by Minnesota Life Insurance Company. This volume submitter plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress

Note 8. Risks and Uncertainties

The Plan provides for various investment options in pooled separate accounts, which invest in any combination of stocks, bonds, fixed income securities, and other investment securities. Investment securities are exposed to various risks, such as interest rate, market fluctuation, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 9. Subsequent Events

The Plan has evaluated subsequent events through September 28, 2025, the date the financial statements were available to be issued.


