Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of MCCi 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of MCCi 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgement made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about MCCi 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedule Required by ERISA

The supplemental *Schedule of Assets (Held at End of Year)*, as of and for the year ended December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial

statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO THE FINANCIAL STATEMENTS
DECEMBER 31, 2024

NOTE 1: *Description of the Plan*

The following description of MCCi (the “Employer”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more comprehensive description of the Plan’s provisions.

General

The Plan is a defined-contribution plan covering all full-time and part-time employees of the Employer who have completed three consecutive months of service, are age 18 and older, and are not residents of Puerto Rico. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employees are generally eligible to participate in the Plan and receive employer matching contributions after three months of service.

Auto Enrollment

The Plan enacted an auto enrollment provision as of January 1, 2020, to encourage participation and retirement savings among employees. Newly eligible employees, who do not return their wage deferral agreement, will be automatically enrolled in the Plan with a 2% deferral election. Automatically enrolled participants are enrolled in the Vanguard Target Date Retirement fund according to their date of birth. Employees may change their deferral election at the beginning of each quarter. Each year, the Employer distributes a notice to their employees explaining the auto enrollment and default investment procedures.

Contributions

Participants may contribute up to the dollar limit set by law of their pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or contribution plans. The Employer may match employee deferrals at the option of the Employer’s Board of Directors. For the years ended December 31, 2024 and 2023, the Employer matched 50% of employees’ deferrals up to 7% of eligible compensation. Participants are permitted to designate all, or a portion of, their elective deferrals as Roth elective deferrals. Contributions are subject to certain limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and an allocation of (a) the Employer’s contribution, (b) Plan earnings net of administrative expenses, and (c) forfeitures of terminated participants’ non-vested account balances. Allocations are based on participant earnings or account balances, as prescribed by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTE 1: *Description of the Plan (Continued)*

Forfeitures

Amounts that are forfeited due to a participant's termination of employment prior to vesting in company contributions made on the participant's behalf are used to restore forfeitures and reduce employer matching, or to offset administrative expenses in subsequent periods. For the year ended December 31, 2024, forfeited nonvested accounts totaling \$11,833 were allocated to participants' accounts to offset matching contributions and \$18,594 were allocated to offset plan administrative expenses.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer's matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

Investment Options

Upon enrollment in the Plan, a participant may direct employee and employer contributions, and earnings thereon, in any of a variety of options selected by the Plan trustees. Generally, the investment options offered to participants for the year ended December 31, 2024 were mutual funds.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant (or beneficiary) may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. In addition, in-service distributions may be made under certain conditions. The Plan provides that distributions of amounts of \$1,000 or less do not require consent and are only paid as lump sums.

Administration

The Plan's trustee and custodian is Charles Schwab Bank. The third-party administrator is The Pension Corporation of America in Cincinnati, OH.

Plan Restatement

The Plan was restated effective January 1, 2022. This restatement incorporates the changes made to the Plan. It also includes addendums that are required by the IRS to reflect recent changes in laws. The two addendums that were included in this restatement were the Hardship Distribution Addendum and the SECURE/CARES/CAA Addendum.

NOTE 2: *Summary of Accounting Policies*

Basis of Accounting

The Plan's policy is to prepare their financial statements on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date. Expenses are recognized in the period in which they are incurred.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Terminated Balances

The account balance of terminated employees who have not elected to withdraw from the Plan as of December 31, 2024 was \$585,711. The Plan Document outlines the procedure for the Plan Administrator to follow when a terminated employee, with a balance remaining, can no longer be located.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Payment of Benefits

Benefits payments are recorded when paid.

Operating Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Other administrative expenses of maintaining the Plan are paid by the Plan and allocated proportionally based on the value of each participant's account. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Subsequent events were evaluated through August 8, 2025, which is the date the financial statements were available to be issued. As of this date, no subsequent events were noted.

NOTE 3: *Income Tax Status*

The Internal Revenue Service has ruled that the Plan qualifies under Section 401(a) of the Internal Revenue Code (IRC) and, therefore, the related trust is exempt from tax pursuant to Section 501(a) of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods.

NOTE 4: *Fair Value Measurement*

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The Plan has Level 1 and Level 2 assets only. The levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 inputs to the valuation methodology include the following:
 - Quoted prices for similar assets or liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in inactive markets
 - Inputs other than quoted prices that are observable for the asset or liability
 - Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 4: Fair Value Measurement (Continued)

The following is a description of the valuation methodologies used for assets measured at fair value.

- *Mutual funds*: Valued at the net asset value of shares held by the plan at year end.
- *Common/Collective Trusts*: Valued by computing unit prices based on the market values of the underlying fund assets.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5: *Investments - Participant Directed*

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following investment information was certified by Charles Schwab Bank and was not subjected to any auditing procedures performed by the independent public accountants.

- a. Total investments as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 are \$7,061,781 and \$5,644,740, respectively.
- b. Net investment income as shown in the accompanying statement of changes in net assets available for benefits of \$767,754 for the year ended December 31, 2024.
- c. All investment-related information in the accompanying supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024.

NOTE 6: *Plan Termination*

Although it has not expressed any interest to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 7: *Transactions with Parties-In-Interest*

Fees paid during the year for legal, accounting, and other services rendered by parties-in-interest were based on customary and reasonable rates for such services. These administrative expenses were paid by the Plan Sponsor.

NOTE 8: *Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.
