Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Turning Point Community Programs 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 of the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

1. DESCRIPTION OF THE PLAN

The following description of the Turning Point Community Programs 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan allows contributions to be made for all eligible employees of Turning Point Community Programs (the Sponsor).

Administration – The Sponsor is the administrator of the Plan and, as such, carries out the duties imposed under ERISA. The Sponsor has delegated certain responsibilities for the operation and administration of the Plan. Principal Financial Group (the Trustee) is the appointed custodian of the Plan's assets. Administrative and recordkeeping services are provided by FuturePlan. Certain investments are managed by Principal Financial Group; therefore, the related transactions are party-in-interest transactions.

Eligibility – All employees become eligible to make salary deferrals into the Plan on the first day of the month coincident with or next following their hire date. And all employees become eligible to receive employer safe harbor, matching contributions, and employer discretionary contributions in the Plan after completion of one year of service with a minimum of 1,000 hours during the year of service or the first year in which they complete 1,000 hours of service. Plan entry for employer contributions is semi-annual, defined as the first day of the 1st and 7th months of the Plan year. Employees must also be at least 21 years of age to participate in the Plan.

Contributions – Participants may contribute up to the maximum amount allowed by IRS limitations through salary deferrals. Participants are also permitted to deposit into the Plan distributions received from other plans (rollovers).

Employer contributions – The Sponsor provides a 3% “safe harbor” contribution on behalf of eligible employees. The Sponsor may make discretionary matching contributions and additional employer contributions to the Plan. There were no matching or discretionary contributions to the Plan for the year ended December 31, 2024.

Investment election – The Plan offers various investment alternatives through the Trustee. Plan participants direct their contributions among these investment alternatives.

Participant accounts – Individual accounts are maintained for each Plan participant to reflect the participant's contributions and employer contribution. In addition, participant accounts are credited with the earnings on their investments as earned. The vested balance in a participant's account is the benefit to which the participant would be entitled upon termination or retirement.

Vesting – Participants’ contributions, rollovers from other qualified plans, and employer safe harbor contributions are 100% vested at all times. However, employees are subject to the following vesting schedule for employer matching and discretionary contributions.

Payment of benefits – Benefits are payable upon retirement, termination, disability, hardship or death. Benefits are paid in either a single lump sum distribution or a rollover to another qualified plan or an individual retirement account.

Costs of administration – The expenses associated with administering the Plan are paid from the Plan net assets and therefore, are reflected in the Plan’s financial statements.

Participant loans – The Plan does not allow participant loans.

Forfeitures – Upon termination of employment, the unvested portion of a participant’s employer contributions account is forfeited. Forfeitures may be used to reduce administrative expenses, to pay employer contributions, or provide additional employer discretionary contributions. The forfeiture account balance was \$37,067 and \$160,490 at December 31, 2024 and 2023, respectively.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment valuation and income recognition – Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024

The Plan's investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Purchases and sales of securities are recorded on a trade-date basis. Interest income and gains (losses) are recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Payment of benefits – Benefits are recorded when paid.

Income taxes – The Plan is a volume submitter defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on March 31, 2014, which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

The Plan has applied the accounting principles related to accounting for uncertainty in income taxes and has determined that there is no material impact on the financial statements. With some exceptions, the Plan is no longer subject to U.S. federal and state income tax examinations by tax authorities for years prior to 2020.

Use of estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Subsequent events have been reviewed through October 3, 2025, the date the financial statements were available to be issued. Management concluded that no material subsequent events have occurred since December 31, 2024 that require recognition or disclosure in the financial statements.

3. BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Principal Fixed Income Guaranteed Option is a guaranteed annuity account that guarantees principal and a contractually specified interest rate. It offers the opportunity for stability of principal and a declared interest rate. The interest rate was 1.55% as of December 31, 2024 and 2023 and did not change during the year ended December 31, 2024. The interest rate reset on June 1, 2025, changing to 1.65%, and will reset again in November 30, 2025. This contract does have surrender charges if it is terminated by the contract holder, or a plan terminates its interest in such contract within certain time periods. This contract is considered benefit responsive. The Principal Fixed Income Guaranteed Option contract value as reported on the statements of net assets available for benefits was \$55,782 and \$54,557 at December 31, 2024 and 2023, respectively.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within a fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual funds: The Plan's mutual funds are valued using market quotations or prices obtained from independent pricing services and calculate a share value or net asset value each day.

The Plan's mutual funds are classified within Level 1 of the fair value hierarchy because the underlying investments are measured by pricing on publicly traded markets with reasonable levels of price transparency and are valued each day. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. INFORMATION CERTIFIED BY THE TRUSTEE (UNAUDITED)

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net depreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Financial Group (the Trustee).

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to terminate the Plan subject to provisions of ERISA.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
