

VI. Principal Plan Provisions - A summary of the main operational features of the Plan is as follows:

- A. Effective Date – August 31, 1974.

- B. Eligibility - On the January 1 nearest two Years of Service and attainment of age 21.

- C. Benefit Service - All Plan Years (Jan. 1-Dec. 31) of 1000 hours are counted.

- D. Retirement Date - The first of the month following age 60 or the later completion of 10 Years of Participation but not beyond age 65 and 5 Years of Participation.

- E. Benefit Formula - A monthly life annuity at Normal Retirement Date equal to 100% of the highest 3 consecutive 3 year Average Compensation prorated for less than 10 Years of Service. Effective 1/31/2001, the accrual of future benefits, except for required Top-Heavy Minimums, has been frozen.

- F. Pre Retirement Death Benefit - The benefit which can be provided by the Actuarial Equivalent of the accrued retirement pension.

- G. Vesting – All participants are 100% vested due to the freezing of accruals.

V. Actuarial Assumptions

A. Funding – The following actuarial assumptions were used in the calculation of the required contribution:

- 1) Interest Rate – Mandated Segment Rates of 4.21/4.75%, 4.86/4.87% and 4.87/5.59% were used for the maximum and the minimum respectively. The Effective Interest Rate was 5.26%.
- 2) Mortality Table – The 2024 Applicable Mortality Table was used for the post-retirement period.
- 3) Salary Scale – It was assumed that salaries would remain constant until Normal Retirement Date.
- 4) Severance Discount – No discount for early severance was assumed.
- 5) Retirement Age – It was assumed that employees would retire on their Normal Retirement Date or immediately if later.
- 6) Asset Valuation – Assets were valued at market value for purposes of calculating the required contribution.
- 7) Actuarial Cost Method – No longer applicable. Method is now mandated.
