### **Notes to Financial Statements**

December 31, 2024 and 2023

#### **Note 1. Description of the Plan**

Heat and Frost Insulators Local 34 Pension Plan (the Plan) was established in 1965, as a result of collective bargaining agreements between the local union and various employers to provide benefits for eligible participants and their beneficiaries upon termination or retirement. The Plan is a multiemployer defined contribution retirement plan and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is administered by a joint board of trustees consisting of an equal number of union and employer representatives. Plan benefits are not insured by the Pension Benefit Guaranty Corporation.

The Plan covers all participants working for an employer under the provisions of a collective bargaining agreement and entitles participants to be eligible upon meeting certain requirements, as defined by the Plan.

An individual account is established for each participant. Employer contributions are credited to the individual account and are adjusted for Plan earnings or losses thereon, less administrative and related expenses. Administrative expenses are allocated to participants' accounts. Allocations are based on participant earnings or account balances, as defined. A participant's account is fully vested immediately upon the participant's entry into the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Participants may also contribute amounts representing distributions from other qualified retirement contribution plans (rollovers).

Participants direct the investment of contributions into various investment options offered by the Plan. In the absence of participant direction, contributions are invested in a qualified default investment alternative until changed by the participant. Participants must evaluate their own investment goals and objectives and choose the investments best suited to achieve those goals and objectives. Poor investment performance by funds selected by the participants may cause their vested balances to be lower than the amounts contributed to the Plan on their behalf.

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested account balance. Note terms are up to 60 months, unless the loan is used to buy or build the participant's principal residence, in which case the maximum term is determined at the time of the loan. Loans are secured by the balance in the participant's account and bear interest at a rate of prime rate plus 1.5%. The interest rate on loan balances as of December 31, 2024 and 2023 ranged from 4.25% to 10.00%. Principal and interest are repaid ratably by the participants through payroll deductions.

## **Note 1. Description of the Plan (continued)**

Benefits are generally payable at early retirement (age 52), normal retirement (age 62), death or separation from service. The Plan also allows for distributions to active employees upon reaching age 62. Benefits may be paid in the form of a lump-sum, partial distribution or monthly installments.

Participants should refer to the summary plan description for more complete information.

## **Note 2. Summary of Significant Accounting Policies**

**Method of Accounting** - The accompanying financial statements have been prepared using the accrual basis of accounting.

**Investments** - Investments of the Plan are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. For all other investments, the fair value of a financial instrument is the amount that would be received to sell that asset (or paid to transfer a liability) in an orderly transaction between market participants at the measurement date (the exit price). Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Purchases and sales of investments are reflected on a trade-date basis.

Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Related fees are recorded as administrative expenses when incurred. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

**Contributions Receivable** - Employer contributions due and not paid at year end are recorded as contributions receivable. Contributions owed as a result of payroll compliance audits are recorded upon settlement with the employer. An allowance for uncollectible accounts is considered unnecessary and is not provided.

**Revenue Recognition** - Revenue derived from employer contributions is recognized in the period in which covered work is performed, based on the number of hours worked in covered employment and the contribution rates currently in effect, as set forth in the collective bargaining agreements. Employers are required to remit contributions monthly. The Plan carries out its purpose described in Note 1 within the mechanical insulator industry primarily located in Minnesota and western Wisconsin.

## **Note 2. Summary of Significant Accounting Policies (continued)**

**Reciprocal Contributions** - The Plan is signatory to reciprocity agreements with various multiemployer retirement plans for its participants who perform work outside the geographical jurisdiction of the local union. Participants who are normally employed within the territory of one local union (home local union) may be temporarily employed within the territory of another local union (reciprocating local union). When a participant works in the territory of a reciprocating local union, the latter is to make contributions to the former's benefit plans on the participant's behalf. Monies received by the Plan on behalf of persons from outside participating local unions are forwarded to their home local union benefit plans. The Plan uses the same recognition and measurement criteria for contributions received on behalf of its participants under the terms of reciprocity agreements as for all other employer contribution revenue. Amounts paid to other plans under the terms of reciprocity agreements are not reflected in the statements of changes in net assets available for benefits, as the amounts received are not revenue earned by the Plan, and the corresponding payments are not an expense of the Plan. The Plan recognizes a liability upon receiving reciprocal contributions on behalf of non-participants working within the jurisdiction of the local union, and recognizes a decrease in that liability upon remitting those contributions to the appropriate plan. Employer contributions included reciprocal contributions of \$57,959 and \$135,603 for the years ended December 31, 2024 and 2023, respectively, from various other retirement plans under the terms of reciprocity agreements. The Plan remitted a total of \$163,610 and \$451,372 in reciprocal contributions to various other retirement plans under the terms of reciprocity agreements for the years ended December 31, 2024 and 2023, respectively. Amounts owed to other plans for reciprocal contributions were not considered to be material as of both December 31, 2024 and 2023.

**Service Credit Income** - The Plan has an agreement with John Hancock Trust Company (John Hancock) for recordkeeping services and administration. The agreement calls for an annual fee of \$79 per participant paid to the Plan quarterly. In addition, John Hancock receives revenue from certain share classes of mutual funds that pay fees such as 12b-1 or sub transfer agency fees, and John Hancock transfers this revenue to the Plan. During the years ended December 31, 2024 and 2023, the Plan received \$147,875 and \$228,749 respectively, in service credit income, which was allocated to those participants' accounts that generated the income.

**Payment of Benefits** - Benefits paid to participants are recorded upon distribution. There were no amounts allocated to participants who elected to withdraw from the Plan who were not paid at either December 31, 2024 or 2023.

**Expense Offsetting Arrangement** - Certain investment related expenses are included in net appreciation in fair value of investments.

**Reclassifications** - Certain reclassifications have been made to prior year amounts to conform to the current year presentation.

## **Note 2. Summary of Significant Accounting Policies (continued)**

**Estimates** - The preparation of financial statements in accordance with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

**Subsequent Events** - Subsequent events have been evaluated through September 16, 2025, which is the date the financial statements were available to be issued.

## **Note 3. Priorities upon Termination**

It is the intent of the Trustees to continue the Plan in full force and effect; however, the right to discontinue the Plan is reserved to the Trustees. Termination shall not permit any part of the Plan assets to be used for or diverted to purposes other than the exclusive benefit of the participants and their beneficiaries, except that provision may be made for payment of necessary expenses resulting from termination of the Plan.

In the event of termination, the net assets of the Plan will be allocated to pay benefits in priorities as prescribed by ERISA and its related regulations. Whether or not a particular participant will receive the full benefits should the Plan terminate at some future time will depend on the sufficiency of the Plan's net assets at that time and the priority of those benefits.

## **Note 4. Tax Status**

The Plan's latest determination letter is dated August 10, 2015, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. The Plan's administrator and the Plan's legal counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken and recognize a tax liability if the Plan has taken uncertain tax positions that more likely than not would not be sustained upon examination by tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## Note 5. Fair Value Measurements

The *Fair Value Measurements and Disclosures* Topic of the Financial Accounting Standards Board Accounting Standards Codification established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

### Basis of Fair Value Measurement

Level 1	Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities
Level 2	Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly
Level 3	Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable

The Plan's investments in mutual funds are classified within Level 1 of the fair value measurements hierarchy. The fair values of the mutual funds are determined by reference to the funds' underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds are traded on national securities exchanges and are valued at the net asset value on the last business day of each period presented.

The Plan has a significant portion of its assets invested in a certain equity mutual fund. The equity mutual fund represented approximately 20% of the Plan's net assets available for benefits as of both December 31, 2024 and 2023. The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across the Plan's investments. Additionally, the investments within each directed fund are further diversified into varied financial instruments.

Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and amounts reported in the statements of net assets available for benefits. The current economic environment has increased the degree of uncertainty.

## **Note 6. Group Annuity Contract**

The Plan has a traditional fully benefit-responsive group annuity contract with New York Life Insurance Company that invests in a pooled separate account. The pooled separate account is invested primarily in fixed income securities, which are owned by New York Life Insurance Company. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

New York Life Insurance Company, the group annuity contract issuer, is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer and is subject to change daily. The minimum interest crediting rate cannot be less than zero. The crediting rate was 3.73% and 3.86% at December 31, 2024 and 2023, respectively.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by New York Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value. The Plan is generally entitled to the full contract value of the investment contract if the Plan provides sufficient advance notice of termination to the investment manager. Twelve months' notice is considered sufficient advance notice of termination according to the investment contract. The Plan administrator believes the occurrence of such events that would also limit the Plan's ability to transact at contract value with Plan participants is not probable.

## **Note 7. Funding Policy**

Participating employers contribute such amounts as specified in their collective bargaining agreements. Hourly contribution rates for journeymen and apprentices were \$16.00 and \$11.32 respectively, from January 1, 2023 through June 11, 2023, and \$16.75 and \$12.07 respectively, thereafter.

**Note 8. Major Employers**

Contributions from three employers accounted for approximately 40% and 47% of total employer contributions during the years ended December 31, 2024 and 2023, respectively. In the event these employers were to suspend contributions, the Plan would retain the risk of meeting fixed administrative expenses until the appropriate adjustments were made.

**Note 9. Related Organizations**

The Plan is related to a welfare plan and a local union, both of which are tax-exempt.

Contributions for the Plan and related organizations are initially received into the related welfare plan's operating account. Amounts owed are routinely transferred from the welfare plan account to the respective organizations' accounts. No amounts were due from the related welfare plan for contributions received at either December 31, 2024 or 2023.
