INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants
Star Cutter Company & Subsidiaries 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Star Cutter Company & Subsidiaries 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Note 1 – Plan Description

General

The Plan is a multiple-employer defined contribution plan that was established on January 1, 1990 by Star Cutter Company and Subsidiaries: Elk Rapids Engineering, Inc., H.B. Carbide Company, Ossineke Industries, Incorporated, Tawas Tool Company, Northern Tool Sales & Service Company, Star SU Company, LLC, and Star SU Fellows Cutter, LLC (collectively, the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The following description of the Plan is provided for general information purposes only. Participants should refer to the Summary Plan Description or the Adoption Agreement, including amendments thereto, for a complete description of the Plan's provisions.

Administration

The Plan Sponsor and named Plan Administrator is Star Cutter Company. The Plan Administrator is responsible for oversight of the Plan. The Plan Administrator has formed an Investment Committee made up of Company officers and the Manager of the Human Resources Department. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performances and oversees the reasonableness of plan expenses and fees. The Plan's Trustee and Investment Custodian was Newport Trust Company, while Matrix Trust Company was the sub-custodian. The Investment Custodian holds all of the Plan's assets and executes all of the Plan's transactions. The Company also has retained Newport Group to provide participant recordkeeping and administration services. Effective November 14, 2024, Ascensus LLC provides participants recordkeeping administration services while Ascensus Trust Company is the Plan's Trustee and Investment Custodian.

Eligibility

The Plan covers all employees of the Company. All eligible employees may begin participating in the Plan on the first day of the month following completion of six months of service.

Contributions to the Plan

Participants may contribute through payroll deferrals, as defined in the Plan Agreement, up to 100% of eligible compensation. Participants who have attained age 50 before the end of the year are eligible to make additional 'catch-up' contributions. Effective January 1, 2024, the Plan allowed for Roth deferrals.

Participants also may contribute amounts representing distributions from other defined benefit or defined contribution plans (rollovers). However, the Plan Administrator reserves the right to refuse acceptance of any rollover which might affect the status of the Plan.

Employer discretionary profit sharing contributions and discretionary matching contributions to the Plan are determined annually by the Company's Board of Directors.

The discretionary profit sharing contributions are allocated as a uniform percentage of compensation for all participants employed on December 31st with 12 months of service and a minimum of 1,000 hours of service during the year. The Board of Directors authorized a discretionary contribution on behalf of the participants of 2% of eligible wages for the year ended December 31, 2024.

The Company made discretionary matching contributions to eligible participants in 2024, with a maximum match of \$2,000 per participant. Employees are eligible to receive this match after completing six months of service.

Participants may direct the investment of both their individual contributions plus their share of employer matching and discretionary contributions into various investment options offered by the Plan. The Company's contributions are allocated in the same manner as that of the participant's elective contributions.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and employer contributions as well as plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Distribution of Benefits

On termination of service, participants whose vested account balances of \$1,000 or less will have their funds automatically rolled over to an IRA without direct consent, unless they elect otherwise. Participants whose vested account balances are greater than \$1,000, but less than \$5,000, will receive a lump sum payment unless they elect otherwise. Participants whose vested account balances exceed \$5,000 may elect a lump sum distribution, periodic equal installment payments, a partial withdrawal, or a rollover of their account balance to another qualified account. Additionally, they may also elect to defer the distribution of their plan balance. Participants who elect to have their benefit payments deferred continue to share in allocations of investment income and losses, but do not share in subsequent allocations of employer contributions. Special rules apply to distributions due to death, disability and retirement. Participants should refer to the full plan document for details.

The Plan allows for in-service distributions upon attainment of age 59 1/2 from all vested accounts. The Plan also allows for in-service distributions prior to attainment of the Plan's normal retirement age due to financial hardship, as defined in the plan document, from employee elective deferral accounts, employer matching accounts, and discretionary contribution accounts.

Vesting

The balance in each participant's salary deferral account is 100% vested at all times.

Employer matching and profit sharing contributions are subject to a cliff vesting schedule based on years of service. A participant is 100% vested after three years of credited service.

A participant's account also becomes fully vested upon the participant's death or disability.

Forfeitures

Forfeitures attributable to employer matching contributions and employer profit sharing contributions are used to offset the Plan's administrative expenses and employer contributions. The balance in the forfeitures account at December 31, 2024 and 2023 was \$7,263 and \$5,702, respectively. Forfeitures of \$23,535 and \$12,671 were used to offset administrative expenses and employer matching contributions, respectively, for the year ended December 31, 2024.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared using the accrual basis of accounting. Employer contributions are recorded when made and income from investments are recorded when they are earned. Employee contributions are recorded when withheld from pay. Expenses are recorded in the accounting period in which they are incurred.

Use of Estimates

The preparation of financial statements in accordance with generally accepted accounting principles (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the Investment Custodian and the Plan's Investment Adviser. See Note 4 for a description of the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is accrued on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Fees and Expenses

Certain of the Plan's administrative expenses, including accounting and legal fees, are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of benefit payments are charged directly to the participant's accounts and are included in administration expenses. Direct fees for custodian, recordkeeping services and investment advisory services are paid by the Plan and also are included in administration expenses. Investment related expenses are included in the net appreciation or depreciation in the fair value of investments.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 16, 2025, which is the date the financial statements were available to be issued.

Note 3 – Unaudited Investment Information Certified by the Custodians

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following information has been certified by Newport Trust Company and Ascensus Trust Company as to its completeness and accuracy and was not subjected to any auditing procedures performed by the Plan's independent auditors:

1. All investment balances reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023;
2. All investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024; and
3. All investment-related information included in the Supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024.

Note 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The Plan investments reported at fair value consist solely of mutual funds that are measured on a recurring basis using Level 1 inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023. Mutual funds are valued at daily closing prices as reported by the fund and are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

Note 5 – Fully Benefit-Responsive Investment Contract

The Plan holds an investment contract with New York Life Insurance Company (“New York Life”). The contract meets the fully benefit-responsive investment contract criteria and therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. New York Life maintains contributions to the guaranteed investment contract in an anchor account. Contract value, as reported to the Plan by New York Life, represents contributions made under the contract, plus earnings, less participant withdrawals, and administration expenses. The fully benefit-responsive investment had a contract value of \$5,309,100 and \$5,889,065 at December 31, 2024 and 2023, respectively.

The traditional investment contract held by the Plan is a guaranteed investment contract. The issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The interest crediting rate is based on the earnings of the underlying assets in the anchor account number 35. The interest crediting rate is reset semi-annually. The minimum crediting rate may not be less than the lesser of 3.0% or a rate that is not less than 1.0% and determined using the six-month average of the five-year Constant Maturity Treasury Rate. Withdrawals and transfers out are subject to a 5% annual limitation.

The Plan’s ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its financial obligations may be affected by future economic and regulatory developments.

A Plan Sponsor initiated termination of the contract is an event that could limit the ability to transact at contract value paid within 90 days. Certain other events may limit the ability of the Plan to transact at contract value with the issuer. Such events include: 1) amendments to the plan document including complete or partial termination or merger of the Plan; 2) activity such as bankruptcy that causes significant withdrawals from the Plan or contract; and 3) the failure of the Plan to continue to qualify for tax-exempt status. The Plan Administrator believes that any events that would limit the Plan’s ability to transact at contract value are remote.

Note 6 – Party-in-Interest Transactions

Certain plan investments are managed by Newport Trust Company and Ascensus Trust Company, who are the Plan’s Trustees and Investment Custodians. During the year ended December 31, 2024, the Plan paid direct compensation to the Investment Custodians for services rendered. Indirect compensation (that is netted against investment income on the statement of changes in net assets available for benefits) is paid to the Investment Custodians from total annual operating expenses charged on the balance of fund investments, depending on the particular fund. Transactions involving these investments are considered party-in-interest transactions; however, these transactions are not considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

Certain mutual funds offered by the Plan provide revenue sharing payments to the Plan. The revenue is credited to the Plan to pay certain plan related expenses. During 2024, the Plan received \$26,364 in revenue sharing payments and utilized \$23,535 of that revenue sharing to cover expenses. As of December 31, 2024 and 2023, the balance in the revenue sharing account amounted to \$15,396 and \$12,657, respectively.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan at any time subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts. Custodial fees and other operating expenses incurred after the termination date may, at the discretion of the Plan Sponsor, be paid by the Plan.

Note 8 – Plan Amendment and Tax Status

The Plan is utilizing a non-standardized pre-approved plan, which has been filed with the IRS and has received a favorable opinion letter dated June 30, 2020. The Plan Sponsor has not elected to apply for an individual IRS Determination Letter on the adoption of the Plan nor on any subsequent amendments. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with applicable provisions of the Internal Revenue Code. As a result, the Plan is qualified under Section 401(a), and the related Trust is tax-exempt as of December 31, 2024.

Effective January 1, 2024, the Plan was amended and restated to make employer matching contributions discretionary and to allow employee Roth contributions.

The Plan permitted provisions of SECURE Act 2.0 during the year ended December 31, 2024 and 2023. Written amendments to the plan document to reflect these operational changes will be adopted at a later date in accordance with the deadlines pursuant to applicable laws and IRS guidance.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
