INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Trustee
Praxis Medical Group 401(k) Plan
Pendleton, Oregon

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Praxis Medical Group 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Praxis Medical Group 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Praxis Medical Group 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Praxis Medical Group 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Plan Description

The following description of Praxis Medical Group 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Praxis Health, P.C. (the Company) who must have at least 45 days of employment (including service for companies acquired by the Company) and are age 19 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan's most recent restatement was effective January 1, 2024. The Trustee oversees the governance of the Plan.

Contributions

Participant contributions – Participants may contribute up to 80 percent of eligible annual compensation, as defined in the Plan. Participants may elect that these deferrals be treated as pre-tax or after-tax (Roth), which are accounted for separately. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers), including from terminated plans sponsored by companies that are acquired by the Company. The Plan includes an automatic enrollment provision whereby newly eligible participants are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation. Participant deferrals will automatically increase by 1 percent each year until they reach a maximum of 10 percent.

Employer match and profit-sharing contributions – The Company may elect to make discretionary matching and profit-sharing contributions to the Plan. For the years ended December 31, 2024 and 2023, the Company made a matching contribution equal to 100 percent of a non-HCE participant's elective deferrals, up to a maximum of 3 percent of eligible compensation. The Company did not make a profit-sharing contribution for years ended December 31, 2024 and 2023. To be eligible for the matching and profit-share contributions a participant must be employed for at least 45 days during the year and must be employed on the last day of the plan year. HCEs are not eligible to receive employer contributions.

Participants direct the investment of their contributions into various investment options offered by the Plan.

Participants' Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Plan Description, continued

Vesting

Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Company's contributions portion of their accounts is based on elapsed time. If termination is due to death or disability, participant is considered to be 100 percent vested. Participant's years of service will count with all Employers which have been acquired by the Company. Participants vest in the Company's contributions based on the following schedule:

For employees hired before January 1, 2009, the Company's contributions are subject to a three-year cliff vesting schedule.

Forfeited Accounts

Forfeitures are the non-vested portion of a participant's account that are lost upon termination of employment. At December 31, 2024 and 2023, unused non-vested forfeited accounts totaled \$206,888 and \$99,311, respectively. Amounts forfeited were \$205,494 and \$98,458 during the years ended December 31, 2024 and 2023, respectively. Forfeitures may be used to pay Plan administrative expenses, reduce employer contributions or may be re-allocated as additional Company contributions. For the years ended December 31, 2024 and 2023, forfeitures were used to reduce employer contributions subsequent to year-end.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant (or their designated beneficiaries) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account or direct rollover to an eligible retirement plan. The participant's account balance is payable as soon as administratively feasible after the date of the event. If the account balance is \$5,000 or under, the balance is automatically distributed as a lump sum within a reasonable amount of time after termination. Under SECURE 2.0 Act, this force out limit was increased to \$7,000 and the Plan allowed qualified domestic violence withdrawals in 2024. The Plan allows for in-service distributions at age 59½ from all accounts, as well as in the event of a hardship, subject to specific rules governing hardship distributions.

Participant Loans

The Plan does not permit participants to take a loan from their account.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Participant and employer contributions are recorded in the year in which participant contributions are withheld and underlying compensation paid.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses and Fees

Certain expenses of administering and maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Recordkeeping, transaction, and distribution fees may be paid directly from participant accounts. Investment related expenses are included as a reduction of net change in fair value of investments.

Revenue Sharing

The Plan contains a revenue sharing expense offset arrangement where the Plan is credited a fixed monthly rate which is used to pay investment advisory expenses. For the years ended December 31, 2024 and 2023, \$27,645 and \$28,192, respectively, was credited to the account and used to pay investment advisory expenses.

Excess Contributions Payable

At December 31, 2024 and 2023, a liability of \$17,209 and \$5,843, respectively, was recorded for amounts refundable by the Plan to participants for deferral contributions deposited in excess of elected or allowable amounts, including as a result of required compliance testing. This amount is included as excess contributions payable, with a corresponding corrective distribution on the accompanying financial statements. These excess contributions were distributed to participants prior to March 15 of the following year.

Recent Accounting Standard Adopted

On January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 *Financial Instruments – Credit Losses (Topic 326): Measurement of Credit Losses on Financial Instruments* and all related amendments (ASC 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. The financial assets held by the Plan that are subject to ASC 326 are employer contributions receivable and participant contributions receivable. There was no impact to the financial statements as a result of adopting this standard

3. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

3. Fair Value Measurements, continued

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies (mutual funds) – The Plan's investments are units of mutual funds held within a group annuity contract. These funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and have a readily determinable fair value.

Insurance contracts - Contracts held by the Plan are not considered fully benefit-responsive at the Plan level and are stated at fair value, which is based on contract value. Contract value is increased by contributions and earnings on the contracts, and reduced by participant withdrawals and administrative expenses. Fair value is assessed based on analysis of interest rates, maturities, discounted cash flows, and other observable inputs.

4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of full or partial Plan termination, affected participants would become 100 percent vested in their Company contributions.

5. Tax Status

Effective January 1, 2024, the Plan was restated to a non-standardized pre-approved profit sharing plan with CODA through execution of an adoption agreement. Premier Retirement Services, Inc., the sponsor of the plan, has received an opinion letter from the Internal Revenue Service dated June 30, 2020, that the adoption agreement and basic Plan document satisfy Internal Revenue Code (IRC) Section 401. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

6. Information Certified by the Plan Custodians

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly the custodians of the Plan have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate as of and for the years ended December 31, 2024 and 2023. For the years ended December 31, 2024 and 2023, the custodians were Empower Annuity Insurance Company of America and Empower Trust Company, LLC.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. Related Party Transactions

Certain Plan investments are maintained and managed by Empower Annuity Insurance Company, an affiliate of the custodian. Empower is the fiduciary, and the custodian of the Plan. Fees paid to Empower for record-keeping and investment management services were \$82,005 and \$77,416 for the years ended December 31, 2024 and 2023, respectively. These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

9. Subsequent Events

Management evaluates events and transactions that occur after the statement of net assets available for benefits date as potential subsequent events. Management has performed this evaluation through the date of the independent auditor's report.
