Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audits.

### **Supplemental Schedule Required by ERISA**

The supplemental schedule, Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### Note 1—Description of the Plan

The following description of Moseley Architects, P.C. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

*General* – The Plan is a defined contribution plan covering all eligible employees of Moseley Architects, P.C. (the “Company”). To be eligible, an employee must be at least 21 years of age. The Plan trustees determine the appropriateness of the Plan’s investment offerings, monitor investment performance and report to the Company’s Board of Directors. The Plan is subject to the provisions of Employee Retirement Income Security Act of 1974 (“ERISA”).

*Plan Administration* – The Company is the Plan sponsor and Plan administrator. Certain administrative functions are performed by employees of the Company, who receive no compensation from the Plan. The Company may reimburse the Plan for any administrative expenses incurred.

*Contributions* – The Plan provides for participant contributions of after-tax and pre-tax annual compensation, up to 100% of their annual compensation, as defined by the Plan. Participants of qualifying age may make additional catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to certain limitations allowed under Section 402(g) of the Internal Revenue Code (“IRC”).

The Company may make matching contributions at its discretion. The Company’s matching contribution percentage was 50% of the first 8% of participant compensation contributed to the Plan. The Company may also make discretionary profit-sharing contributions to the Plan. There were no profit-sharing contributions for the year ended December 31, 2024.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Plan also includes an auto-escalation provision whereby participants are subject to an annual automatic deferral rate increase of 2% until their deferral rate reaches 10% of eligible compensation. Participants may elect to discontinue their participation in the automatic deferral rate increase at any time.

*Participant Accounts* – Each participant’s account is credited with the participant’s contributions and an allocation of Company’s contributions. Participant accounts are charged with withdrawals and an allocation of the administrative expenses that are paid by the Plan. Each participant’s account is also allocated a portion of the Plan earnings and losses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participant accounts are segregated for purposes of determining the earnings or losses on each participant’s choice of investments.

*Vesting* – A participant normally becomes eligible for benefits after reaching age 65 or meeting the vesting requirements. A participant who becomes permanently disabled, dies, or reaches the early retirement requirements while employment of the Company will have a 100% vested interest in his or her account. As defined in the Plan document, the early retirement requirements are attainment of age 55 and completion of 6 years of vesting service. Participants are immediately vested in their voluntary contributions plus actual earnings thereon.

Vesting of Company contributions is determined in accordance with the participant's years of continuous service with the Company as follows:

2 years but less than 3 years	20%
3 years but less than 4 years	40%
4 years but less than 5 years	60%
5 years but less than 6 years	80%
6 years or more	100%

*Investments Options* – Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers multiple investment options for participants as of December 31, 2024. Participants may change their investment elections at any time.

*Payment of Benefits* – Distribution of the vested portion of a participant's account will occur upon the participant's termination of service, retirement, death, disability, attainment of age 59½, or hardship withdrawal, as defined in the Plan. If a participant becomes entitled to receive their benefit for any reason other than death the account will be distributed in a lump-sum payment in an amount equal to the vested value of the participant's account as defined by the Plan. At December 31, 2024, there were no benefit payments that had been requested but not yet paid.

*Forfeitures* – Forfeitures of nonvested contributions may be used to pay Plan expenses or used to offset the Company's contribution obligation. The Plan's balances in the forfeitures account were \$965 and \$25,716 as of December 31, 2024 and 2023, respectively. Forfeiture balances of \$43,586 were used to reduce employer contributions for the year ended December 31, 2024. No forfeitures were used to pay Plan expenses for the year ended December 31, 2024.

### Note 2—Summary of significant accounting policies

*Basis of Presentation* – The accompanying financial statements have been prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

*Use of Estimates* – The preparation of financial statements in conformity with U.S. GAAP requires the Plan management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition* – Investments in the Plan are reported at fair value. U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines plan valuation policies utilizing information provided by the qualified institution.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Note 2—Summary of significant accounting policies (continued)

*Contributions Receivable* – The amount of employer contributions due and payable, but not yet deposited with the Plan as of year-end is reflected as employer contributions receivable in the Plan's financial statements.

*Payment of Benefits* – Benefit payments are recorded when paid.

*Administrative Expenses* – As provided by the Plan Agreement, administrative expenses related to the Plan investments and administration are paid by the Plan, and other administrative expenses are paid by the Company. Investment related expenses are included in net appreciation of fair value of investments.

*Risks and Uncertainties* – The Plan provides for various investment fund options. Investments are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

### Note 3—Information certified by the qualified institution (unaudited)

Assets of the Plan are in the custody of Vanguard Fiduciary Trust Company (the "qualified institution"). The Plan administrator has elected the method of compliance as compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the qualified institution of the Plan has certified to the completeness and accuracy of the following data included in the accompanying financial statements.

- Investments, at fair value as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, including realized and unrealized gains and losses, and interest and dividends as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan's independent auditor did not perform auditing procedures with respect to the certified information, except for comparing such information to the related information included in the financial statements and supplemental schedule, Schedule of Assets (Held at End of Year).

### Note 4—Fair value measurements

U.S. GAAP defines three levels of inputs that may be used to measure fair value as follows:

*Level 1* – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

*Level 2* – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

*Level 3* – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There were no transfers between levels during the year ended December 31, 2024.

The following are descriptions of the valuation techniques used for assets measured at fair value. There have been no significant changes in the methodologies used at December 31, 2024 or 2023.

*Mutual Funds* – These investments are public investment vehicles valued using the net asset value (“NAV”) provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

*Common Collective Trusts* – These investments are valued based on NAV of units of the common collective trust. NAV, as provided by the qualified institution, is used as a practical expedient to estimating fair value. NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The funds' principal objective is to protect principal while providing a higher rate of return than shorter maturity investments, such as money market funds or certifications of deposits.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5—Party-in-interest transactions**

Certain investments of the Plan are managed by the qualified institution of the Plan’s assets. The qualified institution provides investment management services to the Plan. The Plan also pays fees to an investment advisor. Transactions involving these investments are considered to be party-in-interest transactions for which statutory exemption exists under DOL’s Rules and Regulations. Fees incurred by the Plan for investment management and advisory services are paid directly by the Plan and, therefore, do qualify as party-in-interest transactions for which a statutory exemption exists. Fees paid by the Plan to these parties-in-interest totaled \$168,086 for the year ended December 31, 2024.

**Note 6—Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions and the net assets would be allocated to participants of the Plan in amounts equal to the individual account balances.

**Note 7—Tax status**

The Plan has adopted a prototype non-standardized profit-sharing plan with a cash or deferral arrangement. The prototype plan received a favorable opinion letter from the Internal Revenue Service (“IRS”) on June 30, 2020, which stated the prototype plan is designed in accordance with applicable sections of IRC. The Plan has not received a determination letter specific to the Plan itself, and the Plan has been amended since receiving the opinion letter. However, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of IRC. Therefore, no provision for income taxes has been included in the financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

In accordance with U.S. GAAP related to subsequent events, the Plan has evaluated all events subsequent through September 23, 2025, the date these financial statements were available to be issued.
