



## Yang Ming (America) Corporation 401(k) Plan

### Notes to Financial Statements

#### 1. Description of Plan

The following description of Yang Ming (America) Corporation 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan’s provisions.

##### *General*

The Plan is a defined contribution pension plan established effective January 1, 1990 and covers all employees of Yang Ming (America) Corporation who have completed one year of service, have reached the age of 21 or older, and are not employees included in a bargaining unit covered by a collective bargaining agreement with the employer in the negotiation of which retirement benefits were the subject of good faith bargaining. The Plan excludes those employees who are union employees and nonresident aliens. The Plan was amended in 2021 for the relevant mandated Secure Act and CARES Act provisions adopted.

Effective September 1, 2007, all new employees who wish to participate in the Plan may do so immediately upon hiring. This opportunity also applies to employees with less than one year of service. There will be no Company match until one year of service is completed.

The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA). The Plan investments are administered and held in a trust by the Plan’s trustee, Vanguard Fiduciary Trust Company (the “Trustee”) which also serves as the custodian of the Plan. The Vanguard Group, an affiliate of the Trustee is the recordkeeper of the Plan.

##### *Contributions*

Participants in the Plan may make pre-tax contributions. The maximum allowable employee elective deferral contribution for a participant for a plan year shall be 50% of each eligible participant’s compensation limited to \$23,000 for 2024 and \$22,500 for 2023. A participant’s minimum employee elective deferral contribution shall be an amount equal to at least 1% of a participant’s applicable compensation for the Plan year. Participants may roll their funds into the Plan from another qualified plan. In addition, any participant age 50 or more may make a catch up contribution up to \$7,500 and \$7,500 for 2024 and 2023, respectively.

The Company matches employee contributions up to maximums of 11% of the participant’s compensation. Employer matching contributions were \$1,709,364 and \$1,625,770 in 2024 and 2023, respectively.

The Company may make a discretionary profit sharing contribution to the Plan allocated to the participants in the same proportion that their compensation bears to the total compensation paid to all qualifying participants. The Company did not make any profit sharing contributions for the years ended December 31, 2024 and 2023.

The maximum annual addition that may be contributed or allocated to a participant’s account under the Plan could not exceed the lesser of, 100% of a participant’s compensation or \$69,000 and \$66,000 for 2024 and 2023, respectively.

*Participant Accounts*

Each participant's account is credited with the participant's contributions and the Company's contributions, and allocations of Plan earnings. Allocations are based on participant earnings, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their account balances into various investment options offered by the Plan. At December 31, 2024 the Plan offered thirty-one funds as investment options for participants.

*Vesting*

Participants have full and immediate vesting in their contributions plus actual earnings and vest in the Company's profit sharing and matching contributions after six years of service.

A participant also has a non-forfeitable percentage of 100% in the account balance of his/her employer contribution account upon attaining normal retirement age of 59.5, while in the active service of the employer, upon death or disability while in the active service of the employer.

All years of service are credited to determine a participant's vesting service. The method for crediting vesting service is based on hours of service with 1,000 hours of service credited.

Each participant whose employment terminates for reasons other than death, disability or attainment of normal retirement age of 59.5 is entitled to a non-forfeitable right to his/her employer contribution accounts (matching contributions and non-elective contributions) based on the following schedule:

*Participant Loans*

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Interest income on participant loans are recorded on an accrual basis. The loans are secured by the balance in the participant's account and must be repaid in level payments through payroll deductions over a five year period, except for the purchase of a principal residence in which case the loans are due within a period not to exceed 10 years. The loans carry a rate of interest of prime plus one percent as set by the Plan quarterly. The interest rates on loans outstanding at December 31, 2024 and 2023 range from 4.25% to 9.50%. Loans outstanding at December 31, 2024 and 2023 totaled \$370,246 and \$390,903, respectively.

*Deemed Distributed Loans (DDLs)*

A deemed distributed loan (DDL) occurred when a participant had missed loan payments and failed to make it up by the cure period. As of December 31, 2024 and 2023, the statement of net assets identifies the loan receivable amount net of the DDL of \$ 0 and \$0, respectively.

*Payment of Benefits*

Upon termination of service, death, disability, or retirement, a participant will receive their benefits as a lump sum amount equal to the value of the participant's vested interest in his or her account. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan. At December 31, 2024 and 2023 the Company made benefit payments amounting to \$9,250,949 and \$2,533,356, respectively.

Benefit payments were related to distributions that were rolled over to another plan resulting from participants' termination of employment with the plan sponsor, adverse COVID-19 consequences, hardship withdrawal, required mandatory distributions and a voluntary distribution of 59.5 age.

The Plan also provides for hardship withdrawals to participants meeting certain requirements as described in the Plan. There were \$122,858 and \$48,238 of hardship withdrawals in 2024 and 2023, respectively.

*Forfeitures*

Forfeited accounts resulting from withdrawals of a terminated participant's account will be used to reduce employer contributions, or to pay Plan expenses if the employer elects not to pay such expenses directly. At December 31, 2024 and 2023 forfeitures totaled \$23,784 and \$30,488, which \$23,842 and \$33,430 have been applied, respectively. The unapplied forfeitures as of December 31, 2024 and 2023 was \$3,196 and \$3,050, respectively.

*Administrative Expenses*

The Company pays the expenses associated with the administration of the Plan, except for certain investment management fees, and loan fees which are deducted directly from the participant's account. At December 31, 2024 and 2023 administration expenses were not material to the financial statements.

*Investment Options*

Participants direct the investment of their contributions into various options offered by the Plan through its Trustee. The Plan's investments are held in trust and managed by the Trustee, who provides investment options for a minimum of 30 investment funds.

**2. Summary of Significant Accounting Policies**

*Basis of Accounting*

The financial statements of the Plan are prepared under the accrual method of accounting.

*Management Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation*

The Plan's investments in mutual funds are stated at fair value based on quoted market prices of the net asset value of shares held by the Plan at year end.

Unrealized appreciation and depreciation are based on the differences between the beginning of year fair values or cost if purchased during the current year, and year end fair values.

Participant loans are valued at their outstanding balances, which approximate fair value.

*Payment of Benefits / Costs and Expenses*

Benefits are recorded when paid. Costs and expenses of administering the Plan are paid by the Company.

*Recently Issued Accounting Pronouncements*

All new accounting pronouncements issued but not yet effective have been reviewed and determined to be not applicable.

**3. Fair Value Measurements**

The guidance defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Additionally, the guidance requires the use of valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs. These inputs are prioritized to valuation techniques used to measure fair value into three levels. The fair value hierarchy gives the highest priority to quoted market prices (unadjusted) in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Level 2 inputs are inputs, other than quoted prices included within Level 1, which are observable for the asset or liability, either directly or indirectly. The Plan uses Level 1 inputs when available as Level 1 inputs generally provide the most reliable evidence of fair value.

### Notes to Financial Statements

Certain investments are reported at fair value on a recurring basis in the statements of net assets available for benefits. The following methods and assumptions were used to estimate the fair values:

*Interest bearing cash, mutual funds, common stocks and other investments* — These investments consist of various publicly-traded money market funds, mutual funds and common stock. The fair values are based on quoted market prices.

The Plan’s independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**6. Plan Termination/Reorganization**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**7. Tax Status**

The Plan is based on a non-standardized prototype Plan which received a determination letter from the IRS dated August 22, 2001, stating that the Prototype Plan was designed in accordance with the provisions of the Internal Revenue Code, including provisions to comply with recent legislation. Although the Plan has been amended a few times since receiving the determination letter from the IRS, the Plan’s administrator and Trustee believe that the Plan remains designed and is currently being operated in compliance with the applicable requirements of the IRC, therefore no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United State of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions, which as of current none exists. The Plan administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

**8. Reconciliation of Financial Statements to Form 5500**

At December 31, 2024 and 2023, net assets available for benefits per the financial statements agreed to the Form 5500.

**9. Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
