Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Absolute Home Mortgage Corp. 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits – modified cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

Opinion

The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Absolute Home Mortgage Corp. 401(k) Profit Sharing Plan and Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis of Accounting

We draw attention to Note C of the financial statements, which describes the basis of accounting. The financial statements and supplemental schedule are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

B. DESCRIPTION OF PLAN:

The following description of the Absolute Home Mortgage 401(K) Profit Sharing Plan and Trust provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

1. General:

The Plan is a defined contribution plan covering all employees of the Company except union workers and nonresident aliens with no US income. An employee is eligible to join the plan once they have attained the age of 21 and completed three consecutive months of service. An employee will be eligible to receive profit sharing contributions when they attain age 21, complete one year of service and have completed at least 500 hours of service during the Plan year. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

As of February 1, 2020, the Plan provides an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated fund within the Target Date Investment Series based on the participant's age until changed by the participant.

2. Contributions:

Each year, participants may contribute as a pre-tax deferral or a Roth deferral, a percentage or dollar amount of their annual compensation not to exceed the limits imposed by IRC 401(k), 402(g), 404 and 405. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers thirty-eight various investment options to participants. The profit sharing contribution is discretionary and is invested in the participant's account based upon their investment selection. Contributions are subject to certain limitations.

3. Participant Accounts:

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's profit sharing contribution, if any, (b) plan earnings (losses), and charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

B. DESCRIPTION OF PLAN, CONTINUED:

4. Vesting:

Participants are immediately vested in their contributions and rollover amounts. Profit sharing contributions made by the Company are 100% vested after six years of service.

5. Notes Receivable from Participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and currently bear interest at a rate of 4.25% to 9.5%. The loan interest rate will be the prime rate in effect in the month that the loan is effective plus 1%. Principal and interest is paid ratably through monthly payroll deductions.

6. Payment of Benefits:

On termination of service for any reason, a participant may receive the value of the vested interest in his or her account as a single lump-sum payment or have the payment paid as a "direct rollover" to an individual retirement account (IRA) or to another employer's tax qualified plan.

7. Forfeited Accounts:

If a participant terminates employment before becoming 100% vested in their account balance and receives a distribution of the vested portion of their account, the non-vested portion of their account will be forfeited when the distribution is taken. There were no forfeited accounts at December 31, 2024 and December 31, 2023.

C. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

1. Method of Accounting:

The financial statements of the Plan are prepared using the modified cash basis of accounting, which is a comprehensive basis of accounting other than generally accepted accounting principles. This method differs from generally accepted accounting principles because contributions and income are recognized when received rather than earned and expenses are recognized when paid rather than when the obligation is incurred.

2. Estimates:

The preparation of financial statements in accordance with the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

3. Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses have been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

C. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES, CONTINUED:

4. Date of Management's Review:

Subsequent events were evaluated through September 30, 2025, which is the date the financial statements were available to be issued.

5. Investment Valuation and Income Recognition:

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

6. Payment of Benefits:

Benefits are recorded when paid.

7. Expenses:

Certain expenses incurred maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

D. FAIR VALUE MEASUREMENTS:

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used if Level 1 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The common collective trust fund is valued at the net asset value. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

E. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

F. TAX STATUS:

The Company adopted a Prototype Plan. The IRS has determined and issued a notification letter dated June 30, 2020 that indicated that the Prototype Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax period in progress.

G. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

H. PARTIES-IN-INTEREST TRANSACTIONS:

John Hancock Trust Company provided services to the Plan as the recordkeeper. Therefore, these transactions qualify as party-in-interest transactions. For the year ended December 31, 2024, fees paid by the Plan for services provided by John Hancock Life Insurance Company amounted to \$29,667.
