Notes to Financial Statements

Note 1: Description of Plan

The following description of the Winsert 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a qualified defined contribution plan covering eligible classes of employees of Winsert, Inc. (the "Company"). Effective January 1, 2024, employees age 18 or older are eligible to following the completion two months of service. Participants may enter the plan on the payroll following the date on which eligibility requirements are met. Prior to January 1, 2024, employees age 18 or older were immediately eligible to participate upon hire. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Contributions

Each year, participants may contribute to the Plan up to 100% of annual compensation, as defined in the Plan, on a pretax or Roth basis, subject to certain Internal Revenue Service ("IRS") limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or make an alternate deferral election. Effective January 1, 2024, employees are automatically enrolled 30 days after becoming eligible unless an alternate election is made. Prior to January 1, 2024, employees were automatically enrolled after 30 days of service unless an alternate election was made. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Company's matching contribution is discretionary and is determined by the management of the Company. During 2024, the Company's discretionary matching formula was 50% of each participant's contributions up to 6% of their eligible compensation. Rollover contributions are not matched.

The Company may also make a discretionary nonelective contribution to the Plan. Participants must have at least 501 hours of service during the Plan year and be employed by the Company on the last day of the plan year to receive the Company's discretionary nonelective contribution. The Company did not make a discretionary nonelective contribution in 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's discretionary matching contribution, and allocations of (a) the Company's discretionary nonelective contribution and (b) plan earnings or losses. Participant accounts are reduced by withdrawals and an allocation of administrative expenses. Allocations are based on participant's earnings or losses, account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Vesting

Participants are 100% vested immediately in their voluntary contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and nonelective contributions are based on years of service. Participants vest at a rate of 20% each year beginning with the second year of credited service and become fully vested after six years of service. In addition, participants become fully vested upon death or disability.

Notes Receivable From Participants

Participants may borrow from their fund accounts, under certain circumstances, as defined in the plan document. Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range from one to five years. Participants may have two loans outstanding at a given time. The notes are secured by the balance in the participant's account and bear interest at a fixed rate determined by the plan administrator based on prevailing market conditions (prime rate plus 2.00%). Interest rates on existing notes range from 5.25% to 10.50% at December 31, 2024. Principal and interest are paid through payroll deductions.

Payment of Benefits

Plan benefits are available at normal retirement (age 60), disability retirement, death, or termination of employment. Participants may elect to receive benefit payments in the form of a lump-sum distribution or in installments. Distributions from the voluntary contribution portion of a participant's account are also allowed in the event of a financial hardship if certain conditions are met. The Plan also allows for in-service distributions upon attaining age 59 1/2. Participants may withdraw rollover contributions at any time.

Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company's discretionary matching or nonelective contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,666 and \$10,782, respectively. The Company may decide at its discretion how to use forfeitures under the plan document. During 2024, forfeited accounts of \$27,084 were used to reduce Company contributions and \$6,125 were used to pay plan expenses.

SECURE 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The plan has adopted some of these provisions, and is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract ("FBRIC")). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

The FBRIC is reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative and Investment Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain fees incurred by the Plan for investment management services are allocated proportionately to plan participants based on their respective account balances and are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than direct payment. Fees related to the administration of notes receivable and distributions are charged directly to the participant's account and are included in administrative expenses. All other expenses paid by the Plan are allocated proportionately to plan participants based on their respective account balances and are included in administrative expenses.

Note 2: Summary of Significant Accounting Policies (Continued)

Subsequent Events

The Plan has evaluated subsequent events through September 26, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would be used only if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

Mutual funds held in separate accounts: The variable funds are pooled separate accounts that invest directly in designated mutual funds. The separate account owns and holds the underlying mutual fund or collective trust shares which are valued daily at their net asset value ("NAV"). Plans and participants hold "unit of participation" in the separate account. The accumulation unit value ("AUV") is the value of each unit in the separate account, and the separate account is valued daily as the number of accumulation units held multiplied by the AUV. The AUV is first established when a new fund starts (typically the beginning AUV is \$10.00) and is then determined daily based on the NAV of the shares of the underlying fund, the fund's dividends, and the contract's separate account charges.

Note 4: Fully Benefit-Responsive Investment Contract ("FBRIC")

The Plan invests in a FBRIC with Voya Retirement Insurance and Annuity Company ("Voya") in the form of a guaranteed interest contract ("GIC") that invests in traditional investment contracts. Voya maintains the contributions in a general account. The account is credited with earnings on investments and charged for participant withdrawals and administration expenses. Voya is contractually obligated to repay the principal at a specified interest rate that is guaranteed to the Plan. The GIC is carried at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 1%. Such interest rates are reviewed periodically for resetting.

Certain events limit the Plan's ability to transact at contract value with Voya, including plan termination and other events as specified in the GIC. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring. The GIC does not permit Voya to terminate the agreement prior to the scheduled maturity date.

Note 5: Information Prepared and Certified by the Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and the FBRIC held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Voya, the Custodian of the Plan.

Note 6: Party-in-Interest Transactions

Certain plan investments are managed by Voya. Voya is the Custodian, as defined by the plan document and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for administration services amounted to \$4,750 for the year ended December 31, 2024. Fees for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than direct payment.

MAP Retirement is the third-party service provider, as defined by the plan document and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to MAP Retirement for administration services amounts to \$13,725 for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 7: Plan Termination

Although it has expressed no intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company discretionary matching and nonelective contributions.

Note 8: Tax Status

The Company has adopted a non-standardized pre-approved plan document with an IRS notification letter dated June 30, 2020, which stated the non-standardized pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the notification letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
