We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### *Emphasis of Matter – Basis of Accounting*

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

### *Responsibilities of Management for the Financial Statements*

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### *Auditors' Responsibilities for the Audit of the Financial Statements*

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

*Other Matter – Supplemental Schedule Required by ERISA*

The supplemental schedule of assets (held at end of year) is presented for the purpose of additional analysis and is not a required part of the financial statements, but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management has determined to meet the requirements of ERISA Section 103(a)(3)(C).

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of Academy of Art University 401(k) Retirement Plan (the Plan) is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the Plan document.

*General*

The Plan is a defined contribution plan which was established on January 1, 1996 and most recently restated on November 1, 2023. The Plan is intended to qualify under Section 401(k) of the Internal Revenue Code of 1954, as amended. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Substantially all employees of Stephens Institute dba Academy of Art University (the Company) who have reached the age of 21 are eligible to participate in the Plan. Employees may enter the Plan on the first day of the month coinciding with or next following the completion of eligibility requirements.

*Administration*

The Plan is administered by both the Company and July Business Services, Inc. (July). Among other duties, it is the responsibility of the administrators to interpret the Plan, decide on questions of eligibility, determine the amount and manner of benefit payments and maintain administrative records of the Plan. All assets of and for the years ended December 31, 2024 and 2023 were held by Charles Schwab Bank (CSB).

*Trustee*

The trustee of the Plan is Charles Schwab Trust Company (CSTC), a division of CSB. The primary duties of the trustee are to authorize investments and monitor payment of contributions, loans and benefits, as directed by the Plan administrators.

*Participant Accounts*

Each participant's account is credited with the participant's contribution and the Company's matching contribution, as well as allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

*Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates between 4.25 percent and 9.5 percent, based on the prime rate at the time of borrowing plus 1 percent. Principal and interest are paid ratably through bi-weekly payroll deductions.

*Contributions*

**Participants** – The Plan permits each participant, at the participant’s option, to elect to contribute up to 75 percent of annual pre-tax compensation and up to 100 percent of bonuses paid during the year as a basic contribution to the Plan, not to exceed the Internal Revenue Service (IRS) limitations. Participants may also contribute after-tax compensation as a Roth contribution. For the year ended December 31, 2024, the maximum salary deferral was limited to \$23,000. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a money market account as investment options for participants. Participants are fully-vested immediately in their contributions plus actual earnings thereon.

**Employer** – The Company may make matching contributions based on a discretionary percentage of each participant’s eligible compensation or a discretionary dollar amount. Participants are required to have completed one year of service to be eligible for the matching contributions. In order for a participant to share in matching contributions, the participant must be employed on the last day of the Plan year, or if terminated, must have been credited with at least 500 hours of service during the year. Employer match requirements are waived for instances of disability, retirement or death. The Plan provides for 100 percent vesting at all times. No matching contributions were made by the Company during the year ended December 31, 2024.

*Payment of Benefits*

Participants may receive distributions from their accounts upon attainment of age 59½, retirement as a result of disability, incurrance of a financial hardship (as defined), termination of their employment with the Company, death, or termination of the Plan. The participant will receive a lump-sum amount equal to the vested value of the participant’s account balance. For eligible participants receiving a required minimum distribution, the vested balance will be paid out in installments over a period not to exceed the participant’s assumed life expectancy.

*Corrective Distributions*

Due to the failure of certain 2023 compliance tests, corrective distributions of \$52,828 were paid during the year ending December 31, 2024. Due to the failure of certain 2024 compliance tests, corrective distributions of \$8,454 were paid during the year ending December 31, 2025.

*Plan Termination*

Although the Company has not expressed any intent to discontinue the Plan, the Company may do so at any time subject to the provisions of ERISA. In the event of termination, assets of the Plan would be allocated to all participants and distributed in lump sum payments.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

*Basis of Accounting*

The accompanying financial statements of the Plan have been prepared on a modified cash basis of accounting. Contributions by the employees (participants) and the employer are recognized in the period the participants' wages are earned (accrual method of accounting), but withdrawals from the Plan for employee distributions are recognized when amounts are paid to the participants (cash basis of accounting). Therefore, these financial statements are not intended to be a presentation in conformity with accounting principles generally accepted in the United States of America.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan does not have any fully-benefit responsive investments.

*Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value, as determined by CSB. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the cash basis. Dividends are recorded on the ex-dividend date. Net increase in fair value includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance. Related fees are recorded as administrative expenses and expensed when they are incurred. No allowances for credit losses have been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrators deem the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

*Administrative Expenses*

Plan investments are subject to certain investment management service and fund operating fees based on a percentage of invested assets. Such fees are included within the net increase in fair value of mutual funds on the accompanying statement of changes in net assets available for benefits. Fees related to the administration of distributions and participant loans are charged directly to the participants' accounts and are included within administrative expenses on the accompanying statement of changes in net assets available for benefits. The Plan also pays fees to an investment advisory firm, CSB, and July for investment advisory, recordkeeping and other services associated with administration of the Plan. These fees are also included within administrative expenses on the accompanying statement of changes in net assets available for benefits.

*Use of Estimates*

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Subsequent Events*

Plan management has evaluated subsequent events through the date of the auditors' report, September 24, 2025, which is the date the accompanying financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. That framework gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under the Financial Accounting Standards Board's *Accounting Standards Codification (ASC) 820*, are described as follows:

- a) Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- b) Level 2            Inputs to the valuation methodology include:
  - quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- c) Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for investments measured at fair value at December 31, 2024 and 2023. There were no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money market:* Valued at the net investment value of shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan’s investments at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Charles Schwab Investment Management, a division of CSB. CSB held all assets of the Plan, and therefore, these transactions qualify as party-in-interest transactions.

During the year ended December 31, 2024, the Plan paid fees of \$52,871 to July. These fees have been included within administrative expenses on the accompanying statement of changes in net assets available for benefits.

NOTE 6 – TAX STATUS

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code. Although the Plan has been restated since receiving the advisory letter, the Plan administrators believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

NOTE 7 – RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

The delinquent participant loans of active participants as of December 31, 2024 and 2023 are included within notes receivable from participants on the accompanying statements of net assets available for benefits. These delinquent participant loans are shown as deemed distributions of participant loans on the Form 5500.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
