Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Warmington Group Cash Option Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for plan benefits for the years then ended and the related notes to the financial statements.

NOTES TO THE FINANCIAL STATEMENTS

December 31, 2024

NOTE 1: DESCRIPTION OF THE PLAN

The following description of the Warmington Group Cash Option Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan was adopted effective January 1, 1984, and is a defined contribution plan administered by the Warmington Group (the "Company"). In 2022, employees of Warmington Residential California, Warmington Apartment Communities, Warmington Properties, Chateau Interiors-California, Studio Chateau, and Stirling Financial Management became participant employers, and its employees were eligible to participate in the plan. Employees are eligible to participate in the plan once they meet the minimum age of 20 ½ and may enroll in the plan on January 1 or July 1 each year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Company and Plan trustee administer the Plan.

Plan Custodian and Recordkeeper

The trustee of the Plan is Fidelity Management Trust Company ("Fidelity"). Recordkeeping services are provided by Fidelity Investments Institutional Operations Company, Inc. under an agreement with the Plan. Certain information included in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends for the years then ended, and participant loan balances, were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity.

Contributions and Funding Policy

Each year, participants may contribute up to 60% of their annual compensation, as defined in the Plan, up to the maximum contribution amount permitted under the Internal Revenue Code of \$23,000 and \$22,500 (\$30,500 and \$30,000 for participants age 50 and over, respectively) for the years ended December 31, 2024 and 2023, respectively. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and a common collective trust fund. The Plan allows participants to roll over eligible amounts to the Plan from other qualified retirement plans.

At its discretion, the Company may elect to make a matching employer contribution to the Plan. During the years ended December 31, 2024 and 2023, the Company did not make any contributions to the Plan.

NOTE 1: DESCRIPTION OF THE PLAN (continued)

Participant Accounts and Vesting

Each participant's account is credited with the participant's contribution and allocations of a) the Company's matching contribution and, b) Plan earnings, and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Participant accounts are immediately vested in participant and employer contributions plus earnings thereon.

Notes Receivable from Participants

Loans to participants are authorized by the administrator and trustees who are responsible for determining the terms and conditions. These loans are available to all participants on a non-discriminatory basis. The minimum amount of any loan is \$1,000 and may not exceed the lesser of 50% of the participants vested account balance as of the date of loan origination, or \$50,000. The loans generally must be repaid through payroll deductions over a period not to exceed five years. The notes are secured by the balance in the participant's account and bear interest at 5.25% to 10.50% in 2024. Interest rates are determined by the Plan administrator based on prevailing market rates. Participant loans in the amount of \$254,006 at December 31, 2024 and \$206,754 at December 31, 2023 are included in the accompanying financial statements under the caption "Notes receivable from participants".

Payment of Benefits

Upon termination of service before the normal retirement age, a participant with benefits over \$7,000 may elect to defer distribution until normal retirement age or receive a lump sum payment equal to the vested share of the participant's account.

In service distributions are permitted by the Plan after age 59 ½. In addition, the Plan allows participants to make early withdrawals for certain financial hardships. Distribution of benefits can also be accessed in the event of disability or death.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual method of accounting. Investments held by a defined contribution plan are required to be reported at fair value.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Plan investments are included in the accompanying financial statements, which are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Interest earned to date is included in the investment value. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded at the ex-dividend date.

Notes Receivable from Participants

Notes receivables from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. If participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. Administrative and other expenses are recorded as incurred. Refer to Note 6 for a description of Fidelity's Revenue Credit Program.

Payment of Benefits

Benefits are reported when paid.

Subsequent Events

Subsequent events were evaluated through September 25, 2025, which is the date the financial statements were available to be issued.

NOTE 3: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1 – Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at measurement date.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly.

Level 3 – Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective value fund: The Plan holds shares of Fidelity Managed Income Portfolio (“MIP”) Fund, a common collective trust fund designed to deliver safety and stability through the preservation of principal and the accumulation of earnings. The MIP Fund invests in benefit-responsive investment contracts issued by insurance companies and other financial institutions, fixed income securities, and money market funds, which help provide a stable return. The MIP Fund is measured at NAV as a practical expedient, which represents the fair value of the underlying investments divided by the number of outstanding units. Participants may generally direct the withdrawal or transfer of all or a portion of their investment in the MIP Fund at contract value, which represents contributions made, plus earnings, less any withdrawals and administrative expenses. There are no redemption restrictions for participants, although a redemption notice period applies to the Plan itself.

NOTE 4: PLAN TERMINATION

Although the Company has not expressed an intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan.

NOTE 5: TAX STATUS

The Internal Revenue Service has determined and informed the Company, by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

NOTE 6: RELATED PARTY TRANSACTIONS

Plan investments held at December 31, 2024 and 2023 were managed by Fidelity, which qualifies as a party-in-interest as defined by ERISA. The Plan participates in Fidelity's Revenue Credit Program, in which Fidelity makes quarterly payments to the Plan, known as recordkeeping revenue, as part of a service fee agreement. During the year ended December 31, 2024, net administrative expenses totaled \$1,717. During the year ended December 31, 2023, recordkeeping revenue exceeded plan administrative fees, resulting in a net expense credit of \$(7,700). This expense credit is reported in the accompanying statement of changes in net assets available for plan benefits for the year ended December 31, 2023. These transactions with Fidelity are considered party-in-interest transactions and are exempt from the prohibited transaction rules under ERISA.

In addition, fees paid to the Plan's independent auditor for the annual audit of the Plan's financial statements were paid from Plan assets and are included in net administrative expenses. Because the auditor provides services to the Plan, such transactions qualify as party-in-interest transactions under ERISA; however, these transactions are specifically permitted and exempt from the prohibited transaction rules.

NOTE 7: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
