## INDEPENDENT AUDITORS' REPORT

To the Trustee of  
Empres Healthcare 401(K) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Empres Healthcare 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Empres Healthcare 401(K) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

**NOTE 1 - DESCRIPTION OF THE PLAN**

**GENERAL**

Empres Healthcare 401(K) Plan ("the Plan"), with the initial effective date of July 1, 2023, is a defined contribution plan covering the employees of Evergreen Healthcare Group (the "Company"). The Plan is subject to applicable provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. A separate account is maintained for each participant. Participants should refer to the Plan document or summary plan description for a more complete description of the Plan's provisions.

**ELIGIBILITY**

Employees are eligible for participation in the Plan upon attaining age 18 and completing three months of service. Entry into the Plan is permitted on the first enrollment period after which the employee becomes eligible. Eligible participants may enter the Plan the first day of the calendar quarter after or coinciding with, the fulfillment of these requirements.

**PARTICIPANT AND EMPLOYER CONTRIBUTIONS**

The Plan provides for employee salary deferrals which are not to exceed the maximum allowable limits under section 401(k) of the Internal Revenue Code (\$23,000 for 2024). In addition, participants are permitted to make after tax Roth 401(k) contributions which are subject to the same pre-tax contribution limitations. Participants who will attain age 50 before the end of the Plan year may contribute an additional \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Participant's contributions are recorded when withheld from participant's earnings.

The Company may decide to make a matching contribution or a non-elective contribution to the Plan, although the Company is not required to make these contributions. Contributions, if made, are subject to certain IRS limitations. The employer did not make any contributions to the Plan during 2024 and 2023.

**PARTICIPANTS' ACCOUNTS**

Each participant's account is credited with (i) participant's contributions, (ii) employer matching contributions (if any), and (iii) allocations of the Plan earnings based on their specific investments. Each participant's account is charged with an allocation of administrative expenses, if the employer does not pay such expenses, fees and charges. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the amount accumulated in the participant's vested account.

**VESTING**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service, and vests 20% after 1 year of service, and 20% for each year of service thereafter. A participant is 100% vested after five years of credited service, or if terminated due to death, disability, or attainment of age 65.

**NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)**

**FORFEITED ACCOUNTS**

Forfeited non-vested accounts can be used to pay Plan expenses and reduce future Company contributions. At December 31, 2024 and December 31, 2023, there were no forfeited non-vested balances. This account will be used to pay future Plan expenses or reduce future discretionary Company match

**NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of their vested account balance. Only one loan may be outstanding at a time. The loans are secured by the balance in the participants' account and bear interest at rates which are commensurate for similar types of loans as determined by the plan administrator. Generally, the term of the loan may not exceed five years (unless the loan proceeds will be used to purchase a principal residence). Principal and interest is paid ratably through monthly payroll deductions.

**PAYMENT OF BENEFITS**

If a participant's vested account is more than \$7,000, they may choose from several payment options at termination, retirement, or death, with some requiring the participant's spouse's consent. At retirement or termination, a participant can elect various forms of benefit, such as lifetime monthly income, survivor continuation options, fixed-period payments, lump sums, partial payments, or scheduled annual payments, subject to federal minimum distribution rules. At death, the beneficiary can generally elect a lump sum or certain annuity options available to you, but must make the choice before payments begin.

In-service withdrawals are permitted for participants, aged 59 1/2 and older from their vested account balance. The Plan provides for hardship withdrawals in the event of an immediate and heavy financial need.

**PLAN TERMINATION**

Although the Company has not expressed any intent to terminate the Plan, it may do so at any time. If the Plan is terminated, the proportional interest of each participant's account shall then vest 100% and become non-forfeitable.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**BASIS OF ACCOUNTING**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**USE OF ESTIMATES**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefit.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024 and 2023, may not necessarily be indicative of amounts that could be realized in a current market exchange.

**INVESTMENT VALUATION AND INCOME RECOGNITION**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses have been recorded as of December 31, 2024 and 2023, respectively.

**PAYMENTS OF BENEFITS**

Benefits paid to participants are recorded when paid.

**ADMINISTRATIVE AND OTHER EXPENSES**

Substantially all expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The 3 levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1     Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2     Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3     Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

***Mutual funds*** – valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

***Pooled separate accounts*** – Valued at the accumulation unit value, which is based on the value of underlying assets of the account. The accumulation unit value is deemed equivalent to net asset value ("NAV"), which is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. In accordance with Subtopic 820-10, investments measured at NAV per share (or is equivalent) are not classified in the fair value hierarchy.

**NOTE 3 - FAIR VALUE MEASUREMENTS (CONTINUED)**

**Common Collective Trust** – Units of the fund are valued each day on which the New York Stock Exchange (NYSE) is open for trading in accordance with the valuation procedures established by the trustee. The NAV per unit is calculated as of the close of trading on the NYSE. The NAV per unit is computed by dividing the total assets of the Fund, less its liabilities, by the total number of units outstanding at the time of such computation. Investment income earned is reinvested in the Fund and included in the determination of unit values.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023:

**NOTE 5 - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Principal Life Insurance Company and Principal Trust Company are the trustees for the plan. Administrative fees paid by the Plan to Principal Trust Company amounted to \$227,710 for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions, but are exempt from the prohibited transaction rules of ERISA.

The Employer provides accounting and administrative services to the Plan for which no fees are charged.

**NOTE 6 – INCOME TAX STATUS**

The nonstandardized plan document, which the Plan has adopted via nonstandardized adoption agreement, obtained its latest opinion letter dated June 30, 2020. The Internal Revenue Service ("IRS") stated in the opinion letter that the nonstandardized plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC"). The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax-exempt. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

**NOTE 6 – INCOME TAX STATUS (CONTINUED)**

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions.

**NOTE 7 - CONCENTRATIONS**

The Plan holds certain investments that each represents 10% or more of the total net assets held by the Plan. As of December 31, 2024 and 2023, the Plan held two such investments totaling \$3,978,914 and \$2,732,836, respectively.

**NOTE 8 - SUBSEQUENT EVENTS**

The Plan's management has evaluated subsequent events through September 29, 2025, the date the financial statements were available to be issued.
