## INDEPENDENT AUDITOR'S REPORT

To the Participants, Plan Administrator, Trustees and Senior Management

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Citizens Bank Salary Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

#### NOTE 1 - DESCRIPTION OF PLAN

The following description of the Citizens Bank ("Company") Salary Savings Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering all employees of the Company and its subsidiaries who are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors of the Company is responsible for oversight of the Plan. They also determine the appropriateness of the Plan's investment offerings, as well as monitor investment performance.

**Eligibility** - Employees are immediately eligible to participate in the Plan. Participants are eligible to receive safe harbor employer matching contributions once they complete one year of service (minimum of 1,000 hours).

**Contributions** - Each year, participants may contribute up to the maximum amount allowed by law of pretax annual compensation or Roth contributions, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes safe harbor matching contributions equal to 100% of individual participant deferrals up to 4% of eligible compensation. The Company may also elect to make additional discretionary non-safe harbor matching contributions. The Company made no additional matching contribution to the Plan in 2024. The matching Company contributions are invested as directed by the participants.

**Participant Accounts** - Each participant's account is credited with the participant's contributions and the Company's matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are vested immediately in their elective deferrals and the employer safe harbor matching contributions, plus actual earnings on these contributions. Vesting in the Company's discretionary non-safe harbor contributions is based on years of continuous service. A participant is 100% vested in these contributions after 6 years of credited service.

**Notes Receivable from Participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is determined in a non-discriminatory manner by the plan administrator. The interest rate must be comparable to the current interest rates charged by financial institutions for similar loans. Principal and interest is paid ratably through payroll deductions.

**Payment of Benefits** - On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or substantially equal installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**Forfeited Accounts** - At December 31, 2024 and 2023, there were \$254 and \$0 of unused forfeited non-vested accounts. These amounts will be used to restore forfeitures, reduce employer contributions, or pay administrative expenses. In 2024, no forfeitures were used to pay administrative expenses.

## NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's senior management determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses have been recorded as of December 31, 2024 or 2023. Delinquent receivables are recorded as distributions on the basis of the terms of the Plan agreement. Notes receivable from participants are considered to be party-in-interest transactions for which a statutory exemption from the prohibited transactions regulation exists.

**Contributions** – Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of Benefits** - Benefits are recorded when paid.

**Expenses** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events** - Management has evaluated subsequent events through September 10, 2025, the date the financial statements were available to be issued, and has determined that there are no subsequent events that require disclosure.

## NOTE 3 - FAIR VALUE MEASUREMENTS

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled Separate Accounts:* The Plan has investments in participation units held in pooled separate accounts through sub-accounts of an insurance company. The net asset value is used as a practical expedient to estimate fair value.

Included in the pooled separate accounts is a stable value fund which represents participation units of a collective investment trust for which the net asset value is based on the market value of the underlying investments. The stable value fund is composed primarily of fully benefit-responsive investment contracts that are valued at the net asset value of units of the bank collective trust.

**NOTE 4 - INFORMATION CERTIFIED BY THE CUSTODIAN**

The Plan has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, as permitted under such election, the Plan has obtained certifications from John Hancock Life Insurance Company, the custodian, that the information in the accompanying financial statements and supplemental schedules, with respect to investments and investment activity, notes receivable from participants and related interest income is complete and accurate as of December 31, 2024 and 2023 and for the year ended December 31, 2024. The information certified by John Hancock Life Insurance Company is presented based on their certifications.

**NOTE 5 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan has investments in participation units held in pooled separate accounts through sub-accounts at John Hancock Life Insurance Company. John Hancock provides services to the Plan as the investment custodian and record keeper; therefore, these investments and transactions qualify as party-in-interest transactions. In addition, there are notes receivable from participants which also qualify as party-in-interest transactions.

During 2024, the Plan paid \$47,622 in administrative fees to John Hancock, the custodian, which qualify as party-in-interest transactions.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### **NOTE 7 - TAX STATUS**

The Plan sponsor adopted a non-standardized pre-approved profit sharing plan sponsored by CCH Incorporated. Effective January 1, 2022, the Plan was restated to include amended cycle 3 changes as well as other required changes. CCH Incorporated received a determination letter dated June 30, 2020 for the restated plan.

Although the Plan has not applied for its own opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan is qualified, and the related trust is tax-exempt as of the financial statement dates.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
