INDEPENDENT AUDITORS' REPORT

Rotella's Italian Bakery, Inc. Profit Sharing 401(k) Plan
Omaha, Nebraska

Opinion

We have audited the accompanying financial statements of Rotella's Italian Bakery, Inc. Profit Sharing 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Rotella's Italian Bakery, Inc. Profit Sharing 401(k) Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Rotella's Italian Bakery, Inc. Profit Sharing 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Rotella's Italian Bakery, Inc. Profit Sharing 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Rotella's Italian Bakery, Inc. Profit Sharing 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Rotella's Italian Bakery, Inc. Profit Sharing 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental Schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Rotella's Italian Bakery, Inc. Profit Sharing 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan Agreement for a complete description of the Plan's provisions.

The Plan was originally adopted in 1979. Effective January 1, 1993, Rotella's Italian Bakery, Inc. ("Company" or "Plan Sponsor") amended the Plan by converting from a defined contribution profit-sharing plan to a salary-reduction plan with an employer-matching contribution under the provisions of Section 401(k) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (the Code). The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan is administered by the Company.

General

The Plan is a 401(k) salary-reduction plan covering all full-time employees, 21 years of age or older, who have one year of service as defined in the Plan document, provided they have worked at least 1,000 hours during a 12-month period, beginning with the date of employment. Employees who qualify to become participants are eligible to make salary deferrals after completing three months of service. The entry date with respect to salary deferrals is the first day of each month coinciding with or immediately following the date the salary deferral eligibility requirements are met.

Contributions

Participants may contribute up to 80% of their eligible compensation on a pretax basis (i.e., salary reduction) to the Plan up to a maximum of \$23,000 for 2024 and \$22,500 for 2023. Participants age 50 and older may contribute an additional catch-up contribution of \$7,500 for both 2024 and 2023. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company can match up to 100% of the participants' deferrals, but the amount is at the option of the Company's board of directors, but only to the extent of amounts allowable under the provisions of the Code. For the year ended December 31, 2024, the Company made a \$183,848 match contribution to the Plan, of which \$34,659 was paid for with forfeitures and the remaining \$149,189 was paid for by the Company. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's salary-reduction contribution and allocations of the Company's contribution, the Plan's investment earnings or losses, and charged with an allocation of administration costs. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service. Unvested portions of participants' account balances who leave employment revert to the Company and usually will be used to reduce Company matching contributions in the year in which the forfeiture occurs.

NOTE 1 – DESCRIPTION OF THE PLAN, Continued

Participant Loans

Participant loans are not permitted under this plan.

Payment of Benefits

Upon termination of service, participants may elect to receive either a lump-sum amount equal to the value of their vested account balance, partial payments, or elect installments paid over a period of years as defined in the Plan document.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,161 and \$32,509, respectively. These accounts will be used to reduce future employer contributions.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for details.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution. As of December 31, 2024 and 2023, there were no amounts payable to participants who had requested distribution from the Plan prior to year-end, but did not receive the distribution until after year-end.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants in 2025.

Date of Management's Review

Subsequent events were evaluated through October 3, 2025, which is the date the financial statements were available to be issued.

NOTE 3 – TAX STATUS

The Internal Revenue Service has informed the Plan Sponsor by a letter dated March 31, 2014, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The Plan Sponsor believes that the Plan is currently designed and operated in compliance with applicable requirements of the Internal Revenue Code and the Plan continues to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

The Plan has adopted guidance on accounting for uncertainty in income taxes issued by the Financial Accounting Standards Board. Management of the Plan believes that the Plan has taken no uncertain tax positions that require adjustment to the financial statements in order to comply with the provisions of this guidance. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

NOTE 5 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 – PLAN ADMINISTRATION AND EXPENSES

Certain administrative functions are performed by officers of the Company. No such officer or employee receives any compensation from the Plan. All reasonable plan administration expenses, including those involved in retaining necessary professional assistance, may be paid from the assets of the plan to the extent permitted by the participant’s individual agreements. These expenses may be allocated to all plan participants, or for expenses directly related to one participant, charged against that participant’s account balance. The Plan Sponsor may, at its discretion, pay a portion or all of these expenses. For the years ended December 31, 2024 and 2023, the Plan Sponsor paid expenses related to insurance and bonding.

NOTE 7 – RELATED PARTY TRANSACTIONS

Certain Plan investments were managed by Principal Financial Services, Inc. during the year. Principal was the trustee and recordkeeper for the Plan; and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for services provided by Principal amounted to \$33,709 and \$31,232 for the years ended December 31, 2024 and 2023, respectively.

NOTE 8 – FAIR VALUE MEASUREMENTS

The framework for measuring fair values provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: The mutual funds held by the Plan are deemed to be actively traded and are valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price.

Common/Collective Trusts: The collective investment trusts (CIT) funds held by the Plan generally invest in a variety of CITs, separate accounts, and mutual funds. The fair values of the CITs and the separate accounts are not based on publicly quoted pricing inputs. In contrast, the fair values of mutual funds are publicly quoted pricing inputs (Level 1 measurements).

The fair values of all these investments are used in determining the NAV of the CITs. While the NAV of CITs is not publicly quoted, it is calculated in accordance with U.S. GAAP for investment companies and is available to Plan participants and administrators via the Principal Plan Sponsor website or participant access portals. Annual reports containing underlying asset information (with ASC 820 disclosures) are also available.

The NAV serves as the basis for current transactions, and CIT units can be redeemed at NAV as of the measurement date. Therefore, the Plan Sponsor believes these investments have a "readily determinable fair value." The NAV is calculated in a manner consistent with GAAP for investment companies. Because it is valued similarly to mutual funds, the Plan Sponsor believes the Plan's CIT funds should be Level 1 assets to allow for consistent disclosure.

NOTE 8 – FAIR VALUE MEASUREMENTS, Continued

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Sponsor believes the Plan's valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
