As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency ("qualified institution"), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Management is also responsible for administering the Plan and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants to determine the benefits due or which may become due to such participants.

Auditor’s Responsibilities for the Audit of the Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

Notes to Financial Statements

1. Description of Plan

The following description of the Azenta, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution profit sharing plan with a cash deferred arrangement covering all United States employees of Azenta, Inc. (the “Company” or “Employer”) who have reached age 18 (“Participants”). Employees are eligible to participate in the Plan on the first day of the month following their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Participant Contributions

Each year, Participants may contribute up to 25% of their annual pre-tax compensation as defined by the Plan, up to a dollar limit set by federal law. Employees of the Employer shall have an automatic deferral of 3% unless an alternative election is made. An additional deferral of 1% will be added to automatically enrolled Participants’ accounts annually, not to exceed a total deferral percentage of 10% (9% in 2023). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions and to contribute up to 100% of their annual pre-tax compensation to make such contributions. Participants may also contribute amounts representing distributions from other qualified plans (“Participant Rollovers”).

Employer Contributions

The Employer will make a matching contribution of 100% of the first 3% of eligible compensation that a Participant contributes to the Plan, plus 50% of the next 3% of eligible compensation, subject to certain limitations. In 2024 and 2023, the Company made an annual true up contribution of \$17,220 and \$64,813, respectively, for its non-elective matching contribution.

In addition, at its discretion, the Employer may make a profit-sharing contribution. In order to be allocated a profit-sharing contribution, a Participant must be employed on the last day of the plan year, unless separated due to death, disability, or normal retirement age. For the plan years ended December 31, 2024 and 2023, there was no profit sharing contribution to the Plan.

Participant Accounts

Each Participant’s account is credited with the Participant’s contribution, the Employer’s matching contributions, and a pro-rata allocation of (a) the Employer’s profit-sharing contribution, (b) the Plan’s investment earnings, (c) charged with an allocation of investment fees, and (d) charged with direct administrative expenses. Allocations are based on participant earnings, deferrals, or account balances, as defined. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant’s vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon.

Vesting in the Employer's matching and discretionary contributions plus actual earnings thereon is based on years of continuous service. A year of service is defined as a 12-month plan year period. A Participant begins vesting after one year of service and is fully vested after two years of service.

Forfeitures

The non-vested portion of a Participant's account shall be forfeited as of the earlier of the date on which the Participant receives a complete distribution of his or her accounts or the last day of the plan year in which the Participant incurs five consecutive one-year breaks in service.

Forfeitures are used to reduce future employer contributions or pay administrative expenses of the Plan. At December 31, 2024 and 2023, unused forfeited account balances totaled \$8,960 and \$38, respectively. During 2024 and 2023, forfeitures used to pay employer contributions or administrative expenses were immaterial.

Payment of Benefits

In-service withdrawals from a Participant's vested deferral account balance are permitted upon the attainment of age 59½ or due to financial hardship.

Participants are entitled to their vested account balance upon death, disability, retirement, or termination of employment. A Participant may elect to receive a lump-sum amount, installment payments, or partial payments equal to their vested account balance. In addition, if a Participant's vested account is less than \$7,000, and a distribution election has not been made by the Participant, the plan administrator may transfer the amount into an Individual Retirement Account "IRA".

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Terms range up to five years (or up to 15 years for the purchase of a primary residence). Participants are allowed only one loan outstanding at any given time. Notes receivable from Participants are secured by the vested balance in the Participant's account and bear interest at a rate equal to prevailing local bank rates for similar loans. Principal and interest are paid ratably through payroll deductions.

Administrative Expenses

The Plan is responsible for paying all expenses incurred in the administration of the Plan, except to the extent such expenses are paid by the Company. Expenses paid by the Company are excluded from these financial statements. Certain transactional fees are charged directly to the Participant's account and are included in administrative expenses. Other administrative expenses are allocated to Participants as defined. Investment related expenses are included in net appreciation/depreciation in fair value of investments.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The investments of the Plan are reported at fair value. The fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of the investments within the Plan are reflected on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a Participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Subsequent Events

The Plan evaluated all events and transactions that occurred after December 31, 2024, through September 2, 2025, the date these financial statements were available to be issued.

Effective January 1, 2025, an additional deferral of 1% will be added to automatically enrolled Participants' accounts annually, not to exceed a total deferral percentage of 11%.

3. Certified Investments

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, T Rowe Price Trust Company, a qualified institution, has certified that the following investment information included in the

accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the Form 5500 - Schedule H, Part IV, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of the plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

4. Fair Value Measurement

The Plan follows the guidance of Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurement*, which defines fair value and establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets.
- quoted prices for identical or similar assets or liabilities in inactive markets.
- inputs other than quoted prices that are observable for the asset or liability.
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual Funds

Shares held in mutual funds traded on national securities exchanges are valued at the net asset value as of December 31, 2024 and 2023.

Common Trust Funds

Common trusts funds are valued at the net asset value (NAV) of units held and are published daily on NASDAQ. The NAV is based on the fair value of the underlying investments held by the common trust funds less its liabilities. The fair value of the underlying investments is determined using market quotations or prices obtained from independent pricing sources that may employ various pricing methods to value the investments, including matrix pricing.

Stable Value Fund

The TRP Stable Value Fund is a common trust fund composed primarily of fully benefit-responsive investment contracts. The stable value fund is valued at the net asset value (NAV), which is based on the fair value of the underlying investments less its liabilities. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions may occur daily with no advance notice. There are no unfunded commitments related to these investments. If the Plan initiates a full redemption of the stable value fund, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner. This is a direct filing entity.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes that its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Risks and Uncertainties

The plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect Participants' account balances and the amounts reported in the statements of net assets available for benefits.

6. Related-Party and Party-in-Interest Transactions

Certain plan investments are shares of mutual funds and common trust funds managed by T. Rowe Price Trust Company, the plan trustee; therefore, these transactions qualify as party-in-interest. Notes receivable from participants also qualify as party-in-interest transactions.

7. Tax Status

The Plan has adopted the T. Rowe Price Retirement Services, Inc. pre-approved, Profit Sharing/Money Purchase/CODA Plan, which received an opinion letter from the Internal Revenue Service dated August 19, 2020, stating that the written form of the underlying plan document is qualified under Section 401(a) of the Internal Revenue Code ("IRC"), and that any employer adopting this form of the plan will be considered to have a plan qualified under Section 401(a) of the IRC. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. Although the Plan has been amended since the date of the letter, the plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and that the Plan continues to be tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Termination of the Plan

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, Participants will become 100% vested in their accounts.
