Note 1 - Plan Description

The following description of 8th Light 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of 8th Light Holdings, Inc. (the "Company") who have completed two months of service. Leased employees, nonresident alien employees, and union employees are not eligible for participation in the Plan. Employees are permitted to enter the Plan on the first day of the plan year quarter coinciding with or following the date when plan eligibility criteria are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides for employee salary deferral contributions up to maximum tax-deferred limitations established by the Internal Revenue Code. Participants who have attained age 50 may make catch-up contributions in addition to their regular deferral contributions. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Certain participant contributions in 2024 and 2023 were paid after the time frame required by the Department of Labor. The Company remitted these contributions during 2024 and remitted related lost earnings to the Plan in 2024.

The Plan provides for employer safe harbor matching contributions of 100 percent of the participant's contribution, not to exceed 4 percent of the employee's compensation.

The Company may make annual discretionary and profit-sharing contributions. Participants who have completed two months of service and remain employed on the last day of the plan year will be eligible to receive an allocation of the Company discretionary and profit-sharing contributions. As of December 31, 2024, the Company has not made any discretionary or profit-sharing contributions to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 50 percent of their account balances, not to exceed \$50,000. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate.

Benefit Payments

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account or partial withdrawals.

After age 59½, a participant may make withdrawals of 401(k) contributions, employer contributions, and/or rollover contributions and related investment earnings, which are subject to income tax to the participant at ordinary rates.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan agreement.

Note 1 - Plan Description (Continued)

Vesting

Participants are immediately 100 percent vested in employee salary, rollover, and employer safe harbor contributions and any income or loss thereon. Vesting in the Company's discretionary and profit-sharing contributions portion of their accounts, plus actual earnings thereon, is based on years of service. Participants vest in discretionary and profit-sharing contributions made by the Company 20 percent after two years of service and another 20 percent per year thereafter until they become fully vested after six years of service.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future Company contributions. There were no forfeited account balances at December 31, 2024 and 2023.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Minnesota Life Insurance Company or its affiliates. Minnesota Life Insurance Company is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value except as noted below regarding the fully benefit-responsive investment contract. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The pooled separate account investments are valued at net asset value (NAV) per share (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. There were no redemption restrictions or unfunded commitments on these investments.

The Minnesota Life Insurance Company Guaranteed Return Account (the "Guaranteed Return Account") is a group annuity contract issued by Minnesota Life Insurance Company (Minnesota Life) that invests in the general assets of Minnesota Life. The general assets of Minnesota Life are predominantly high-quality, fixed-income investments. Minnesota Life considers the Guaranteed Return Account to be benefit responsive. Benefit-responsive contracts are recorded at contract value. Contract value represents principal invested, plus interest earned, less any withdrawals.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Note 2 - Summary of Significant Accounting Policies (Continued)

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 3, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Minnesota Life Insurance Company (the "Custodian") and its affiliate holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodian.

Note 4 - Investment Contracts

The Plan has a benefit-responsive investment contract with Minnesota Life Insurance Company. Minnesota Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Minnesota Life establishes interest rates for moneys invested in the insurance contract that may change periodically. When establishing interest crediting rates for this product, Minnesota Life considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account. The minimum crediting rate for the benefit-responsive contract is 1 percent.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

Note 5 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.
