INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee and participants of the
Aftermath 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Aftermath 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the financial statements).

Opinion

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by the qualified institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Auditor's Responsibilities for the Audit of the Financial Statements

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following description of the Aftermath 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more detailed description of the Plan's provisions.

General

The Plan is a defined contribution plan covering eligible employees of Aftermath Services LLC (the Company or Plan Sponsor), as defined in the Plan document. All employees of the Company, except those who are members of a collective bargaining agreement are eligible to participate in the Plan. Employees become eligible to participate in the Plan on the first of the month following when they have completed one year of service and have attained the age of 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each participant may make pre-tax and/or Roth contributions of up to 100% of eligible compensation as defined by the Plan document, not to exceed a maximum of \$23,000 in 2024, plus up to an additional \$7,500 for participants who have reached at least 50 years of age by the end of the year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company makes a safe-harbor matching contribution of 100% of participant deferrals for the first 3% of eligible compensation and 50% of participant deferrals for the next 2% of eligible compensation for eligible participants.

The Company may also make a discretionary profit-sharing or additional matching contribution to participants. Employees must be employed on the last day of the Plan year and have completed 1,000 hours of service during the Plan year in order to be eligible for the discretionary profit-sharing contribution. In 2024, the Company did not make discretionary profit-sharing contributions or additional matching contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, any Company contributions and earnings and losses on the investments in their account and is charged with certain administrative expenses. Upon enrollment in the Plan, a participant may direct contributions to any of the investment options offered by the Plan. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

December 31, 2024 and 2023

Vesting

Participants are vested immediately in their contributions and Company safe-harbor matching contributions, plus actual earnings thereon. For Company discretionary profit-sharing and additional matching contributions and earnings thereon, participants vest 20% after two years of service, then 20% per year thereafter until they are fully vested after 6 years of service. Participants who previously participated in predecessor plans may be subject to different vesting schedules. All amounts become fully vested upon the participant's attainment of normal retirement age, disability, or death.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account. A participant may have one note outstanding at any time. The notes are secured by the balance in the participant's account and bear a reasonable rate of interest. At December 31, 2024, notes had fixed rates ranging from 6.50% to 9.50% for the term of the note, not to exceed five years unless used for the purchase of the participant's primary residence. Principal and interest are paid through payroll deductions.

Payment of Benefits

At the time of death, disability, termination of service or retirement, the participant or their beneficiary may receive payment of the vested interest in their account in a lump-sum amount or installment payments equal to the value of the participant's vested interest in their account. If a participant terminates employment and has an account balance between \$1,000 and \$7,000 for which no distribution request has been made, the balance will be rolled into an individual retirement account in the participant's name. If a participant terminates employment and has an account balance less than \$1,000, the participant will automatically receive a lump-sum distribution. Participants are eligible to receive hardship withdrawals when certain conditions are met.

Forfeited Accounts

Forfeited non-vested account balances totaled \$188 and \$108 as of December 31, 2024 and 2023, respectively. These accounts may be used to pay Plan administrative expenses or reduce future Company contributions. There were no forfeitures used to offset 2023 Company contributions funded in 2024 or related to the 2024 employer contribution receivable funded in 2025.

Administrative Expenses

The Plan document allows for certain administrative expenses to be paid by the Plan. Certain account activity charges are paid from the accounts of participants that incur the charge. These expenses are paid to a service provider of the Plan, therefore qualify for party-in-interest transactions. All other administrative Plan expenses are paid by the Company. The Company does not expect reimbursement from the Plan for these expenses.

December 31, 2024 and 2023

The Plan has an ERISA account to pay for third-party administrative fees. During 2024, \$14,093 was deposited into the ERISA account, all of which was used to pay Plan administrative expenses. Deposits to this account are included in net change in contract value of investment on the accompanying statement of changes in net assets available for benefits. Payments from this account are included in administrative expenses in the year paid. The ERISA account balance totaled \$0 as of December 31, 2024 and 2023.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The Company safe-harbor matching contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan. The Company discretionary profit-sharing and additional matching contributions are considered payable to Plan when they are approved by the Company. Any unfunded participant or Company contributions are included in the participant or employer contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023.

In accordance with Financial Accounting Standards Board's Accounting Standards Codification 326, *Financial Instruments—Credit Losses*, the Company estimates the current credit risk associated with employer contribution receivables. The Company determined that no allowance for credit loss was necessary as of December 31, 2024 and 2023.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value, except for the guaranteed interest contract, which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net change in fair value and contract value of investments includes interest, dividends, and realized and unrealized gains and losses on those investments. Interest income is recorded when received.

Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received by the Plan. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the plan administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded. Notes receivable from participants also qualify as party-in-interest transactions.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 24, 2025, which is the date the financial statements were available to be issued.

3. Information Certified by the Qualified Institutions

All information in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net change in fair value and contract value of investments and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America (collectively, Empower), the Plan's qualified institutions.

4. Investments

Plan investments include a guaranteed interest contract managed by Empower. Empower is a service provider of the Plan; therefore, transactions in this investment qualifies as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net change in fair value or contract value of investments, as they are paid through revenue sharing, rather than a direct payment.

Investments are exposed to various risks, such as market, currency, interest rate, and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, and significant cybersecurity attacks. It is at least reasonably possible that changes in their fair value will occur in the near term and that such changes could materially affect participants' account balances.

Notes to Financial Statements

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds are stated at quoted market prices for the identical security in an active market (Level 1).

The Plan invests in a guaranteed interest contract which is a general obligation of Empower. The guaranteed interest account is valued at contract value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. The investment contract is backed by the general account of the issuer. The Plan makes deposits with the issuer and receives a guaranteed interest rate for the specified time. Interest is accrued on a fully compounded basis and paid either periodically or at the end of the contract term. The issuer guarantees that all qualified participant withdrawals will occur at contract value (principal plus accrued interest). The methodology for calculating the interest crediting rate is based on earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The weighted average crediting interest earned by the contract for the years ended December 31, 2024 and 2023 was 1.41% and 1.23%, respectively. Empower considers the contract to be fully benefit responsive for participant-initiated transactions and is stated at contract value. Investment income of this contract is presented on a contract basis. Contract value is the aggregation of contributions, plus interest, less withdrawals, if any.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their Company's contributions.

6. Income Tax Status

The Plan is a Non-Standardized Pre-Approved prototype plan document sponsored by Empower Retirement LLC (Empower Retirement), an affiliate of the qualified institutions. Empower Retirement received an opinion letter from the Internal Revenue Service, dated November 14, 2022, which states that the prototype document is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although, the Plan has not received an individual determination letter and has been amended since Empower Retirement received the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by taxing authorities and may change upon examination.
