### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Northern Contours, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

#### Note 1. Description of the Plan

The following description of Northern Contours, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for more complete information.

**General:** The Plan is a defined contribution plan covering employees located in the United States of America of Northern Contours, Inc. (the employer and Plan Administrator) who meet certain eligibility requirements. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA). The Northern Contours, Inc.'s Board of Directors is responsible for oversight of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Board of Directors.

**Eligibility:** An employee is eligible to make payroll deferrals to the Plan upon attaining the age requirement of 21. Entry into the Plan is on a monthly basis.

Employees are eligible for employer discretionary matching contributions upon attaining the age requirement of 21 and commencement of payroll deferrals.

**Contributions:** Eligible participants are permitted to elect to have a percentage of their annual compensation, limited by Plan provisions and applicable law, contributed as pretax or Roth contributions to the Plan. This deferral percentage can be changed by the participant at the beginning of each payroll period. The Plan allows participants age 50 and older to make catch-up contributions. The Plan includes an automatic enrollment provision whereby all newly eligible employees who do not make an elective deferral contribution election will be automatically enrolled in the Plan deferring 3% of the employee's compensation. The default enrollment rate under the automatic enrollment provision will increase 1% annually up to a maximum of 10%, unless the participant affirmatively elects otherwise.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans and certain individual retirement accounts (rollover).

Each year, at its discretion, the employer may make a matching contribution to the Plan, which is allocated to those participants who elect salary reduction contributions. The matching contribution for 2024 was equal to 20% of the participants' contributions to the Plan. Contributions are subject to certain limitations.

**Participant accounts:** Each participant's account is credited with the participant's contributions and employer matching contributions, if any, as well as an allocation of Plan investment results and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participant contributions, plus actual earnings thereon, are immediately 100% vested. Employer matching contributions, plus actual earnings thereon, vest at the rate of 20% per year after one year of eligible service. A participant is 100% vested after five years of credited service.

Notwithstanding the above, participants shall become 100% vested in their account upon Plan termination, attaining age 62, death or becoming totally and permanently disabled during the term of employment.

**Investment options:** Under the Plan, participants are allowed to make their own investment decisions, selecting from investment choices authorized by the Plan Administrator. Participants may elect at any time to have all or part of their account balances and future contributions transferred from one fund to another or transferred between funds in any combination. All investment choices vary in type of investment, rate of return and investment risk.

**Notes receivable from participants:** Participants may borrow up to one-half of their vested balance, with a maximum not to exceed \$50,000 and a minimum note amount of \$1,000. Notes are secured by the balance in the participant's account and bear interest at a rate fixed by the Plan Administrator at the time of the note, which is currently based on the prime rate plus two percentage points. Notes have a repayment period not to exceed five years, with the exception of notes used for acquiring a home, which can be repaid over a period not to exceed 15 years. At December 31, 2024, interest rates ranged from 4.50% to 10.50% with maturities through December 2029. Principal and interest are paid ratably through payroll deductions.

**Benefit payments:** Upon termination of service, death, disability, normal retirement (age 65), early retirement (age 62), the participant may receive the value of the vested interest in his or her account in the form of lump-sum or installment payments. If a participant terminates employment, and the participant's account balance is less than \$5,000, the Plan Administrator will authorize the benefit payment without the participant's consent. The Plan allows for in-service distributions and hardship distributions, subject to Plan limitations.

**Forfeitures:** Forfeited nonvested accounts are used to pay administrative expenses or to fund employer contributions. There were approximately \$19,000 and \$2,000 of forfeited nonvested accounts as of December 31, 2024 and 2023, respectively. For the year ended December 31, 2024, accumulated forfeitures of approximately \$9,000 were used to fund employer contributions. Accumulated forfeitures will be applied to pay expenses or fund employer contributions in 2025.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors and trustee. See Note 4 for a discussion of fair value measurements.

Interest income is recorded on the accrual basis, and dividends are recorded on the ex-dividend date. Purchases and sales of investments are recorded on a trade-date basis. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Contributions:** Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments, and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year).

**Benefits paid to participants:** Benefits are recorded when paid.

**Administrative fees:** Certain expenses of maintaining the Plan are paid directly by the employer and are excluded from these financial statements. Fees related to the administration of the Plan are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

**Risks and uncertainties:** The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the 2024 statement of net assets available for benefits.

**Plan termination:** Although it has not expressed any intent to do so, the employer has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants would become fully vested in their accounts.

**Subsequent events:** The Plan has evaluated subsequent events through October 2, 2025, the date the financial statements were available to be issued.

Empower Trust Company, LLC, the trustee of the Plan, also certified as to the completeness and accuracy of \$1,207,944 of net appreciation in fair value of investments, \$77,250 of interest and dividends related to the aforementioned investments, and \$25,914 of interest income on notes receivable from participants for the year ended December 31, 2024.

#### Note 4. Fair Value Measurements

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Registered investment companies (mutual funds):** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Common collective trust funds:** Valued at the NAV of shares in each account held by the Plan at year end. The net asset value is not a public-quoted price in an active market. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

#### Note 6. Tax Status

The Plan has adopted a nonstandardized preapproved plan sponsored by Ascensus LLC. Ascensus LLC has received an opinion letter from the Internal Revenue Service as to the preapproved plan's qualified status. The preapproved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code (IRC).

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
