Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We have performed an audit of the accompanying financial statements of Retail Merchandising Services, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Retail Merchandising Services, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C)

Basis for Opinion on the Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Retail Merchandising Services, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. Responsibilities of Management for the Financial Statements

1. Description of Plan

The following description of Retail Merchandising Services, Inc. 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan covering all eligible employees of Retail Merchandising Services, Inc. (“Company”). Effective January 1, 2023, this Plan is referred to as “Qualified Automatic Contribution Arrangement 401 (k) Plan”, also known as QACA. This is a Safe Harbor QACA Plan, which is plan design where the Employer commits to making certain contributions as described under “Contributions” paragraph below. This commitment to make contributions enables the Employer to simplify the Administration of the Plan by ensuring that nondiscrimination regulations are met, which is why it is called a “Safe Harbor Plan”.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions - The Plan permits contributions up to the maximum percentage allowable by IRS Code Section 401(k) (13) “Qualified Automatic Contribution Arrangement (“QACA”) Safe Harbor. As of January 1, 2023, the Plan is a “QACA Safe Harbor plan.”

In order to maintain “QACA Safe Harbor” status, the Employer will have to make contributions in an amount equal to a percentage of elective deferrals, the specified matching percentage for the corresponding level of deferrals as shown in the table below.

Elective Deferral Tier	Matching Percentage
100%	first 3%
50%	next 2%

For purposes of calculating this safe harbor matching contribution, your compensation and deferrals will be computed for each payroll period.

The Employer may make an additional discretionary matching contribution. If the Employer makes a additional discretionary matching contribution, the discretionary additional matching contribution will not apply as to elective deferrals exceeding 6% of your compensation.

1. Description of Plan (continued)

Employees are allowed to defer their compensation to the Plan. These amounts are referred to as deferrals and are held on account for them. Employees are entitled to all deferrals, including gains or losses, when permitted to take a distribution from the Plan.

The Company made safe harbor contributions of \$341,627 and \$292,453 during the years ended December 31, 2024 and 2023, respectively.

Participant accounts - Individual accounts are maintained for each Plan participant. An eligible participant's account is credited with allocations of the employer's discretionary contributions and plan earnings and charged with withdrawals, plan losses, and an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Under the QACA Plan, the vesting in the Company's profit-sharing contributions allocated to a participant's account is typically based on years of continuous service, with the key point being that the employer contributions must be fully vested after the employee completes two years of service. Matching contributions to a QACA Safe Harbor 401(k) plan must be 100% vested after a participant completes no more than 2 years of service. A participant is 100% vested after three years of credited service. Participants also become fully vested upon attainment of age 60 or termination of employment because of death or disability. Employee contributions and safe harbor matching contributions are always fully vested.

1. Description of Plan (continued)

Payment of benefits - Benefits may be withdrawn if any of the following occur: normal retirement age, which is defined as age 60; disability; termination of employment; termination of the Plan; death. Vested balances of less than \$5,000 are paid out in a lump sum as soon as administratively possible after the participant is eligible to receive them. Vested balances over \$5,000 are paid out as requested by the participant.

Forfeited accounts - Forfeited non-vested accounts are first used to reduce employer contributions and then used to pay Plan administrative expenses. For the years ending 2024 and 2023, forfeitures used to reduce employer contributions amounted to \$0, respectively. There were forfeited accounts plus interest not yet allocated to the remaining participants totaling \$0 and \$46 for the years ended December 31, 2024 and 2023, respectively.

2. Summary of Accounting Policies

Basis of accounting - The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

Payments of benefits - Benefits are recorded when paid.

Plan expenses - Expenses incurred by the Plan for audit fees, plan administrative fees, and substantially all other operating expenses are paid from the Plan's assets, unless paid by forfeitures. The expenses will be allocated either proportionately based on the value of account balances or as equal dollar amounts based on the number of participants, depending on the nature of the expense.

Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Fully benefit-responsive investment contracts – In accordance with generally accepted accounting principles, investment contracts held by a defined contribution plan have the option to be reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan has elected to report them at contract value for both the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

2. Summary of Accounting Policies (continued)

Investment valuation and income recognition - The Plan's investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Subsequent events - Plan management has evaluated subsequent events through August 8, 2025, which is the date the financial statements were available to be issued.

3. Information Certified by the Custodians

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Voya Retirement Insurance and Annuity Company, the custodian of the Plan, has certified the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that priorities the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 inputs must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

6. Investment Contract with Life Insurance Company

The Plan entered into a benefit-responsive investment contract with Voya Retirement Insurance and Annuity Company (Voya). The Fund maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by the Fund. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value, which approximates market value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the stable value fund is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract.

6. Investment Contract with Life Insurance Company (continued)

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The value of the investment contract was \$55,832 and \$37,740 as of December 31, 2024 and 2023, respectively. The investment earns a guaranteed minimum interest rate (“GMIR”) of 1.00% for the life of the contract. Voya may credit interest at a current rate that may be higher than the GMIR. The current interest rate was 1.00% during the years ended December 31, 2024 and 2023. The current interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

8. Plan Amendments and Tax Status

The prototype plan obtained its latest determination letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of ERISA and the IRC and therefore fulfills the criteria for exemption from federal and state income tax.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

The Plan paid investment advisory, investment management, and recordkeeping fees totaling \$46,507 and \$35,030 during the years ended December 31, 2024 and 2023, respectively.
