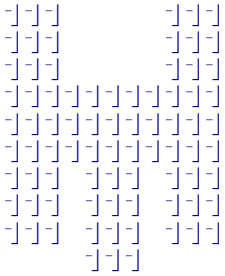

INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Palm Beach First Responders Foundation, Inc. Sponsored Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Palm Beach First Responders Foundation, Inc. Sponsored Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Palm Beach First Responders Foundation, Inc. Sponsored Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about The Palm Beach First Responders Foundation, Inc. Sponsored Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. 1. **Description of Plan**

The following description of The Palm Beach First Responders Foundation, Inc. Sponsored Retirement Plan (the "Plan"), is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

- a) *General* – The Plan is sponsored by Palm Beach First Responders Foundation, Inc. (Plan Sponsor) and is maintained for the exclusive benefit of eligible employees of the Town of Palm Beach (Employer), in order to help them plan for their retirement. The Plan covers all employees of the Palm Beach Police Department and the Palm Beach Fire Department, except for individuals who are participating in the Deferred Retirement Option Program under the Town of Palm Beach Employees Retirement System, employees covered under a collective bargaining agreement, except where such collective bargaining agreement provides for coverage under this Plan, nonresident aliens, individuals who as to any period of time are classified or treated by the employer as independent contractors, seasonal employees, leased employees, or consultants.

Participants become eligible after completing one year of service. Participants are credited with one year of service for each 12-consecutive month eligibility computation in which the participant is credited with at least 1,000 hours of service. The original effective date of the Plan is January 1, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

- b) *Plan Administration* – The Plan is administered by the Plan's Sponsor Administrative and Investment Committee. Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal) is the trustee, held custody, and serviced the Plan's investment assets during the year ended December 31, 2024 and 2023. The Plan has an agreement with The Paragon Alliance Group, LLC to provide third-party administrative services.
- c) *Contributions* – Each year, the Plan Sponsor may make discretionary non-elective contributions in an amount to be determined at the end of the Plan year. Participants cannot defer their own contributions into the Plan. Following the last day of each Plan year, the Plan Sponsor shall determine the level, if any, at which contributions may be made to the Plan. Contributions for a Plan year may be made at any time on or before December 31st of the following Plan year. Contributions are based upon base pay for a Plan year and exclude the following forms of non-regular pay: straight and regular over-time pay, bonuses, and shift premiums. As of December 31, 2024 and 2023, the Plan Sponsor made discretionary non-elective contributions of \$741,009 and \$664,921, respectively.
- d) *Participant Accounts* – Each participant's account is credited with the Plan Sponsor's non-elective contributions and plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. **Description of Plan, continued**

- e) *Vesting* – Vesting in the Plan Sponsor’s contributions is based upon years of completed vesting service. A participant is 100% vested after 6 years of credited service. Participants vest in their account based on the elapsed time method. Under this method participants are credited with a year of service on each anniversary date of their date of employment. Only whole years of service are counted. Upon death or disability, while still employed, or reaching age 65, non-elective contributions become 100% vested.
- f) *Administrative Expenses* – All expenses of Plan administration and operation, including fees of any agents employed and including any expenses attributable to a termination of the Plan, are paid by the Plan Sponsor.
- g) *Investment Options* – Upon enrollment in the Plan, a participant may direct the investment of their contributions into various investment options offered in Principal’s portfolio of investments. Participants may change their investment options via phone or internet access to Principal at any time.
- h) *Participant Notes Receivable* – The Plan does not allow loans.
- i) *Payments of Benefits* – Upon retirement, death, disability, or termination of service, a participant may elect to receive either a lump-sum amount or annual installments equal to the value of the participant’s vested interest in his or her account. The Plan does not allow hardship distributions.
- j) *Forfeitures* – Participants that terminate employment with the Employer and are less than 100% vested will forfeit the non-vested portion of the non-elective contributions in their account. Forfeitures are retained in the Plan and are used to reduce future contributions or pay Plan expenses. During the year ended December 31, 2024, \$45,413 was forfeited by participants, while \$336 was applied to administrative expenses. The balance of forfeited non-vested accounts as of December 31, 2024 and 2023 was \$47,123 and \$15,421, respectively.

2. **Summary of Significant Accounting Policies**

The following are the significant accounting policies followed by the Plan:

- a) *Basis of Accounting* – The accompanying financial statements are prepared on the accrual basis of accounting.
- b) *Use of Estimates* – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- c) *Payment of Benefits* – Benefits are recorded when paid.

2. **Summary of Significant Accounting Policies, continued**

d) *Plan Risk and Uncertainties* – The Plan is expected to invest in various investment securities. Investment securities are exposed to various risks such as interest rates, market, and credit risks. Due to the level of risk associated with certain investment securities, it is a least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts that are reported in the statements of net assets available for benefits. Additionally, the financial position of the Plan Sponsor, The Palm Beach First Responders Foundation, Inc. may have a significant impact on the Plan. Specifically, the ability of the Plan Sponsor to make discretionary non-elective contributions to the Plan and/or the stability of the Plan Sponsor's operations. Other external factors which may affect the Plan, and the Plan assets include legislation or regulations established by the Internal Revenue Service (IRS), Employee Retirement Income Security Act of 1974, and/or Department of Labor (DOL).

3. **Fair Value Measurements**

Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 820-10, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

3. Fair Value Measurements, continued

The following descriptions list the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024.

- a) *Mutual funds held in common and collective trusts (CCTs)* – Valued at the net asset value (NAV), as quoted by the investment manager, of shares held by the plan at year end. In this instance, the NAV is used as a practical expedient to estimate fair value.
- b) *Mutual funds held in pooled separate accounts (PSAs)* – Valued at the net asset value (NAV), as quoted by the investment manager, of shares held by the plan at year end. In this instance the NAV is used as a practical expedient to estimate fair value.
- c) *Mutual funds* – Valued at quoted market prices of a national security exchange on the last business day of the year, of units held by the Plan at year end.

The Plan’s independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

5. Related Party Transactions

Certain plan investments include shares of mutual funds managed by Principal Trust Company. Principal is the investment custodian of the Plan’s assets. Furthermore, Principal is the record keeper and trustee of the Plan, as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions. However, they are not considered prohibited transactions in accordance with appropriate ERISA exceptions.

6. Tax Status

This individually designed Plan has a favorable determination letter from the Internal Revenue Service dated January 9, 2023. Furthermore, the Plan’s sponsor and administrator believe that the Plan is designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore believes that the Plan is qualified and is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan’s financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Plan Termination

Although it has not expressed an intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, and accrued benefits, to the extent funded or required to be funded, and must be distributed to the participants.

8. Subsequent Events

Management has evaluated subsequent events through October 2, 2025, the date on which the financial statements were available to be issued, and determined there were no events to disclose in these financial statements.

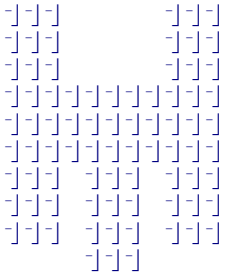

INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Palm Beach First Responders Foundation, Inc. Sponsored Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Palm Beach First Responders Foundation, Inc. Sponsored Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of assets held for investment purposes as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. **Description of Plan**

The following description of The Palm Beach First Responders Foundation, Inc. Sponsored Retirement Plan (the "Plan"), is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

- a) *General* – The Plan is sponsored by Palm Beach First Responders Foundation, Inc. (Plan Sponsor) and is maintained for the exclusive benefit of eligible employees of the Town of Palm Beach (Employer), in order to help them plan for their retirement. The Plan covers all employees of the Palm Beach Police Department and the Palm Beach Fire Department, except for individuals who are participating in the Deferred Retirement Option Program under the Town of Palm Beach Employees Retirement System, employees covered under a collective bargaining agreement, except where such collective bargaining agreement provides for coverage under this Plan, nonresident aliens, individuals who as to any period of time are classified or treated by the employer as independent contractors, seasonal employees, leased employees, or consultants.

Participants become eligible after completing one year of service. Participants are credited with one year of service for each 12-consecutive month eligibility computation in which the participant is credited with at least 1,000 hours of service. The original effective date of the Plan is January 1, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

- b) *Plan Administration* – The Plan is administered by the Plan's Sponsor Administrative and Investment Committee. Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal) is the trustee, held custody, and serviced the Plan's investment assets during the year ended December 31, 2024 and 2023. The Plan has an agreement with The Paragon Alliance Group, LLC to provide third-party administrative services.
- c) *Contributions* – Each year, the Plan Sponsor may make discretionary non-elective contributions in an amount to be determined at the end of the Plan year. Participants cannot defer their own contributions into the Plan. Following the last day of each Plan year, the Plan Sponsor shall determine the level, if any, at which contributions may be made to the Plan. Contributions for a Plan year may be made at any time on or before December 31st of the following Plan year. Contributions are based upon base pay for a Plan year and exclude the following forms of non-regular pay: straight and regular over-time pay, bonuses, and shift premiums. As of December 31, 2024 and 2023, the Plan Sponsor made discretionary non-elective contributions of \$741,009 and \$664,921, respectively.
- d) *Participant Accounts* – Each participant's account is credited with the Plan Sponsor's non-elective contributions and plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. **Description of Plan, continued**

- e) *Vesting* – Vesting in the Plan Sponsor’s contributions is based upon years of completed vesting service. A participant is 100% vested after 6 years of credited service. Participants vest in their account based on the elapsed time method. Under this method participants are credited with a year of service on each anniversary date of their date of employment. Only whole years of service are counted. Upon death or disability, while still employed, or reaching age 65, non-elective contributions become 100% vested.
- f) *Administrative Expenses* – All expenses of Plan administration and operation, including fees of any agents employed and including any expenses attributable to a termination of the Plan, are paid by the Plan Sponsor.
- g) *Investment Options* – Upon enrollment in the Plan, a participant may direct the investment of their contributions into various investment options offered in Principal’s portfolio of investments. Participants may change their investment options via phone or internet access to Principal at any time.
- h) *Participant Notes Receivable* – The Plan does not allow loans.
- i) *Payments of Benefits* – Upon retirement, death, disability, or termination of service, a participant may elect to receive either a lump-sum amount or annual installments equal to the value of the participant’s vested interest in his or her account. The Plan does not allow hardship distributions.
- j) *Forfeitures* – Participants that terminate employment with the Employer and are less than 100% vested will forfeit the non-vested portion of the non-elective contributions in their account. Forfeitures are retained in the Plan and are used to reduce future contributions or pay Plan expenses. During the year ended December 31, 2024, \$45,413 was forfeited by participants, while \$336 was applied to administrative expenses. The balance of forfeited non-vested accounts as of December 31, 2024 and 2023 was \$47,123 and \$15,421, respectively.

2. **Summary of Significant Accounting Policies**

The following are the significant accounting policies followed by the Plan:

- a) *Basis of Accounting* – The accompanying financial statements are prepared on the accrual basis of accounting.
- b) *Use of Estimates* – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- c) *Payment of Benefits* – Benefits are recorded when paid.

2. **Summary of Significant Accounting Policies, continued**

d) *Plan Risk and Uncertainties* – The Plan is expected to invest in various investment securities. Investment securities are exposed to various risks such as interest rates, market, and credit risks. Due to the level of risk associated with certain investment securities, it is a least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts that are reported in the statements of net assets available for benefits. Additionally, the financial position of the Plan Sponsor, The Palm Beach First Responders Foundation, Inc. may have a significant impact on the Plan. Specifically, the ability of the Plan Sponsor to make discretionary non-elective contributions to the Plan and/or the stability of the Plan Sponsor's operations. Other external factors which may affect the Plan, and the Plan assets include legislation or regulations established by the Internal Revenue Service (IRS), Employee Retirement Income Security Act of 1974, and/or Department of Labor (DOL).

3. **Fair Value Measurements**

Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 820-10, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

3. Fair Value Measurements, continued

The following descriptions list the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024.

- a) *Mutual funds held in common and collective trusts (CCTs)* – Valued at the net asset value (NAV), as quoted by the investment manager, of shares held by the plan at year end. In this instance, the NAV is used as a practical expedient to estimate fair value.
- b) *Mutual funds held in pooled separate accounts (PSAs)* – Valued at the net asset value (NAV), as quoted by the investment manager, of shares held by the plan at year end. In this instance the NAV is used as a practical expedient to estimate fair value.
- c) *Mutual funds* – Valued at quoted market prices of a national security exchange on the last business day of the year, of units held by the Plan at year end.

The Plan’s independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

5. Related Party Transactions

Certain plan investments include shares of mutual funds managed by Principal Trust Company. Principal is the investment custodian of the Plan’s assets. Furthermore, Principal is the record keeper and trustee of the Plan, as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions. However, they are not considered prohibited transactions in accordance with appropriate ERISA exceptions.

6. Tax Status

This individually designed Plan has a favorable determination letter from the Internal Revenue Service dated January 9, 2023. Furthermore, the Plan’s sponsor and administrator believe that the Plan is designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore believes that the Plan is qualified and is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan’s financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Plan Termination

Although it has not expressed an intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, and accrued benefits, to the extent funded or required to be funded, and must be distributed to the participants.

8. Subsequent Events

Management has evaluated subsequent events through October 2, 2025, the date on which the financial statements were available to be issued, and determined there were no events to disclose in these financial statements.
