### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Marquee Brands, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). ### 1. Description of the Plan

The following description of the Marquee Brands, LLC 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan's information.

#### *General*

The Plan was adopted effective January 1, 2017, by Marquee Brands LLC (the Company, or Employer), the sponsor of the Plan. The Plan was amended and restated effective January 1, 2020. The Plan is a contributory defined contribution plan covering all eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### *Plan Administration*

The Plan custodian is Voya Retirement Insurance and Annuity Company (Voya). All administrative decisions are made by the Plan's administrative committee.

#### *Eligibility*

Participants must be 21 years of age to participate in the Plan. There is no minimum service requirement in order to make salary deferrals under the Plan. Thus, you will be able to make salary deferrals (provided you are an eligible employee) as of the first entry date following your date of employment (or the date you satisfy any minimum age requirement described above). Union employees, nonresident aliens and residents of Puerto Rico are excluded from participation in the Plan.

#### *Contributions*

Participants may contribute up to 100% of pre-tax annual compensation as defined in the Plan document limited to Internal Revenue Service (IRS) regulations to a maximum amount of \$23,000 for the year ended December 31, 2024. Individuals who would be at least age 50 by December 31, 2024 may make an additional catch-up contribution, up to a maximum amount of \$7,500 for the year ended December 31, 2024. The Company may allow participants, upon proper notice and approval, to enter into a special salary deferral agreement to make employee deferral contributions of up to 100% of any Employer paid cash bonus designated by the Company. The Plan also allows for Roth 401(k) and rollover contributions.

The Employer will make a safe harbor matching contribution to the account of each eligible participant equal to 100% of salary deferrals that do not exceed 3% of compensation plus 50% of salary deferrals between 3% and 5% of compensation. The safe harbor matching contribution made for the year ended December 31, 2024 totaled \$646,700. The Employer may make a discretionary matching contribution of up to 4% of eligible compensation. There were no discretionary matching contributions made for the year ended December 31, 2024. In addition, the Employer may make a discretionary non elective contribution to eligible participants based on each participants compensation, as defined, to the total compensation of all participants. No non elective contribution was made for the year ended December 31, 2024.

### ***Participant Accounts***

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, the Company's matching contributions, and Plan earnings, and charged with withdrawals and an allocation of Plan losses and administrative expenses not otherwise paid by the Company. Allocations are based on participant earnings or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are vested immediately in their contributions, as well as any Employer contributions, plus actual earnings thereon.

### ***Notes Receivable from Participants***

Participants are permitted to borrow a minimum of \$1,000 of their vested benefits under the Plan. Participants may borrow up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the highest outstanding loan balance in their account during the prior 12-month period. Loans are secured by the participant's account and all participant loans will be charged a reasonable rate of interest. For this purpose, the interest rate charged on a participant loan must be commensurate with the interest rates charged by persons in the business of lending money for loans under similar circumstances and is fixed for the term of the loan. At December 31, 2024 and 2023, notes bear interest at a rate of 3.25% to 10.50%. The notes are repaid ratably through payroll deductions over a period of five years or less, unless used to purchase a principal residence. These loans are subject to certain restrictions as defined by the Plan document and applicable restrictions under the Internal Revenue Code (IRC). Participants are allowed one outstanding loan at a time.

### ***Contributions Receivable***

Participant contributions and any related safe harbor matching contributions, discretionary matching and discretionary nonelective contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

### ***Payment of Benefits***

On termination of service with the Company (including termination of service due to death, disability, or retirement), a participant may generally elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Participants may withdraw any vested amount allocated to their accounts in service after attaining age 59½. In the event of a hardship, participants who are current employees may withdraw their vested employee and Company contributions to the extent permitted by the Plan. Participants may withdraw their rollover contributions to the extent permitted by the Plan.

### 2. Summary of Accounting Policies

#### *Basis of Accounting*

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### *Use of Estimates*

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value, except for the fully benefit-responsive investment contract, which is stated at contract value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Gains or losses from the sale of investments are determined on the average cost basis. Realized and unrealized gains and losses on investments held are included in net appreciation in fair value of investments in the accompanying statement of changes in net assets available for benefits. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Payment of Benefits*

Benefit payments to participants are recorded upon distribution.

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

#### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

### 3. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024 and 2023.

*Pooled Separate Accounts* - Pooled separate accounts are valued at their accumulation unit value (AUV) as a practical expedient. The AUV is determined daily based on the net asset value (NAV) of shares of the underlying fund, the fund's dividends, and the separate account charges (i.e., the daily asset charge). The Plan's investments in the pooled separate accounts may be redeemed daily. There are no redemption fees or notice periods and no unfunded commitments.

The investments in pooled separate accounts, which are valued at AUV, have not been classified in the fair value hierarchy, in accordance with Accounting Standards Update (ASU) 2015-07, *Disclosures for Investments in Certain Entities That Calculate Net Asset Value per Share (or its Equivalent)*. The underlying funds of the investments in pooled separate accounts are with various registered investment companies whose investment strategies are to seek capital appreciation through investment in common stocks, fixed income securities, and mutual funds.

The Plan had no financial assets that were measured at fair value on a nonrecurring basis during the years ended December 31, 2024 and 2023.

### 4. Fully Benefit-Responsive Contract

The Plan entered into a fully benefit-responsive guaranteed-interest account contract with Voya. Voya maintains the contributions in a fixed account. The account is credited with earnings on the underlying interests and charged for participant withdrawals and administrative expenses. Voya is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Because the guaranteed-interest contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed-interest contracts. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus interest, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), and (2) the establishment or activation of, or material change in, any Plan investment fund, or an amendment to the Plan or a change in the administration or operation of the Plan, including the removal of a group of employees from Plan coverage as a result of the sale or liquidation of a subsidiary or division or as a result of group layoffs or early retirement programs. The Plan administrator believes that any events which would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

The guaranteed-interest contract do not permit Voya to terminate the agreement prior to the scheduled maturity date.

### 5. Information Certified by the Trustee

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya, a qualified institution.

### 6. Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by Voya. Participant loan and distribution processing fees are paid to Voya by participants. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. The Company provides certain accounting, administrative, and investment management services to the Plan for which no fees are charged. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

### 7. Tax Status

The Plan uses a volume submitter document sponsored by Ascensus. Ascensus received an advisory letter from the IRS, dated June 30, 2020, which states the volume submitter document is acceptable and satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. The Plan has been amended since receiving the opinion letter. However, the Plan's management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audit by taxing jurisdictions; however, there are currently no audit for any tax periods in progress.

### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### 9. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will remain 100% vested in their account balances.

### 10. Prohibited Transactions and Contingencies

During the Plan years ended December 31, 2022 through 2024, employee salary deferral contributions totaling \$100,091 were not remitted within the appropriate time period by the Company. These transactions constitute prohibited transactions, as defined by ERISA. The Company is taking the appropriate steps to correct these late remittances with a contribution of lost earnings to the affected participants. The Company does not expect the lost earnings to be material and has implemented a procedure to ensure all future remittances are done within the prescribed time period.

The Company is responsible for any fines, excise taxes, and/or penalties or actions brought by the affected participants or regulatory authorities related to these prohibited transactions.

### 11. Subsequent Events

The Plan's management has performed subsequent event procedures through October 1, 2025, which is the date the financial statements were available to be issued; there were no subsequent events requiring adjustments to the financial statements or disclosures as stated herein.
