#### Note 1. Description of Plan

The following description of Holmes Food, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement, as amended, for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan that covers substantially all nonunion employees of Holmes Food, Inc.; Holmes Foods Poultry LTD; H.F. Poultry, Inc.; Rio Grande Pak, Inc. and Rio Grande Pak Foods LTD, (collectively, the Company or Plan Sponsor) who have completed at least three months of service and are age 21 or older. Participants may enter the Plan on the first day of the month following the date on which eligibility requirements were met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

**Contributions:** Each year, participants may elect to contribute pretax elective deferrals up to 90% of eligible wages, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Company makes safe harbor matching contributions of 100% of participant contributions, up to a maximum of 4% of eligible wages. Additional matching and profit sharing amounts may be contributed at the option of the Company's board of directors. There were no discretionary matching and profit sharing contributions for the year ended December 31, 2024. Participants must complete more than 500 hours of service to receive a discretionary profit sharing contribution. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Investment options:** Upon enrollment in the Plan, a participant may direct all contributions to selected investments as made available and determined by the Plan Administrator in 1% increments. Participants may change their investment options daily.

**Participant accounts:** Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are 100% vested at all times in their voluntary contributions, Company safe harbor contributions and actual earnings thereon. Vesting in the Company's discretionary matching and profit sharing contributions is based on the participants' years of service.

Company discretionary matching and profit sharing contributions have a six-year graded vesting period as follows:

Full and immediate vesting will occur upon death or disability or termination of the Plan.

**Forfeitures:** At December 31, 2024 and 2023, there were no unallocated forfeitures in the forfeited nonvested accounts. In 2023, there were no forfeitures to pay for Plan expenses or reduce employer contributions.

**Payment of benefits:** On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive the vested interest in his or her account. Participants may elect to receive a distribution in the form of a lump-sum payment or partial withdrawals. If the participant's vested balance is less than \$7,000, benefits shall be distributed to the participant through a lump-sum distribution or, if no election has been made by the participant, through a direct rollover into an Individual Retirement Account. The Plan also allows for in-service distributions upon reaching age 59½ or for proven financial hardship. Hardship withdrawals are also available subject to certain limitations, as defined in the Plan agreement.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The accompanying financial statements are prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisers and custodian. See Note 4 for disclosure of the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Contributions receivable:** Employee and the related employer matching contributions are recorded in the period the employee contribution is withheld.

**Payment of benefits:** Benefits are recorded when paid.

**Administrative expenses:** Expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of Plan services for participants are charged directly to the participant's account, and are included in administrative expenses. Investment-related expenses are included as an offset to net appreciation in fair value of investments.

**Subsequent events:** The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued.

#### **Note 4. Fair Value Measurements**

Accounting Standards Codification (ASC) Topic 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820, Fair Value Measurements and Disclosures, are described below.

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices for the asset or liability that are observable
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, Level 2 inputs must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques that are used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

**Pooled separate accounts:** Pooled separate accounts are valued based on the net asset value (NAV) of units of the pooled account. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The method above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note 5. Party-in-Interest Transactions

Parties in interest are defined under Department of Labor (DOL) regulations as any fiduciary of the Plan, any party rendering services to the Plan, the Company and certain others. Certain Plan investments are managed by John Hancock, the custodian; therefore, these transactions and investments qualify as party-in-interest transactions.

The Company paid certain administrative expenses related to the Plan for the year ended December 31, 2024.

#### Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

#### Note 7. Tax Status

The plan is qualified under the appropriate section of the Internal Revenue Code (IRC) and intends to continue as a qualified plan. The IRS has determined and informed the Plan Sponsor by a letter dated June 30, 2020, that the Plan, as designed, is qualified under the appropriate section(s) of the IRC. The Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 8. Nonexempt Transactions

During 2023, the Plan Sponsor inadvertently deposited \$63 of participant deferrals outside of the average number of business days it takes the Plan Sponsor to reasonably segregate the assets. These were within the required time frame as stated by the DOL's regulations; however, they were considered late based on the Plan Sponsor's average number of business days for participant deferral remittances. The Plan sponsor reimbursed the Plan for lost interest. The Plan Sponsor filed Form 5330 and paid the applicable excise tax in 2024. The excise tax payments were made from the Plan Sponsor's assets and not from assets of the Plan.

#### **Note 9. Risks and Uncertainties**

The Plan invests in various investments. Investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.
