As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedule of assets (held at end of year) and schedule of delinquent participant contributions as of December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Note 1. Description of Plan

The following brief description of the Dickie Brennan & Co., Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of Dickie Brennan & Co., LLC; Seven Sixteen Iberville, LLC; Brasserie, LLC; Le Petit Restaurant, LLC; Cousins Restaurant, Inc.; Acorn Café, LLC; Commissary, LLC; Clubhouse Concepts, LLC (effective June 1, 2023); Pascal's Operating Company, LLC (effective March 17, 2023); and DBC Catering, LLC (effective June 1, 2023) (collectively, the Companies) who have satisfied the eligibility requirements of age 21 and older and one year of service. Dickie Brennan & Co., LLC is the Plan Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Each year, participants may elect to contribute his or her eligible compensation, up to the maximum allowed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Companies may make, at their discretion, a matching contribution to the Plan. For the year ended December 31, 2024, the Companies matched 50% of the participants' contributions, up to 5% of their eligible compensation. The Companies may also make, at their discretion, a profit-sharing contribution to the Plan. There was no profit-sharing contribution made to the Plan for the year ended December 31, 2024.

Participant Accounts

Participants direct the allocation of their voluntary contributions and discretionary matching and profit-sharing contributions from the Companies among the Plan's investment options. Each participant's account is also credited with allocations of plan earnings/losses. Participant accounts are charged with an allocation of administrative expenses for investment management fees paid by the Plan. Allocations are based on participant earnings/losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is limited to the vested balance in the participant's account.

Notes Receivable from Participants

Participants may borrow up to 50% of their vested account balance but may not exceed \$50,000. The minimum amount a participant can borrow is \$1,000. The loans are secured by the balance in the participant's vested account and bear an interest rate which is determined by the Plan Administrator. Principal and interest are paid ratably through bi-weekly payroll deductions. Loan interest paid by a participant is credited to the account of the paying participant.

Note 1. Description of Plan (Continued)

Payment of Benefits

Distributions from plan assets are made upon the participant's death, disability, retirement, termination of service, or other circumstances as described in the Plan Document. Distributions may be made in the form of a lump sum payment or an alternate form of payment as permitted in the Plan Document. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan.

Vesting

Participants are immediately vested in their contributions plus actual earnings/losses thereon. A participant becomes 100% vested in the Companies' discretionary contributions and earnings/losses thereon after 6 years of credited service. Participants become 100% vested in the Companies' contributions and earnings/losses at normal retirement age, death, disability, or termination of the Plan.

Forfeitures

When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeiture accounts may be applied to payment of plan administration expenses or used to reduce future employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$8,800 and \$7,638, respectively.

Plan Termination

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination or partial termination of the Plan, or the complete discontinuance of contributions, the rights of all affected participants to their accrued benefits shall be fully vested and non-forfeitable.

Administrative Expenses

Administrative expenses of the Plan may be paid by the Companies or the Plan as provided in the Plan Document. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent loans are treated as distributions based upon the terms of the Plan Document.

Contributions

Contributions from plan participants and the matching contributions from the Companies are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Tax Status

The plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the IRC. The Plan has been amended since adopting the preapproved plan document; however, the plan administrator believes the Plan is designed, and being operated, in compliance with the applicable requirements of the IRC.

Note 2. Summary of Significant Accounting Policies (Continued)

Tax Status (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Note 3. Information Certified by John Hancock Life Insurance Company (U.S.A.)

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedules, obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.) (John Hancock), a qualified institution.

John Hancock also certified to the completeness and accuracy of \$818,757 of net appreciation in fair value of investments and \$7,047 of interest income on notes receivable from participants for the year ended December 31, 2024.

Note 4. Fair Value Measurements

The *Fair Value Measurement* Topic of the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 4. Fair Value Measurements (Continued)

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: Valued at the market value of the underlying mutual funds as adjusted for the Plan's participation unit in the pooled accounts.

The preceding method may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- (a) This category attempts to maximize returns by taking a relatively higher degree of risk. It emphasizes capital appreciation as a primary investment objective, rather than income or safety of principal.
- (b) These funds primarily consist of investments seeking various degrees of current income, capital appreciation, and preservation of capital. The allocations are dependent on the target retirement date. The funds invest in fixed income and equity funds, with a goal of capital appreciation for those funds with distant target retirement dates. As the target retirement date approaches, the funds change the mix toward a goal of preservation of capital and production of income.
- (c) These funds seek to preserve an investment portfolio's value by investing in lower risk securities such as fixed-income and money market securities.
- (d) These funds consist of a diversified portfolio of stocks that has capital appreciation as its primary goal, with little or no dividend payouts. Portfolio companies would mainly consist of companies with above-average growth in earnings that reinvest their earnings into expansion, acquisitions, and/or research and development.
- (e) These funds have a dual strategy of capital appreciation and current income generation through dividends or interest payments. A growth and income fund may invest only in equities or in a combination of stocks, bonds, REITS, and other securities.
- (f) These funds emphasize current income, either on a monthly or quarterly basis, as opposed to capital appreciation. Such funds hold a variety of government, municipal, and corporate debt obligations, preferred stock, money market instruments, and dividend-paying stocks.

Note 5. Related-Party and Party-in-Interest Transactions

Certain plan investments are managed by John Hancock. John Hancock is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Certain fees incurred and paid directly by the Plan are for investment management services. Consequently, such transactions are permitted under the provisions of the Plan and are exempt from the provision of the party-in-interest transactions under ERISA.

Note 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7. Prohibited Transactions

During 2023, the Plan Sponsor failed to deposit \$137,693 of participant deferrals within the required timeframe as stated by the United States Department of Labor (DOL) regulations. The Plan Sponsor calculated lost earnings of \$192 for these late remittances and deposited these lost earnings into affected participants' accounts in August 2024 to compensate those participants for potential lost income due to the delays.

Note 8. Subsequent Events

Management has evaluated subsequent events through the date that the financial statements were available to be issued, September 26, 2025 and determined that the following event occurred that requires disclosure:

In July 2025, the Plan Sponsor closed Cousins Restaurant, Inc.

No further subsequent events occurring after September 26, 2025 have been evaluated for inclusion in these financial statements.
