## NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

### 1. Description Of Plan And Basis Of Presentation

The RevGen Partners, Inc. 401(k) Plan (the Plan) is sponsored by RevGen Partners, Inc. (the Company or the Plan Administrator).

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The following description of the Plan provides only general information. Participants and all others should refer to the Plan Agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering employees of the Company. The Company adopted the Plan effective January 10, 2010. Under the provisions of the Plan, participants who have completed three consecutive months of service are automatically enrolled at 6%, with the plan entry date on the first of the month coinciding with attaining this service requirement.

The Plan is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986 (the Code), as amended.

Principal Life Insurance Company (Principal) serves as an asset custodian and the Plan's record keeper. Principal (qualified institution) was determined by management to meet the requirements of ERISA Section 103(a)(3)(C) to certify the investment information as complete and accurate.

#### Participant Contributions

Participants may contribute up to 90% of eligible compensation (as defined in the Plan Agreement), as Roth contributions, pre-tax contributions or a combination thereof, subject to certain Internal Revenue Service (the IRS) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of \$7,500 in 2024. Employees may contribute rollover contributions from other qualified plans. Participants may change their tax-deferred contribution percentage as of any payroll period and may discontinue their election on the first day of each payroll period. Once discontinued, the participant may reelect to make contributions on the first day of any payroll period. Participants may redesignate the investment options in which their allocated shares of the total Plan are invested to be effective on any day.

### Notes To Financial Statements (*Continued*)

#### **Company Matching Contributions**

Participants are immediately eligible for Company matching contributions, which are equal to a uniform percentage a participant's elective deferrals each payroll period. The Company's match is equal to 25% of the participant's 401(k) elective deferral contributions. Elective deferrals over 6% of a participant's pay are not matched.

The Company may also make a discretionary profit-sharing contribution in addition to the base matching contributions of the Plan. There were no discretionary profit-sharing contributions for the year ended December 31, 2024.

#### **Participant Accounts**

Participant accounts are credits with participant contributions, the Company's contributions, and an allocation of Plan earnings and administrative expenses. The allocation of earnings is determined by the earnings of the participant's investment selection based on each participant's account balance and the investments selected by the participant.

#### **Investment Options**

Participants may direct their deferrals, rollovers and employer contributions into various investment options maintained by Principal.

#### **Vesting**

Participants are immediately vested in their voluntary salary deferral contributions and rollover contributions and any income or loss thereon.

The Company's matching contributions vest according to the following schedule:

One year	25%
Two years	50%
Three years or more	100%

#### **Forfeitures**

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are first be used to pay administrative expenses. If any forfeitures remain then they can be used to reduce employer contributions or be allocated as soon as administratively feasible.

During 2024 and 2023, there was \$9,424 and \$4,708 used to pay administrative expenses and \$29,639 and \$15,918 used to reduce employer contributions, respectively. There were no unallocated forfeitures as of December 31, 2024 and 2023, respectively.

#### **Notes Receivable From Participants**

A participant may borrow from their account the lesser of \$50,000 or 50% of their vested account balance with a minimum loan amount of \$500. Participants may only have 1 loan outstanding at any given time. Loans are secured by the participant's vested account. The loans are to be repaid over a 5-year period unless they are for the purchase of a principal residence, which allow for up to a 30-year period. Principal and interest are collected ratably through bi-weekly payroll deductions.

#### **Benefit Payments**

A participant's entire vested interest in the Plan is payable in the event of termination, upon death of the participant, attaining normal retirement age of 59½ or becoming totally disabled, as defined in the Plan Agreement. A participant's benefits are payable in a lump-sum payment or periodic cash installments. In addition, hardship distributions are permitted if specified criteria are met.

#### **Administrative Expenses**

The majority of Plan expenses are paid by the Company. Plan expenses not paid by the Company are deducted from Plan assets. Administrative expenses paid by the Plan include record keeper fees, services fees and transactions fees.

## **2. Summary Of Significant Accounting Policies**

#### **Basis Of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

#### **Estimates And Assumptions**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

#### **Investment Valuation And Income Recognition**

The Plan's investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. The net depreciation in fair value of investments represents the difference between the aggregate fair value at year end and the values at the beginning of the year, and includes any realized gains and losses in shares that were bought and sold during the year.

#### **Notes Receivable From Participants**

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

#### **Payment Of Benefits**

Benefit payments are recorded when paid.

#### **Subsequent Events**

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

### **3. Certified Investment Information**

Certain information related to investments, notes receivable from participants and investment income disclosed in the accompanying financial statements and supplemental schedule, as of December 31, 2024 and 2023 and for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Principal.

#### 4. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets,
  - Quoted prices for identical or similar assets or liabilities in inactive markets,
  - Inputs other than quoted prices that are observable for the asset or liability and

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value:

#### **Mutual Funds**

Assets are valued at the daily closing price as reported by the funds. Mutual funds are open-end investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (the NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified as Level 1 within the fair value hierarchy.

#### **Common/Collective Trusts**

These are valued at the unit value or the NAV of the shares held by the Plan at year end. The NAV, as provided by the Trustee of the fund, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities, divided by the number of shares outstanding. All of the underlying investments held by the Plan may be redeemed daily. The common/collective trusts held by the Plan are not required to be reported in the fair value hierarchy. The common/collective trusts held by the Plan files an annual report on Form 5500 as a direct filing entity. The common/collective trusts have no unfunded capital.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **5. Party In Interest Transactions**

The Plan incurs expenses related to general administration and recordkeeping. These expenses and certain accounting and auditing fees related to the Plan are paid by the Company, and the Company performs certain administrative functions at no cost to the Plan.

Certain participants of the Plan have outstanding loans with the Plan as of December 31, 2024 and 2023. These loans are considered party in interest transactions in accordance with Department of Labor guidelines.

### **6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### **7. Income Tax Status**

The IRS has determined and informed the Plan Administrator by letter dated June 30, 2020 that the Plan is designed in accordance with applicable sections of the Code. The Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believe that the Plan is qualified and tax exempt.

### **8. Risks And Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
