Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The GCC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Note 1 – Description of the Plan

The following description of The GCC 401(k) Plan (the "Plan") provides only general information. Participants and all others should refer to the Plan document for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution plan, which went into effect July 1, 1994, that is generally available to all employees of GCC of America, Inc. (the "Company," "Plan Sponsor," or "Plan administrator") and Related and Participating Employers (collectively, the "Employer"). The Plan excludes leased employees, reclassified employees, and independent contractors. Employees are eligible after completing 3 months of service and attainment of age 18. Employees may enter the Plan on the first day of the month coincident with or next following the date they meet the Plan's eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Benefits under the Plan are not guaranteed by the Pension Benefit Guaranty Corporation.

Contributions. The following types of contributions are allowable under the Plan:

- Salary Deferral Contributions - Participants may contribute up to 90% of their pretax compensation, as defined in the Plan document. Participants may also elect to make an after-tax Roth contribution to the Plan. The Plan has an automatic contribution arrangement. Unless a newly eligible participant affirmatively elects otherwise after being given appropriate notice, 1% of their compensation will automatically be withheld and contributed to their pre-tax contributions account. A participant's total salary deferral contribution cannot exceed \$23,000 (\$30,500 for participants age 50 or older) in calendar year 2024.
- Safe Harbor Matching Employer Contributions - The Company makes a safe harbor Employer matching contribution each Plan year equal to 100% of each eligible participant's salary deferral contributions that do not exceed 4% of each eligible participant's compensation.
- Discretionary Nonelective Employer Contributions - The Company may make a discretionary nonelective Employer matching contribution to those eligible participants that are employed on the last day of the Plan year and have completed six months of service within the Plan year. Participants who die, become disabled, or attain early or normal retirement age during the year, are also eligible to share in an allocation of the discretionary nonelective Employer contribution. Such contribution is allocated in the proportion that each participant's compensation bears to the total compensation of all participants. For the year ended December 31, 2024, the Employer did not make a discretionary nonelective Employer contribution.
- Rollover Contributions - Amounts distributed to participants from other qualified employee benefit plans may be rolled into the Plan.

All contributions are allocated to the Plan's investment funds at the direction of the participants.

The total annual additions to a participant's account may not exceed the lesser of \$69,000 in calendar year 2024, or 100% of the participant's compensation, as defined.

Investment Options. Participants may currently direct their investments into various registered investment companies and a pooled separate account.

Participant Accounts. Each participant's account is credited with the participant's contributions (pre-tax deferrals, Roth deferrals and rollovers, if any) and an allocation of (a) the Employer's contribution (safe harbor matching and discretionary nonelective), (b) fund earnings or losses, and (c) administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting. Participants are immediately vested in their elective deferral contributions, rollover contributions, safe harbor Employer matching contributions, and related earnings thereon. Profit sharing contributions made prior to January 1, 2009 and non-safe harbor (frozen) matching contributions made prior to 2009 are also 100% vested.

Vesting in nonelective Employer contributions is based on periods of service, as defined in the Plan document, and occurs according to the following schedule:

<u>Periods of Service</u>	<u>Vested %</u>
Less than 3	0%
3	100%

Furthermore, employed participants become 100% vested in nonelective Employer contributions upon the following events:

- Participant's death
- Participant becomes disabled as defined under the Plan;
- Participant attains early or normal retirement age, as defined; or
- Termination or partial termination of the Plan.

Forfeitures and Unallocated Asset Accounts. When certain terminations of participation in the Plan occur, the non-vested portion represents a forfeiture. Forfeitures are used to pay administrative expenses of the Plan, used to reduce discretionary Employer nonelective contributions, or are reallocated as an additional discretionary Employer nonelective contribution. The Plan also maintains unallocated asset accounts. As of December 31, 2024 and 2023, the balance in the forfeitures and unallocated asset accounts were \$3,305 and \$77, respectively.

Plan Expense Account. The Plan maintains a Plan Expense Account ("PEA") that is funded with revenue credits from the Plan's service provider. The PEA is used to offset Plan administrative expenses. As of December 31, 2024 and 2023, the balance in the PEA was \$1,529 and \$6,848, respectively.

Notes Receivable from Participants. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of (i) \$50,000 reduced by the highest outstanding loan balance during the previous 12 months; or (ii) 50% of their vested account balance. Loan terms range from 1 month up to a maximum of 5 years (20 years if used for the purchase of a principal residence). The loans are secured by the balance in the participant's account and bear interest at the bank prime rate plus 2% at the date the loan is granted. Principal and interest payments are paid ratably through monthly participant ACH payments.

Payment of Benefits. Benefits to participants or beneficiaries generally are payable as a lump sum, installments, or partial withdrawals equal to the value of their vested account upon retirement, disability, death or termination of the participant. A terminated employee with a balance of less than a certain dollar threshold, as defined by the Plan document, may be automatically paid out by the Plan upon termination. Additionally, participants may request in-service withdrawals of their after-tax contributions account, rollover contributions account, for a qualified reservist distribution, for a qualified birth or adoption distribution, upon attainment of age 59½, or upon incurring a financial hardship, as defined in the Plan document, if certain criteria are met.

Note 2 – Summary of Significant Accounting Policies

Use of Estimates and Basis of Accounting. The financial statements of the Plan are prepared using the accrual method of accounting. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition. The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and qualified institutions. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Contributions. Participant contributions and the related Employer matching contribution are recognized in the period in which participant contributions are withheld from compensation.

Benefits Paid to Participants. Benefits are recorded when paid.

Expenses and Revenue Credits. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Also included in administrative expenses are recordkeeping, investment advisory, consulting, and other fees. Additionally, certain investment related expenses are included in net appreciation in fair value of investments.

The Plan receives revenue credits from the Plan's service provider which are used to reduce administrative expenses of the Plan. During 2024, total administrative expenses and revenue credits netted to \$120,872, which consisted of \$239,569 in administrative fees and \$118,697 in revenue credits.

Note 3 – Fair Value Measurements

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

- Registered investment companies ("RICs") are valued at the quoted net asset value ("NAV") of shares/units held by the Plan at year end.
- Pooled separate accounts ("PSAs") are valued at the NAV of units held by the Plan at year end. The NAV, as provided by the qualified institutions, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the PSAs less their liabilities. This practical expedient is not used when it is determined to be probable that the PSAs will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination or partial termination, affected participants will become 100% vested in their accounts.

Note 7 – Tax Status

The Plan Sponsor has adopted an Empower Retirement, LLC Non-Standardized Pre-Approved Profit Sharing Plan ("pre-approved plan"). The pre-approved plan received an opinion letter from the IRS on September 16, 2022, which stated that the pre-approved plan is qualified under the applicable sections of the Internal Revenue Code ("IRC"). Although the pre-approved plan and the Plan have been amended since receiving the IRS opinion letter, the Plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified under Section 401(a) of the IRC and the related Trust is tax exempt as of December 31, 2024 and 2023. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Party-In-Interest Transactions

The Company provides to the Plan certain accounting and administrative services for which no fees are charged.

Certain Plan investments are units of pooled separate accounts offered by Empower Annuity Insurance Company. As Empower Annuity Insurance Company is one of the qualified institutions of the Plan, these transactions qualify as party-in-interest transactions. Additionally, the Plan maintains notes receivable from participants. Fees paid for services rendered by parties-in-interest were based on customary and reasonable rates for such services.

Note 9 – Concentrations, Risks, and Uncertainties

The Plan provides for various investment options. Investment securities, in general, are exposed to various risks, such as significant world events, interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts presented in the statements of net assets available for benefits. As of December 31, 2024 and 2023, there was one investment which individually represented more than 10% of net assets available for Plan benefits. See supplemental Schedule of Assets (Held at End of Year) for a complete listing of investments held at December 31, 2024.

Additionally, some investments held by the Plan are invested in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

Note 10 – Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 29, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan was amended to provide for an auto escalation on the Plan's automatic contribution arrangement. Unless a newly eligible or rehired participant affirmatively elects otherwise after being given appropriate notice, 1% of their compensation will be withheld and contributed to the Plan as a pre-tax salary deferral contribution. Such automatic contribution will be increased 1% annually on July 1 until a 5% salary deferral percentage is reached.

On January 6, 2025, the Company announced the acquisition of three pure-play aggregates operations in Texas.
