This letter is being filed in connection with the Form 5500 filing for the Cliff Castle Casino Welfare Benefit Plan (the "Enterprise Plan"), with regard to the plan year ending December 31, 2024.

The Enterprise Plan is the wraparound welfare benefit plan maintained for the employees of Yavapai-Apache Nation enterprises who are deemed to be performing commercial functions and subject to the requirements of the Employee Retirement Income Security Act of 1974 ("ERISA"). Yavapai-Apache Nation (the "Nation") also maintains a separate wraparound welfare benefit plan for the employees of the Nation who perform essential governmental functions that are not commercial in nature (the "Governmental Plan"). The Nation classifies all employees in reasonable and good faith operational compliance with Section 906 of the Pension Protection Act.

For the period covered by the 2024 Form 5500 filing, the data for the Enterprise Plan and the Governmental Plan was kept and reported on a combined basis. As a result, the Form 5500 for the Enterprise Plan also includes the population covered by the Governmental Plan and therefore are over-inclusive. The inclusion of the Governmental Plan in the Form 5500 is not a waiver of the governmental status of the Governmental Plan or any employee participation in such Plan, nor is it a waiver of Nation's sovereign immunity with regard to the Governmental Plan.
