Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of SCUFCW Joint Benefit Funds 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the SCUFCW Joint Benefit Funds 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

- The amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 - DESCRIPTION OF THE PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The SCUFCW Joint Benefit Funds 401(k) Plan (the “Plan”) is a defined contribution plan established on April 1, 1998 to provide voluntary retirement benefits and tax-deferred savings opportunities to eligible employees, as defined in the Plan, of SCUFCW Joint Benefit Funds LLC (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The specific provisions of the Plan, including eligibility, contributions, priorities upon termination and benefit information, are contained in the Plan document, which governs the legal operations of the Plan.

A. Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Risk and Uncertainties

Plan investments are exposed to various investment risks such as interest rate, market, fluctuations, and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and such changes could materially affect participants’ account balances and the amounts reported in the financial statements.

D. Administrative Expenses

Plan participants pay a majority of Plan expenses.

E. Investment Valuation and Income Recognition

Accounting standards establish a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market:

Level 1 – Inputs are quoted prices in active market.

Level 2 – Inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

The following tables summarize the Plan’s investments at December 31, 2024 and 2023 based on the inputs used to value them:

Level 1 investments consist of mutual funds and a short term investment fund valued at their quoted market prices.

F. Eligibility

Employees who have completed at least a three month period of service and attained the age of 21 are eligible to participate in the Plan.

G. Notes Receivable from Participants

Participants may borrow from their account up to the lesser of 50% of the vested account balance or \$50,000, subject to limitations included in the Plan. Loans are repaid within five years, unless for the purchase of a principal residence in which case the term of the loan is not to exceed 10 years. The minimum loan amount is \$1,000. Participants may have a maximum of two loans outstanding at any time. Loan bears interest at a reasonable rate of interest. Notes receivable from participants at December 31, 2024 carry interest rates of 4.25% to 9.50%.

H. Distributions and Withdrawals

Each participant's share of the net assets of the Plan is allocated to an individual account. Vested benefits are payable upon termination of employment, retirement, death or disability. Normal retirement age is 65. Hardship distributions are permitted. Participants are allowed to make in-service withdrawals at the age of 59½.

I. Participant Contributions

Participants direct their contributions into the investment options offered by the Plan.

Participants may contribute up to 50% of their eligible wages on pre-tax basis, as defined in the Plan, limited to a maximum annual amount specified by the Internal Revenue Code (the "IRC"). Catch-up and Roth contributions are permitted. The Plan also permits participants to make rollover contributions from other qualified plans.

J. Vesting

Participant account balances are immediately vested 100%.

K. Company Contributions

The Company may be required to make a top heavy contribution to only non-highly compensated employees. There were no top heavy contributions in 2024. Participants are fully vested in top heavy contributions after 6 years.

L. Forfeitures

Forfeitures of terminated participants' non-vested accounts may be used to pay administrative costs or Company contributions. During 2024 and 2023, there were no forfeitures.

NOTE 2 - INCOME TAX STATUS

The Plan has adopted the Schwab Retirement Plan Services Inc. Profit Sharing/401(k) Non-Standardized Adoption Agreement. The form of the plan qualifies under applicable provisions of the IRC for tax-exempt status. The Company believes that the Plan is operated in accordance with, and qualifies under, the applicable requirements of the IRC, therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 3 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts and net assets would be distributed based upon participants' account balances at that time.

NOTE 4 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Charles Schwab Trust Bank, the trustee of the Plan.

NOTE 5 - STABLE VALUE FUND

The Putnam Stable Value Fund seeks to offer a higher yield than money market instruments while providing safety of principal. The weighted average crediting rate was 3.96% and 4.09% for 2024 and 2023, respectively. Units of investment are redeemable at contract value (purchase price plus accrued interest), which approximates fair value. There are no funding commitments or limits on participants' ability to redeem units at contract value. Redemption restrictions and/or market value adjustments may apply to Plan level redemptions.

The Plan's ability to receive amounts due is dependent on Putnam Investment's ability to meet its financial obligations. There are no reserves against contract value for credit loss. Certain events might limit the ability of the Plan to transact at contract value including premature termination of Plan investments in the stable value fund. The plan administrator does not believe that any events limiting the Plan's ability to transact at contract value are probable of occurring.

NOTE 6 - RELATED PARTY TRANSACTIONS

Certain Plan investments are managed by the trustee or an affiliate. Any purchases and sales of these investments are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibitions of party-in-interest transactions under ERISA.

NOTE 7 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 22, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
