NOTE A - PLAN DESCRIPTION

The following description of the Retirement Savings Plan for Employees of WestPoint Home LLC (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by WestPoint Home LLC (the "Company"). The purpose of the Plan is to provide eligible employees to save for retirement. In addition to retirement benefits, the Plan provides certain benefits in the event of death, disability, or other termination of employment. The Plan is for the exclusive benefit of eligible employees and their beneficiaries. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). T. Rowe Price Trust Company ("T. Rowe Price" or "the Trustee") serves as both the trustee and the custodian.

Eligibility

As described in the Plan document, all full-time employees are eligible as of their hire date to make contributions and receive the Company discretionary match.

Contributions

Each active Plan participant may make contributions between 1% and 50% of his or her eligible compensation. Contributions are also subject to certain limits specified by the Internal Revenue Code ("IRC"). Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may contribute pre-tax or Roth 401(k) contributions. Participants are also permitted to transfer amounts representing distributions from other qualified plans to the Plan.

The Company made discretionary matching contributions ("Company contributions") of 50% of each participant's pre-tax contributions not to exceed 6% of the participant's eligible compensation for the year ended December 31, 2024.

Participant Accounts

A separate account is established for each participant. The account is credited or charged, as applicable, with the participant's salary deferral contributions, rollovers, an allocation of the Company's discretionary contributions, the participant's share of investment earnings and losses, the participant's distributions and certain administrative charges. Allocations are based on participant earnings or account balances, as defined. Participants direct the investment of their account into the various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

Vesting

Participants are immediately vested in their rollovers and participant contributions plus actual earnings thereon. Vesting in the Company's contributions plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after three years of service.

If, while as an employee, the participant dies or becomes disabled before the three-year vesting period, the participant's account will be 100% vested.

Forfeitures

An employee may forfeit the non-vested portion of his or her account if employment ceases and the employee is less than 100% vested in any Company contributions made to his or her account. Forfeited balances of terminated participants' nonvested accounts are used to reduce future Company contributions or pay Plan expenses. For the year ended December 31, 2024, the Company utilized \$15,661 of forfeitures for the payment of Company contributions. There were \$1,449 and \$35 of available forfeitures on December 31, 2024 and 2023, respectively.

Payment of Benefits

Upon retirement, disability, death or termination of service, a participant may receive either a lump sum, a rollover amount equal to the value of the vested portion of his or her account, equal installment payments over a specified period of time, or partial payments in amounts that are requested from time to time. Distributions are subject to the applicable provisions of the Plan document. The Plan allows in-service withdrawals, such as hardship withdrawals, under certain conditions based on the participant's eligibility and approval by the Plan Administrator.

If a terminated participant has a vested account balance less than \$5,000, then the vested balance will be distributed in a lump sum as soon as administratively feasible following the event that entitles the participant to a distribution.

Notes Receivable from Participants

Participants may borrow from their accounts (excluding Roth amounts), a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the borrower's vested account balance or \$50,000 less the amount of the highest outstanding loan balance in the prior 12-month period. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1% in effect at the time of the application of the loan and will be fixed for the entire term of the loan. The maximum term of a general loan is five years and the maximum term of a residential loan is 15 years. Interest rates on outstanding loans ranged from 4.25% to 9.50% as of December 31, 2024 and December 31, 2023.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant's loan to be in default, the participant's loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments. The recordkeeper of the Plan charges a quarterly administrative fee that is charged directly to the participant accounts.

Other Income

T. Rowe Price Retirement Plan Services, Inc. receives pricing credits associated with certain investments in the Plan and allocates those pricing credits to participants in proportion to their account balances invested in those options.

Subsequent Events

The Plan has evaluated subsequent events through October 2, 2025, the date the financial statements were available to be issued. Plan management is not aware of any subsequent events which would require recognition or disclosure in the financial statements.

NOTE C - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;

- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023:

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust funds - Valued at the NAV of the units held by the Plan at year-end, as determined by fair value of the underlying assets. Underlying assets include commingled pools of exchange traded equity and fixed income securities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with industry practices, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE D - STABLE VALUE FUND

The Plan's investments include an investment in the T. Rowe Price Stable Value Fund (the "Fund"), a collective trust fund that is considered to be a stable value fund with underlying investments in fully benefit-responsive investment contracts. Fair value of the stable value fund is the NAV of the fund. The NAV is based on net assets, which includes the fully benefit-responsive investment contracts at contract value. The Fund is an open-end commingled pool dedicated exclusively to the management of assets of defined contribution plans. The Fund's investment objective is to maximize current income consistent with the maintenance of principal and to provide for withdrawals for certain participant-initiated transactions under a retirement plan without penalty or adjustment. To achieve its investment objective, the Fund invests in underlying assets (typically fixed income securities or bond funds and may include derivative instruments such as futures contracts and swap agreements) and enters into a "wrapper" contract issued by a third party. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Withdrawals for benefit payments and participant transfers to noncompeting investment

options to be paid to Plan participants shall be made 30 days after written notification has been received. Withdrawals, other than for benefit payments and participant transfers to noncompeting investment options may be made up to one year after notification is received. As of December 31, 2024 and 2023, there were no other restrictions or unfunded commitments.

Certain events can limit the ability of the Plan to transact at contract value with the Fund, and the Fund itself may be subject to circumstances that affect its ability to transact at contract value. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value are probable of occurring.

NOTE E - INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

The Plan Administrator has elected to have the audit performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The Plan Administrator determined that the certification received from the Trustee meets the requirements of ERISA Section 103(a)(3)(C). The Trustee certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate:

- Investments at fair value and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income, other income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, Line 4i - schedule of assets (held at end of year) as of December 31, 2024.

NOTE F - TRANSACTIONS WITH PARTIES-IN-INTEREST

Certain Plan investments are held and managed by T. Rowe Price. T. Rowe Price also performs administrative and recordkeeping services for the Plan. Therefore, these transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules. Additionally, the Plan has loans to participants that also qualify as party-in-interest transactions.

NOTE G - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Company's contribution portion of their account.

NOTE H - TAX STATUS

The Plan utilizes a pre-approved plan document sponsored by T. Rowe Price. The Internal Revenue Service ("IRS") provided an opinion letter dated August 19, 2020, which states the pre-approved plan document satisfies the provisions of Section 401 of the IRC. The Plan Administrator believes the Plan, including any subsequent amendments, is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE I - RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is a least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
