Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of ClearVision Optical Company, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). 1. Description of Plan

The following description of the ClearVision Optical Company, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established effective August 31, 1978, as restated January 1, 2021. The Plan covers all employees of (the Company) who have completed 60 days of service and are age 21 or older. Employees are eligible to receive discretionary employer contributions after completion of 1,000 hours of service during the plan year and are employed by the Company on the last day of the plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan's trustees are responsible for oversight of the Plan. The Plan's trustees determine the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Additional discretionary profit sharing and/or discretionary matching contribution amounts may be contributed at the option of the trustees of the Company. Employees are eligible to receive discretionary employer contributions after completion of 1,000 hours of service during the plan year and are employed by the Company on the last day of the plan year. For the year ended December 31, 2024, there were no discretionary profit sharing or matching contributions to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Company's discretionary contributions, if any, and an allocation of the Plan's earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses), account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions, plus actual earnings (losses) thereon. Vesting in the Company's discretionary profit sharing and matching contribution portion of their accounts is based on years of continuous service. Participants are 100% vested after six years of credited service.

Life Insurance Contracts

Participants can elect to purchase a life insurance contract on their life with Security Mutual Life Insurance Company of New York. The insurance contract must provide that proceeds will be paid to the Plan's trustees. However, the Plan's trustees must pay all proceeds of the contract to the participant's beneficiary in accordance with the distribution provisions of the Plan. The form and type of contract purchased is determined by the plan administrator.

The total premiums paid for a participant's ordinary life insurance cannot be less than 50% of the aggregate Company contributions allocated to such participant's account. If term insurance or universal life insurance is purchased, the aggregate premiums cannot exceed 25% of aggregate Company contributions allocated to the insured participant's account.

Under these options, participants own life insurance policies, which accumulate a cash value and dividends. Current cash surrender value in the event of termination or disability at December 31, 2024 and 2023 are \$439,707 and \$417,623, respectively. Premiums paid during the year ended December 31, 2024 were \$6,537. There were no amounts transferred from the cash surrender value of the life insurance contracts to the John Hancock Life Insurance Company of New York, the custodian of the Plan, during 2024.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the plan document. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. If a terminated participant's vested balance is less than or equal to \$7,000, the amount may be automatically distributed in the form of an annuity with John Hancock Life Insurance Company of New York. In addition, the Plan allows for hardship distributions if certain criteria are met.

Forfeited Accounts

There were no forfeited nonvested accounts as of December 31, 2024 and 2023. Forfeited accounts will be used to reduce future Company contributions, pay plan expenses or be allocated back to the participants. There were no forfeitures used during 2024 to pay plan expenses or allocated back to participants.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management and trustees determine the Plan's valuation policies utilizing information provided by the investment advisers, custodian and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains on investments bought and sold as well as held during the year.

Life Insurance Contracts

Life insurance contracts are credited with an interest rate or dividends, which generally vary with each policy. The interest rate for the policy year is declared by Security Mutual Life Insurance Company of New York annually. The contract had a minimum guaranteed interest rate of 5.0%.

If the Plan were to request a liquidation, surrender charges and/or market value adjustment could apply. Thus, the insurance contract is not considered fully benefit responsive. The cash surrender value of the policies approximates fair value.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Subsequent events were evaluated through October 1, 2025, the date the financial statements were available to be issued.

Recent Regulatory Updates

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts are valued based upon the unit values of such pooled accounts held by the Plan at year-end. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means, although are not based upon quoted market prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled accounts, there are no unfunded commitments or redemption restrictions.

Life insurance contracts are valued based on unobservable inputs, as observable inputs are not available, using valuation methodologies to determine fair value to include discounted cash flows and other similar techniques.

The collective trust fund (stable value fund) is valued at the net asset value (NAV) of units of bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund, less their liabilities. This practical expedient is not used when it is determined to be probable that the funds will sell the investments for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

4. Concentrations

As of December 31, 2024 and 2023, the Plan had investments of \$8,624,941 and \$7,314,182, respectively, that were concentrated in three investments.

5. Information Certified by Custodian

Accordingly, John Hancock Life Insurance Company of New York, the Custodian of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024 except for the cash surrender value of life insurance of \$439,707 and \$417,623 at December 31, 2024 and 2023, respectively, and the \$22,084 of net appreciation in cash surrender value of life insurance for the year December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

6. Related-Party and Party in Interest Transactions

Certain plan investments are managed by John Hancock Life Insurance Company of New York, the Custodian, and therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment manager services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their Company contributions.

8. Tax Status

The Plan adopted a volume submitter plan offered by CCH Incorporated DBA FT William Com. The volume submitter plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the custodial assets are exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. market risks include global events. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
