- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with generally accepted accounting principles in the United States of America ("GAAP").
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with generally accepted auditing standards in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Thomasville National Bank 401(k) Profit Sharing Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Thomasville National Bank 401(k) Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) Audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



# Notes To Financial Statements

## NOTE 1. PLAN DESCRIPTION

The following description of Thomasville National Bank 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan covering all employees of Thomasville National Bank (the "Bank" and the "Plan Sponsor") who are 21 years of age or older and have completed one year and 1,000 hours of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

### Participation

An employee will become eligible to participate in the 401(k) arrangement and employer contributions on the first day of the quarter following the completion of one year and 1,000 hours of service with the employer and attaining the age of 21.

### Contributions

*Employee Contributions:* A participant may elect to contribute, on a before-tax or after-tax basis from 1% of his or her compensation up to the maximum allowed by law. All contributions are subject to the limitations provided in ERISA and the Internal Revenue Code ("IRC").

*Employer Contributions:* Each Plan year, the employer may, at its sole discretion, make a matching contribution equal to a discretionary percentage of the employee's 401(k) elective deferrals. The Plan requires a safe harbor contribution of not less than 3% of compensation each year. The Plan also provides for a discretionary profit sharing contribution determined by the Company's Board of Directors (the "Board"). In December 2024, the Board approved a profit sharing and safe harbor contribution in the total amount of 5% of eligible compensation. All contributions are subject to the limitations provided in ERISA and the IRC.

### Investment Options

John Hancock Life Insurance Company is a custodian for the Plan assets and provides mutual fund investment options. TNB Financial Services is also a custodian and provides the option for participants to invest in the common stock of the Bank's parent company, Thomasville Bancshares, Inc. Employer contributions are invested in the same investment selection as the employee contributions. Participants may change investment options at any time.

**NOTE 1.****PLAN DESCRIPTION (CONTINUED)****Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings or losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

*Employee Contributions:* All participants are 100% vested as of their participation date.

*Employer Matching and Profit Sharing Contributions:* Participants become 20% vested after two years of service and the vesting percentage increases 20% for each year of service thereafter until six years of service, at which time the participant is 100% vested. Safe harbor contributions are immediately 100% vested.

**Retirement Benefits**

A participant becomes eligible for benefits at the normal retirement date (age 65). If the vested account balance is less than \$1,000, then the vested account balance will be distributed in a lump-sum payment. If the vested account balance is more than \$1,000, the participant may elect to receive the benefits either as a lump-sum distribution, as part lump-sum and part installments, or as installment payments over a specified period of time or a joint and survivor annuity.

**In-Service Withdrawals**

Upon attaining age 59½, participants may at any time withdraw all or any part of their vested account resulting from employee contributions, employer matching contributions, or discretionary contributions.

**Disability Benefits**

A participant may retire under the Plan in the event of disability and shall be eligible to receive the entire amount standing to his or her credit in his or her individual accounts.

**Termination Benefits**

*Employee Contribution:* A participant shall receive 100% of his or her employee contribution if his or her employment is terminated.

*Employer Contributions:* A participant shall receive only his or her vested portion of the employer contribution account if his or her employment is terminated for any reason other than retirement at normal age, disability, or death.

**NOTE 1. PLAN DESCRIPTION (CONTINUED)**

**Death Benefits**

If a participant dies while in the service of the Bank, his or her beneficiary shall receive the vested amount of the participant's individual accounts. In the event of death of an inactive participant, any remaining benefits which were payable to the inactive participant shall be paid to his or her beneficiary.

**Notes Receivable from Participants**

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest from 4.25% to 9.50%, which is commensurate with local prevailing rates at the time of issuance. Loans must be repaid through payroll deductions from each regular paycheck.

**Forfeitures**

Amounts of participants' forfeited non-vested accounts shall be used to reduce future employer contributions or pay Plan administrative expenses. At December 31, 2024 and 2023, there were no balances held in forfeited non-vested accounts. During the year ended December 31, 2024, forfeited non-vested accounts of \$2,578 were used to offset matching contributions and pay Plan administrative expenses.

**NOTE 2. SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

**Valuation of Investments and Income Recognition**

The Plan's investments are stated at fair value, as defined in Note 3. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for further discussion of fair value. In accordance with GAAP for stating investments at fair value, net unrealized appreciation for the year is reflected in the statement of changes in net assets available for benefits.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**NOTE 2.****SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)****Contributions Income Recognition**

The Plan records employer and employee contributions receivable when compensation is paid, and deferrals are withheld. In accordance with ASC 326, Financial Instruments - Credit Losses, no allowance for credit losses has been recorded at December 31, 2024 and 2023, as employer and employee contributions receivable have never historically incurred losses and current conditions and supportable forecasts show zero risk of nonpayment.

**Payment of Benefits**

Benefits are recorded when paid.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan payments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. Payments on loans are collected through regular payroll deductions.

**Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Subsequent Events**

The Plan Administrator has evaluated subsequent events through July 18, 2025, the date the financial statements were available to be issued.

**NOTE 3.****FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) Topic 820, Fair Value Measurement (“ASC 820”), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under this guidance are described below:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets,
- quoted prices for identical or similar assets or liabilities in inactive markets,
- inputs other than quoted prices that are observable for the asset or liability, and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common stock:* Valued at the closing price reported on the active market on which the individual security is traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by John Hancock Life Insurance Company and TNB Financial Services, the custodians of the Plan, except for comparing such amounts to information included in the Plan's financial statements and supplemental schedule. The Plan Administrator has obtained certifications from the custodians that the following information is complete and accurate.

**NOTE 4. INFORMATION CERTIFIED BY PLAN CUSTODIANS (CONTINUED)**

\* Only loans held against John Hancock Life Insurance Company funds are certified. Loans held against the Thomasville Bancshares, Inc. stock are not certified by John Hancock Life Insurance Company. The balance of loans held with TNB Financial Services was \$29,942 and \$36,000 as of December 31, 2024 and 2023, respectively. Interest income on these loans amounted to \$3,147 for the year ended December 31, 2024.

*Supplemental schedule:* Except for loans held against Thomasville Bancshares, Inc.'s common stock, all investment balances and information included in the supplemental schedule of assets (held at end of year).

**NOTE 5. TRANSACTIONS WITH PARTIES-IN-INTEREST**

A party-in-interest is defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. The Plan holds mutual funds managed by John Hancock Life Insurance Company, the Plan's custodian, which qualify as party-in-interest transactions. Notes receivable from the participants held by the Plan are also considered party-in-interest transactions. Additionally, at December 31, 2024 and 2023, the Plan had participant directed investments of \$18,316,438 and \$15,216,226, respectively, in the Plan Sponsor's parent company common stock. Dividends received by the Plan on the Plan Sponsor's parent company stock during 2024 were approximately \$579,000.

**NOTE 6. INCOME TAX STATUS**

The Plan is a word-for-word adapter of a prototype plan, for which the custodian received a favorable determination letter on June 30, 2020 from the Internal Revenue Service ("IRS"). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not, would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7. ADMINISTRATIVE EXPENSES**

Certain administrative functions are performed by officers or employees of the Bank. No such officer or employee receives compensation from the Plan. Certain other administrative expenses are paid directly by the Bank. Investment related expenses are included in net appreciation of fair value of investments.

**NOTE 8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
