Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Kern Oil & Refining Co. Pension Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Kern Oil & Refining Co. Pension Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Notes to Financial Statements

Note 1. Plan Description

The following description of the Kern Oil & Refining Co. Pension Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan established effective April 1, 1982 covering employees of Kern Energy, formerly Kern Oil & Refining Co., (the Company) except union employees. Any employee who was a participant in the Plan before January 1, 1989, and had not terminated as a participant, became a participant on January 1, 1989 as a result of an amendment on January 1, 2001. Employees hired after January 1, 1989 become eligible to participate on the first of the month, following or coincident with 3 months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

The Company makes a monthly contribution equivalent to 5.1% of the participant's monthly earnings as of January 1 of the current Plan year. For the year ended December 31, 2024 the employer contribution was \$996,156. Contributions are funded monthly.

The Plan permits participants to contribute amounts transferred in from other qualified retirement plans. The Plan permits participant deferrals, however no amounts were contributed by participants during the year ended December 31, 2024.

The forfeiture reserve balance can be used to offset employer contributions or to pay Plan expenses, which would otherwise be payable by the Company, in accordance with the Plan agreement. The Company's contributions were reduced by \$50,676 from forfeited nonvested account balances for the year ended December 31, 2024. The forfeiture reserve balance as of December 31, 2024 and 2023 was \$1,031 and \$5,681, respectively.

Participant accounts:

Separate accounts are kept for each participant. Each participant's account is credited with employee contributions and the allocation of the Company's contribution, allocation of earnings and losses and Plan fees. Investments in participant accounts are participant directed; participants direct the investment of their contributions into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Vesting:

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in employer contributions plus actual earnings thereon is based on years of service as follows:

1	20%
2	40%
3	60%
4	80%
5	100%

If an active participant dies or is disabled prior to attaining the normal retirement age of 65, the participant becomes 100% vested.

Benefit payments and withdrawals:

On termination of service, a participant may elect distribution of their account or they may defer distribution and leave the value of their account on deposit with the Plan until normal retirement (age 65) or upon total disability lasting longer than 12 months. Participants may elect to receive either a lump-sum amount equal to the vested value of the participant's vested interest in his or her account, a distribution in the form of installments, or a combination of both.

Participants may take hardship distributions in the event of an immediate and heavy financial need.

There were no amounts allocated to withdrawing participants for benefit claims that have been processed and approved for payment prior to year-end that have not been paid as of December 31, 2024.

Note 2. Significant Accounting Policies

Basis of accounting:

The financial statements of the Plan are maintained on the accrual basis of accounting.

Use of estimates:

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes to Financial Statements

Investment valuation and income recognition:

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Benefits:

Benefit payments are recorded when paid.

Plan fees:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Income tax status:

The Internal Revenue Service has determined and informed the Company by a letter dated June 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and therefore, believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Notes to Financial Statements

Note 3. Fair Value Disclosures

The Financial Accounting Standards Board (FASB) provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB are described as follows: Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access; Level 2 inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means; Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Common/collective trusts: The fair value of the common/collective trusts are from broker quotations from market makers, original transaction price and recent transactions in recent or similar instruments.

Pooled separate accounts: Separate accounts that invest exclusively in mutual funds are valued at the net asset value of the underlying mutual fund. Those separate accounts directly investing in fixed maturity securities are measured based on the pricing data provided by outside valuation service providers who in turn generally use the mean of bid and ask prices but may also use alternative observable pricing inputs for certain securities.

Registered investment companies (mutual funds): The fair values of mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realized value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in all their accounts.

Note 6. Party-in-Interest Transactions

For the years ended December 31, 2024 and 2023, certain Plan investments are pooled separate investments and common collective trusts managed by Principal Life Insurance Company (Principal), which is the custodian, as defined by the Plan. Fees paid by the Plan for the year ended December 31, 2024 amounted to \$36,642 and are presented as deductions on the statement of changes in net assets available for benefits. These transactions qualify as party-in-interest transactions which are exempt from prohibited transaction rule.

Certain balances included on Schedule H Part II on the Annual Return of Employee Benefit Plan (Form 5500) have been reclassified for purposes of presentation in the financial statements.
