Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Notes to Financial Statements

Note 1. Plan Description

The following description of the Kern Oil & Refining Co. Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan established April 1, 1982 covering all employees of Kern Energy, formerly Kern Oil & Refining Co., (the Company) who have completed 1,000 hours of service. Employees become eligible to participate on the first day of January, April, July, or October following their service requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

Participating employees are allowed to make contributions of their pretax annual compensation as defined in the Plan, pursuant to Section 401(k) of the Internal Revenue Code. Plan participants are permitted to contribute amounts transferred from other qualified defined contribution plans. Participants are automatically enrolled at a rate of 6%, with automatic increases of 1% annually, up to 10%, unless they elect to opt out of these provisions. The employer contribution is a discretionary amount that is determined by Plan management each Plan year. For the year ended December 31, 2024, the employer contribution was 25% of employee deferrals up to a maximum of 10% of eligible compensation and amounted to \$333,637. Contributions are funded annually.

Forfeitures of terminated employees' nonvested account balances can be used to offset employer contributions and expenses. The Company's contributions were reduced by \$13,803 from forfeited nonvested account balances for the year ended December 31, 2024. The forfeiture reserve balance as of December 31, 2024 and 2023 was \$613 and \$256, respectively.

Participant accounts:

Separate accounts are kept for each participant. Each participant's account is credited with the allocation of the Company's contribution, the employee's contribution, and allocation of Plan earnings and losses and Plan fees. Investments in participant accounts are participant-directed; participants direct the investment of their contributions into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Notes to Financial Statements

Vesting:

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in employer contributions plus actual earnings thereon is based on years of service as follows:

If an active participant dies or is disabled prior to attaining the normal retirement age of 65, the participant becomes 100% vested.

Benefit payments and withdrawals:

On termination of service, a participant may elect distribution of their account or they may defer distribution and leave the value of their account on deposit with the Plan until normal retirement (age 65). Participants may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account.

Participants are permitted to take hardship distributions of employee contributions for heavy and immediate needs.

There were no amounts allocated to withdrawing participants for benefit claims that have been processed and approved for payment prior to year end that have not been paid as of December 31, 2024.

Note 2. Significant Accounting Policies

Basis of accounting:

The financial statements of the Plan are maintained on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Notes to Financial Statements

Use of estimates:

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition:

Investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that the changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Benefits:

Benefit payments are recorded when paid.

Plan fees:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Income tax status:

The Internal Revenue Service has determined and informed the Company by a letter dated June 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and therefore, believes the Plan is qualified and the related trust is tax-exempt.

Notes to Financial Statements

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 3. Fair Value Disclosures

The Financial Accounting Standards Board (FASB) provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB are described as follows: Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access; Level 2 inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means; Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Pooled separate accounts: Separate accounts that invest exclusively in mutual funds are valued at the net asset value of the underlying mutual fund. Those separate accounts directly investing in fixed maturity securities are measured based on the pricing data provided by outside valuation service providers who in turn generally use the mean of bid and ask prices but may also use alternative observable pricing inputs for certain securities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realized value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Investment Contracts with Insurance Company

The Plan holds guaranteed general-account contracts with Principal Life Insurance Company (Principal) which meets the fully benefit-responsive investment contract criteria and is therefore reported at contract value. Principal maintains the contributions in a general account. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the schedule maturity date.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rates for the Plan's Principal Guaranteed Interest Accounts for 2024 were 4.86%, 4.77%, 4.74%, 4.65%, and 4.65%. The Plan's 2024 Principal Guaranteed Interest Accounts range in maturity from December 31, 2024 through December 31, 2028. The crediting interest rates for the Plan's Principal Guaranteed Interest Accounts for 2023 were 5.27%, 5.27%, 4.75%, 4.51%, and 4.41%. The Plan's 2023 Principal Guaranteed Interest Accounts range in maturity from December 31, 2023 through December 31, 2027. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a periodic basis for resetting. The balance of the investments at December 31, 2024 and 2023 were \$809,873 and \$1,176,450, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (e) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

Note 6. Plan Termination

Although it has not expressed an intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

Notes to Financial Statements

Note 7. Party-in-Interest Transactions

For the years ended December 31, 2024 and 2023, certain Plan investments are shares of pooled separate accounts managed by Principal Life Insurance Company (Principal), which is the custodian as defined by the Plan. Fees paid by the Plan for fees amounted to \$60,822 for the year ended December 31, 2024 and are presented as deductions on the statement of changes in net assets available for benefits. These transactions qualify as party-in-interest transactions which are exempt from the prohibited transactions rules.

Note 8. Reconciliation of Financial Statements to Form 5500

Certain balances included on Schedule H Part I, Part II on the Annual Return/Report of Employee Benefit Plan (Form 5500) have been reclassified for the purposes of presentation in the financial statements.
