## INDEPENDENT AUDITOR'S REPORT

To the Committee of  
AMPP 401(k) Thrift Trust:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of AMPP 401(k) Thrift Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the AMPP 401(k) Thrift Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the investment information is prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from qualified institutions as of December 31, 2024, and for the year then ended, stating that certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion on the 2024 Financial Statements

In our opinion, based on our audit and the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section:

- The amounts and disclosures in the accompanying 2024 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- The information in the accompanying 2024 financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of AMPP 401(k) Thrift Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion on the 2024 financial statements.

### **Responsibilities of Management for the 2024 Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about AMPP 401(k) Thrift Trust's ability to continue as a going concern for one year from the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the 2024 Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2024 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the 2024 financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **1. DESCRIPTION OF THE PLAN**

The following description of AMPP 401(k) Thrift Trust (“Plan”) provides only general information. Participants should refer to the legal plan document for a more complete description of the Plan’s provisions.

##### **General**

The Plan is a qualified retirement plan originally effective January 1, 1980, to provide employees the opportunity to save for retirement on a tax-advantaged basis. The amended and restated provisions of the Plan became effective May 1, 2022, to conform the Plan to new tax laws and regulations. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

##### **Eligibility**

Employees of Association for Materials Protection and Performance (“Company”) are eligible to participate in the Plan for purposes of elective deferrals when they have completed three months of service and have attained age 21. Employees are eligible to participate in the Plan for purposes of employer contributions when they have completed one year of service and have attained age 21.

##### **Contributions**

A participant may elect to reduce their compensation by a specific percentage or dollar amount and have that amount contributed to the Plan as an elective deferral. There are two types of elective deferrals: pre-tax deferrals and Roth deferrals. A participant may revoke or make modifications to their salary deferral election. A participant at least age 50 or will attain age 50 before the end of a calendar year may elect to defer additional amounts called catch-up contributions. The Plan also includes an automatic deferral feature. Accordingly, the Company will automatically withhold 6% of a participant’s compensation each payroll period and contribute that amount to the Plan as a pre-tax deferral unless the participant makes a contrary election. This amount will increase by 1% each plan year until the amount withheld from the participant reaches 10% of compensation unless the Company amends the Plan, the participant enters into a salary reduction agreement, or the participant elects not to defer under the Plan.

The Plan is referred to as a safe harbor 401(k) plan. In order to maintain safe harbor status, the Company will make a contribution equal to 4% of their compensation. The Company may also make a discretionary matching contribution. For the year ended December 31, 2024, the discretionary matching contributions were 100% of a participant’s deferrals up to 4% of compensation.

A participant is also permitted to deposit into the Plan distributions they have received from other plans and certain individual retirement arrangements as rollover contributions.

##### **Vesting**

Participants are always 100% vested in all of their Plan account.

##### **Participant Accounts**

Each participant’s account is credited with the participant’s contributions, employer contributions, and an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided by the participant’s vested account.

A participant will be able to direct the investment of their entire interest in the Plan. The Company will provide the participant with information on the investment choices available to them, the procedures for making investment elections, the frequency with which they can change their investment choices, and other important information.

**Notes Receivable From Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants are allowed to have two loans outstanding at one time. Loan terms range from one to five years or if the loan is for the purchase of a principal residence, the term can be extended to fifteen years. The interest rate is 1% over the prime rate published in the Wall Street Journal. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

A participant may receive a distribution of some or all of their accounts in the Plan when they terminate employment with the Company. If the vested account balance exceeds \$5,000, the participant's consent is required to distribute their account. If the vested account balance does not exceed \$5,000, a distribution of their vested account balance will be made, regardless of whether they consent to receive it. A participant may receive a distribution from certain accounts prior to termination of employment provided that have attained age 59½ or have incurred a financial hardship.

**2. SUMMARY OF ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Company to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are expensed when they are incurred.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be issued.

**Reclassifications**

Certain reclassifications have been made to the 2023 financial statements presentation to correspond to current year's format. Net assets available for benefits is unchanged due to these reclassifications.

**3. CERTIFIED INVESTMENT INFORMATION**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, interest, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by the Company and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America ("EAIICA") and Empower Trust Company, LLC, qualified institutions.

**4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Fixed Annuities* – Valued daily based on the valuation method disclosed in the annuity contract, as calculated by EAIAC. All of the inputs are generally considered to be obtainable and observable through review of existing contracts and readily available published information. The value is the basis for current participant transactions (purchases and sales) which may occur daily.

*Collective Trust Funds* – Valued at the NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the collective trust fund less its liability. This practical expedient is not used when it is determined to be probable that the collective trust fund will sell the investment for an amount different than the reported NAV.

**5. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Empower Funds and EAIAC. EAIAC is the recordkeeper for the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. The Plan also engages in transactions with participants related to notes receivable, which are party-in-interest transactions with respect to the Plan. These transactions are covered by an exemption from the prohibited transaction rules of ERISA.

EAIAC provides certain administrative services to the Plan pursuant to an agreement between the Company and EAIAC. EAIAC receives revenue from mutual fund service providers for services EAIAC provides to the funds. This revenue is used to offset certain amounts owed to EAIAC for its administrative services to the Plan.

If the revenue received by EAIAC from such mutual fund service providers exceeds the amount owed under the agreement, EAIAC remits the excess to the Plan. Such amounts may be applied to pay administrative expenses or allocated to the accounts of the participants. During 2024, there were no excess amounts. The Plan or the Company may make a payment to EAIAC for administrative expenses not covered by revenue sharing.

**6. PLAN TERMINATION**

Although the Company intends to maintain the Plan indefinitely, the Company reserves the right to terminate the Plan at any time. Upon termination, no further contributions will be made to the Plan and all amounts credited to participants' accounts will continue to be 100% vested. The Company will direct the distribution of participants' accounts in a manner permitted by the Plan as soon as practicable.

**7. TAX STATUS**

The Plan has adopted a pre-approved plan document which obtained its latest opinion letter dated November 14, 2022, in which the Internal Revenue Services ("IRS") stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Company believes that the Plan is still designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and tax-exempt.

GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
