### Opinion

We have audited the financial statements of Scheels Employee Stock Ownership Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ## **Note 1 - Description of Plan**

The following brief description of Scheels Employee Stock Ownership Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete description of the Plan's provisions.

### **General**

The Plan, a defined contribution plan, is designed as a stock bonus plan for participating employees of Scheels All Sports, Inc. (the Company). The Plan invests primarily in the Company's common stock. The Plan operates as an employee stock ownership plan and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986 (IRC) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The administrator and trustee of the Plan is the Company's Executive Committee.

### **Eligibility**

An employee is eligible to participate in the Plan after they have completed one year of service and have reached the age of 21, provided they work at least 1,000 hours during such Plan year. An employee will have completed one year of service if they have worked 1,000 hours during their first 12 months of employment or worked 1,000 hours during any Plan year following their first 12 months of employment. Participants who do not have at least 1,000 hours of service during such Plan year or are not employed on the last working day of a Plan year are generally not eligible for an allocation of Company contributions for such year.

### **Entry Date**

An employee will become a participant the first day of the Plan year if the eligibility requirements are met in the first six months of the Plan year or the first day of the following Plan year if the eligibility requirements are met in the last six months of the Plan year.

### **Contributions**

The Executive Committee of the Company determines the Plan contribution amount annually. Contributions can be made in cash, Company stock, or in such other property as is acceptable to the trustee. The contributions are allocated according to the pro rata share of each participant's compensation to total eligible compensation. For the year ended December 31, 2024, the Company contributed 3,035 shares of Company stock, with a fair value of \$9,500,643.

### **Voting Rights**

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the trustee prior to the time that such rights are to be exercised. The trustee is permitted to vote any allocated share for which instructions have not been given by a participant. The trustee is also required to vote any unallocated shares on behalf of the collective best interest of Plan participants and beneficiaries.

**Put Option**

Under Federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market or is subject to trading limitations includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to a participant for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

**Participant Accounts**

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of shares of the Company's common stock released by the trustee from the unallocated account and forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to the total eligible compensation. Plan earnings and losses are allocated to each participant's account based on the ratio of the participant's account balance.

**Vesting**

Upon retirement, disability, or termination of employment with the Company or termination of the Plan, participants will be entitled to a distribution of their vested interest. The vested interest is earned according to the following schedule:

<u>Years of Service</u>	<u>Vested Percentage of Individual Account</u>
Less than 3	0%
3 or more	100%

A year of service is any fiscal year during which the employee has 1,000 or more hours of service. Participants are 100% vested in their account balances upon attainment of age 55 and completion of ten years of service, normal retirement, death, or permanent disability.

**Forfeitures**

At December 31, 2024 and 2023, there was no balance in the forfeited non-vested account as all forfeitures are used in the same year they are forfeited. Forfeited accounts are re-allocated to eligible participants. During the year ended December 31, 2024, forfeited non-vested accounts totaling approximately \$181,134 were re-allocated to eligible participants. Allocations are based on a participant's eligible compensation, relative to the total eligible compensation.

### **Payment of Benefits**

Participants may elect to receive a lump-sum amount equal to the value of their vested interest. If the value of the participant's vested interest exceeds \$1,000, they can elect to receive the distribution in the form of an annuity. Otherwise, the distribution will be made in a single lump-sum. Any terminated participants with a balance of less than \$7,000 shall be distributed in the form of an involuntary cash-out. Distributions may be made at the participant's election prior to termination upon attainment of age 61 and at least ten years of service or hardship as defined in the Plan document.

Distributions to a Participant attributable to Company Stock shall be substantially equal monthly, quarterly, semiannual, or annual installments over a period not longer than five years. If the vested balances credited to a Participant's Company Stock are in excess of \$1,380,000, the five-year period shall be extended one additional year for each \$275,000 for up to five years.

### **Diversification**

Diversification is offered to participants close to retirement age so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 and with at least ten years of service with 1,000 hours may elect to diversify a portion of the account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify either receive a cash distribution or a rollover into an Individual Retirement Account.

### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

## **Note 2 - Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

### **Use of Estimates**

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

**Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

**Expenses**

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits.

**Note 3 - Investments**

The Plan had no unallocated shares as of December 31, 2024 and 2023. The Plan's investment in Company common stock at December 31, 2024 and 2023, is as follows:

During 2024, the Plan distributed approximately 37,218.52 shares to participants with a fair value of \$116,507,356, and the Company bought back approximately 1,553.61 shares from participants with a fair value of \$4,863,351. As of December 31, 2024, a receivable of approximately 15.56 shares was due from the Company, with a fair value of \$64,538.

**Note 4 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common Stock – The fair value of the Company common stock held in the Plan is valued at estimated fair value based upon an independent appraisal. The appraisal was based upon a combination of the market and income valuation techniques consistent with prior years. The appraiser took into account historical and projected cash flow and net income, discount rates, return on assets, return on equity, market comparables, and estimated fair value of Company assets and liabilities, including certain discounts.

The valuation process involves the Trustee's selection of an independent appraiser on an annual basis. Plan management accumulates the data for the appraiser from the audited financial statements of the Company. The appraiser prepares a preliminary report, which Plan management reviews in detail, discusses, and approves.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Fund – Valued at fair value based on the NAV of units held of the collective fund. The NAV is based on the observable market prices of the underlying investments within the fund, less liabilities. The NAV for the underlying assets of the fund is a readily determinable measure of their fair value and is the basis used by the fund for current transactions.

### Note 5 - Related Party and Party-in-Interest Transactions

Certain Plan investments are shares of common stock of the Plan sponsor. Additionally, the Plan sponsor made stock contributions for the year ended December 31, 2024. As of December 31, 2024, the Plan has a receivable from the Company for additional shares to be contributed. These transactions are related party and exempt party-in-interest transactions under ERISA.

As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

**Note 6 - Tax Status**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated April 1, 2015, that the Plan and related trust were designed in accordance with the applicable regulations of the IRC.

Subsequent to the issuance of the determination letter, the Plan was amended. However, the Company, Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and, therefore believe the Plan is qualified and the related trust continues to be tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7 - Risks and Uncertainties**

The Plan invests in various investment securities, which consist primarily of the Company's common stock. Investment securities are exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Market risks include global events which could impact the value of investments, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 8 - Right of First Refusal**

Company stock that has been distributed to a participant, and not immediately repurchased by the Company or trust, may be subject to a right of first refusal if so determined by the Company. Prior to any subsequent transfer, the shares must first be offered by written offer to the Company, and then, if refused by the Company, to the trust at fair market value as determined by an independent appraiser appointed by the ESOP Committee.

**Note 9 - Administration of Plan Assets**

The Plan's assets, which consist principally of Company common shares, are held by the custodian and administered by the Trustee of the Plan.

Company contributions are held and managed by the custodian and Trustee, which invests cash received and interest, and makes distributions to participants.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses for the trustee fees are paid directly by the Company.

**Note 10 - Plan Amendments**

Effective January 1, 2024, in connection with the SECURE Act 2.0, the Plan has elected to apply the optional provisions including increasing the minimum vested account balance threshold for mandatory distributions from \$1,000 to \$7,000. The Company intends to formally amend the Plan document to reflect the changes in a future amendment.

**Note 11 - Subsequent Events**

Effective January 1, 2025, the Plan entered into an agreement with GreatBanc Trust Company to serve as the exclusive Trustee, replacing the Company's Executive Committee.
