Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Farmer Bros. Co. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). 1. Plan Description

The following description of the Farmer Bros. Co. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Farmer Bros. Co. (the "Company" or "Employer") who are 18 years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective January 1, 2022, assets totaling \$7,695,775 from the Farmer Bros. Co. Amended and Restated Employee Stock Ownership Plan was merged into the Plan.

Contributions

Each year, participants may contribute up to 100% of their annual compensation on a pre-tax or after-tax (Roth) basis, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. There is an annual limit as to the amount that can be deducted from compensation that is determined by the Internal Revenue Code ("IRC"). Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically invested in a designated balanced fund until changed by the participant. Effective January 1, 2023, the Plan was amended to remove the automatic enrollment at a contribution rate of 3% of a participant's eligible compensation and would increase each year by 1% up to a maximum of 10% of a participant's eligible compensation.

The Employer makes a matching contribution for non-union employees equal to 100% of elective deferral contributions, and 50% of the next 2% of elective deferrals, up to 5% of eligible pay. Employer matching contributions for union participants will be made in an amount as determined by the collective bargaining agreement. The Employer may also make a discretionary contribution to the Plan. For the 2024 plan year, no discretionary Employer contributions were made to the Plan. Effective August 1, 2024, the Plan was amended to provide for a discretionary matching contribution in place of the stated matching contribution that was contributed for eligible participants. Effective August 1, 2024, the Company has suspended making discretionary matching contributions.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) Employer contributions and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Plan Description (*continued*)

Vesting

All participants are fully vested in their contributions, rollovers, and safe harbor matching contributions plus actual earnings thereon. Participants who are non-union or a member of Union 265 or 377 will always be 100% vested in Employer matching contributions. Vesting in Employer matching contributions for participants who are a member of Union 455 or 807 is based on years of continuous service as follows:

Forfeitures

If a participant terminates employment and is less than 100% vested in their Employer matching contributions, the participant will forfeit the non-vested portion of their account. The Company uses forfeited non-vested amounts to pay Plan expenses and to reduce Employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$70,572 and \$63,044. During 2024, \$50 was used to reduce Employer contributions and \$56 was used to reduce Plan expenses from forfeited non-vested accounts.

Payment of Benefits

Upon termination of service due to death, disability, retirement, age 59 1/2 or other reason, a participant is entitled to receive a lump-sum amount equal to the value of the participant's vested interest in their account.

Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, cannot exceed the amount required to relieve the financial need.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum amount of \$1,000 up to a maximum equal to the lesser of 50% of a participant's vested account balance or \$50,000, subject to the approval of a loan application. Participants may not have more than one loan outstanding at any time. The interest rate will be based on rates available for similar loans from commercial lending institutions as determined by the Plan Administrator. Loans are repaid through payroll deductions within a five-year period, unless the loan was made to acquire a primary residence, in which case the loan can be repaid over a twenty-year period.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("US GAAP"), which requires management to make certain estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows US GAAP guidance on Fair Value Measurements which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value ("NAV") per share as a practical expedient are not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

All of the Plan's investments are stated at fair value except for the group annuity contract, which is valued at contract value. The Company's common stock is the only common stock the Plan currently invests in and is valued at the closing price reported on the active market on which the security is traded. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These investments are required to publish their daily NAV and to transact at that price and are deemed to be actively traded. Pooled separate accounts are reported at the value reported to the Plan by the insurance company, which represents the fair value of the underlying investments comprising the accounts. The common/collective trusts are valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The group annuity contract is valued at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded upon a distributable event.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Administrative expenses of maintaining the Plan may be paid by the Company or the Plan, at the Employer's discretion. Certain administration fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 2, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year), including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, interest and dividend income, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company, a qualified institution.

The Plan had investments in a benefit-responsive group annuity contract, which is stated at contract value. The group annuity contract amounted to \$8,984,174 and \$9,544,475 at December 31, 2024 and 2023.

Common/Collective Trusts

The Plan offers various common/collective trusts through Great Gray Trust Company. The unit values are determined on a daily basis and amounts can be redeemed daily. The Plan has no unfunded commitments related to the common/collective trusts at December 31, 2024. The Plan did not hold investments in common/collective trusts at December 31, 2023.

5. Group Annuity Contract

The Principal Fixed Income Option (the “PFIO”) is a benefit-responsive group annuity contract issued by Principal Life Insurance Company. The PFIO is backed by the issuer’s general account and is valued at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is reset on a semi-annual basis and will never be less than the guaranteed minimum interest rate.

As described in Note 2, because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

An employer-level liquidation or employer-initiated transfer of the Plan’s interest in the PFIO will be subject to either a 12-month irrevocable advance notice or a 5 percent surrender charge, whichever the employer chooses. Participant initiated transfers from the PFIO may also be subject to the 5 percent surrender charge when the transfers are requested in anticipation of the employer-level liquidation of the Plan’s interest in the PFIO. If this scenario occurs, the surrender charge will be billed to the employer.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

6. Party-In-Interest Transactions

Certain investments of the Plan are managed by Principal Life Insurance Company, Principal Trust Company, or Principal Global Investors Trust Company, all of whom are members of Principal Financial Group. Principal Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA. Certain investments of the Plan consist of common stock issued by the Company. These transactions also qualify as party-in-interest transactions.

The Plan entered into a revenue sharing agreement with Principal whereby the Plan received certain revenue sharing credits to be used to reduce Plan expenses. During 2024, eligible credits of \$62,267 were used to pay Plan expenses.

7. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of a Plan termination, participants will become 100% vested in their Employer contributions.

8. Tax Status

The Internal Revenue Service (“IRS”) has determined and informed the prototype document preparer by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

9. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
